



H. B. No. 22-105: To offset FAC increases with revenue derived from the Liquid Fuel Tax. Introduced by REP. DONALD M. MANGLONA of Rota, Precinct 7 & REP. RALPH N. YUMUL of Saipan, Precinct 3 (Representatives Blas Jonathan “BJ” T. Attao, Richard T. Lizama, Corina L. Magofna, and Edmund S.
