## A LOCAL APPROPRIATION BILL FOR AN ACT FOR THE FIRST SENATORIAL DISTRICT

To appropriate up to $\$ 199,674.79$ of the Earned Bond Interest Income collected for the First Senatorial District that has been identified by the Commonwealth Economic Development Authority as available for appropriations; and for other purposes.

## BE IT ENACTED BY THE FIRST SENATORIAL DISTRICT DELEGATION PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:

## SECTION 1. PURPOSE.

The purpose of this Act is to appropriate up to $\$ 199,674.79$ of the Earned Bond Interest Income collected for the First Senatorial District that has been identified by the Commonwealth Economic Development Authority as available for appropriation.

## SECTION 2. APPROPRIATION.

Notwithstanding any provisions of law, statutes, rules or regulations to the contrary, the Rota Legislative Delegation hereby appropriates up to $\$ 199,674.79$ of the Earned Bond Interest Income collected for the First Senatorial District, that has
been identified by the Commonwealth Economic Development Authority as available for appropriation, for the construction of a basketball and volleyball court for the Dr. Rita H. Inos Junior/Senior High School.

## SECTION 3. EXPENDITURE AUTHORITY.

The expenditure authority of the funds appropriated in Section 2 shall be the Commissioner of the Public School System.

## SECTION 4. REPROGRAMMING.

Funds appropriated under this act shall not be reprogrammed for any other purpose. Notwithstanding any provision of law, the project funded under this Act shall be without fiscal year limitation.

## SECTION 5. SEVERABILITY.

If any provision of this Act or the application of any such provision to any person or circumstance should be held invalid by a court of competent jurisdiction, the remainder of this Act or the application of its provisions to persons or circumstances other than those to which it is held invalid shall not be affected thereby.

## SECTION 6. SAVINGS CLAUSE.

This Act and any repealer contained herein shall not be construed as affecting any existing right acquired under contract or acquired under statutes repealed or under any rule, regulation or order adopted under the statutes. Repealers contained in this Act shall not affect any proceeding instituted under or
pursuant to prior law. The enactment of the Act shall not have the effect of terminating, or in any way modifying, any liability, civil or criminal, which shall already be in existence on the date this Act becomes effective.

## SECTION 7. EFFECTIVE DATE.

This Act shall take effect upon its approval by the Governor or its becoming law without such approval.
