### A LOCAL APPROPRIATION BILL FOR AN ACT FOR THE FIRST SENATORIAL DISTRICT

To appropriate up to \$199,674.79 of the Earned Bond Interest Income collected for the First Senatorial District that has been identified by the Commonwealth Economic Development Authority as available for appropriations; and for other purposes.

# BE IT ENACTED BY THE FIRST SENATORIAL DISTRICT DELEGATION PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:

#### 1 **SECTION 1. PURPOSE.**

- The purpose of this Act is to appropriate up to \$199,674.79 of the Earned
- 3 Bond Interest Income collected for the First Senatorial District that has been
- 4 identified by the Commonwealth Economic Development Authority as available
- 5 for appropriation.

#### 6 SECTION 2. APPROPRIATION.

- Notwithstanding any provisions of law, statutes, rules or regulations to the
- 8 contrary, the Rota Legislative Delegation hereby appropriates up to \$199,674.79 of
- 9 the Earned Bond Interest Income collected for the First Senatorial District, that has

- 1 been identified by the Commonwealth Economic Development Authority as
- 2 available for appropriation, for the construction of a basketball and volleyball court
- 3 for the Dr. Rita H. Inos Junior/Senior High School.

#### 4 SECTION 3. EXPENDITURE AUTHORITY.

- 5 The expenditure authority of the funds appropriated in Section 2 shall be
- 6 the Commissioner of the Public School System.

#### 7 SECTION 4. REPROGRAMMING.

- Funds appropriated under this act shall not be reprogrammed for any other
- 9 purpose. Notwithstanding any provision of law, the project funded under this Act
- shall be without fiscal year limitation.

#### **SECTION 5. SEVERABILITY.**

- If any provision of this Act or the application of any such provision to any
- person or circumstance should be held invalid by a court of competent jurisdiction,
- 14 the remainder of this Act or the application of its provisions to persons or
- circumstances other than those to which it is held invalid shall not be affected
- 16 thereby.

#### SECTION 6. SAVINGS CLAUSE.

- 18 This Act and any repealer contained herein shall not be construed as
- 19 affecting any existing right acquired under contract or acquired under statutes
- 20 repealed or under any rule, regulation or order adopted under the statutes.
- 21 Repealers contained in this Act shall not affect any proceeding instituted under or

- 1 pursuant to prior law. The enactment of the Act shall not have the effect of
- terminating, or in any way modifying, any liability, civil or criminal, which shall 2
- 3 already be in existence on the date this Act becomes effective.
- 4 **SECTION 7. EFFECTIVE DATE.**
- 5 This Act shall take effect upon its approval by the Governor or its becoming
- 6 law without such approval.
