Representative Edwin K. Propst: Thank you, Speaker and colleagues. I just wanted to bring up a couple of things that I received from a couple of constituents and this is actually for the committee, but I thought it'd be appropriate to discuss with all members so that everyone is aware. I did briefly discuss it with Chairwoman Denita Yangetmai on the – regarding cannabis. First thing, there's a constituent who is trying to open up his business and one of the drawbacks – one of the hardships his finding is that there's a requirement that you must have liability insurance to open up his business. All the insurance company he has checked, there's no insurance company that will do this for cannabis so this is something Madame Chair that I hope we can address and your members. The next one is the high rate of taxes of bringing in hemp cigarettes it's taxed just like cigarettes like tobacco and it's at 60% it's rather high for small business that are bringing it in. Hemp is not cannabis, it's not addictive – I mean certainly not addictive, but it really is a very mild substance and it's used to treat anxiety among other things, but treating it at the high rate of 60% is not conducive to this tough economy and if we want to see businesses grow, importing this and selling it is really not a bad thing. It's agricultural and natural. It's like taxing carrots not that you would smoke carrots, but I'm just saying it's natural and it's agricultural and it's hemp. So, I just feel that Madame Chair if these issues could be addressed from these two different constituents, we would appreciate it and I also welcome any comments on that. Anyone who would like to chime in on that at a later time. Thank you, Speaker and colleagues.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Propst. Any other member? Representative Babauta Sheila.

Representative Sheila Therese J. Babauta: Thank you, Mr. Speaker and members. I do have a couple of items I would just like to bring up during this time. First of all, congratulations to Rep. Denita Yangetmai and Rep. Ivan Blanco for their appointments to the APIL representing the 22<sup>nd</sup> CNMI Legislature. So, APIL is the Association of Pacific Island Legislatures, I highly encourage our members to keep us informed and also to be advised of what has happened at the Pacific Islands forum where our Micronesian leaders had to pull out of the forum due to conflict and some members not recognizing a gentlemen's agreement. I want to just recognize our leaders in Micronesia for standing their ground and for uniting in that action. Also, Mr. Speaker I would like to bring up the concern that I have that we still have an Acting Director for the LB, Legislative Bureau and any update on that would be greatly appreciated to the body and I do hope that the viewing public and anyone who's interested in the position does submit their intent and their interest in the position. I hope that there's a deadline to fill the position and I do understand that it is something that must be agreed upon between the House and the Senate, so I look forward to any communications and any updates regarding the Director of the Legislative Bureau. Lastly, Mr. Speaker and members just today our office received a letter from an anonymous person in one of the department's in our government just expressing a grievance complaint and officially filing one with the Office of Personnel Management. Mr. Speaker and colleagues, it's very disheartening to hear that our service members and those who work for the government are experiencing toxic work environments and unhealthy and very abusive workplaces. So, Mr. Speaker and colleagues, I will be submitting this as official communication to your office so that it can be shared so that we're all informed and so that it can be referred to

the proper committee so we can address any grievances and follow-up with the proper departments for action. Thank you, Mr. Speaker.
