The Honorable Edmund Joseph S. Villagomez, Speaker of the House, presided.

A moment of silence was observed.

<u>Representative Donald M. Manglona:</u> At this time, Mr. Speaker, I move to place this bill on the Bill Calendar, but not for action on today's session.

The motion was seconded.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Donald. I now recognize the Floor Leader for the proper motion.

Representative John Paul P. Sablan: Objection Mr. Speaker on the motion.

Speaker Edmund Joseph S. Villagomez: Recognize.

<u>Representative John Paul P. Sablan:</u> Can we have the mover explain what's the sense of urgency of placing this legislation to the Bill Calendar for the record?

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you for that Representative Sablan and Representative Leepan. Recognize Representative Donald Manglona.

Representative Donald M. Manglona: Thank you, Mr. Speaker. With the way the law is written the money is expected to come within 60 days and we hope to move on with this legislation in order for the legislation to act on its appropriation. Thank you.

Speaker Edmund Joseph S. Villagomez: Recognize Representative Leepan.

Representative Joseph Leepan T. Guerrero: Mr. Speaker, absent of plans of how this money is going to be used – how do we know that there's no said in motion by the feds in how this money should be used. For one, I would like to ask counsel because the language of this bill is to appropriate. This is federal money, it's not money that we collected. I don't see that we are authorized to appropriate federal money and I want the counsel to explain to me how is that that we have the authority to appropriate federal money.

Speaker Edmund Joseph S. Villagomez: Counsel.

<u>Legal Counsel Joseph Taijeron:</u> Congressman Leepan, I actually agree with you and I think Representative Donald Manglona sees the need to actually establish the authority and that's what this bill – this legislation is putting forth exactly. Until this bill passes into law, there is no prohibition or enabling legislation. It's the law, it's silent on whether or not \$515 Million Dollars will see legislative approval or disapproval. So that's why this legislation is being put on the table.

Representative Joseph Leepan T. Guerrero: But do we have assurance from the federal that we can do this? That's what I'm trying to allude. I mean I want something in black and white that the federal is saying "yes, CNMI you can appropriate this funding." We haven't seen this money. We haven't seen the guidelines. I want to see the guidelines. I haven't had the opportunity to chime in with our Delegate to Washington, I don't know and now that we're basically moving forward to put this on calendar. I object Mr. Speaker. I want to see a standing plan. I want to see everything because what if its language in there and the authority remains with the Governor. What's the purpose of this piece of legislation?

Representative Christina Marie E. Sablan: Privilege Mr. Speaker.

Speaker Edmund Joseph S. Villagomez: Recognize Representative Sablan.

Representative Christina Marie E. Sablan: Thank you. I think we're getting ahead of ourselves in debating the legislation. I would like to note that the motion that was offered by Chairman Donald Manglona is to place it on our calendar not for action today. I will also note that the American Rescue Plan is providing to the Commonwealth as well as other US Territories of unprecedented windfall of federal monies that's intended to support the government operations and to replace shortfalls in revenues that we do absolutely have the authority to appropriate. What this bill proposes is to assert that authority to require the expenditure plan that would be reviewed by the legislature prior to certification to the US treasury. The process is spelled out in the American Rescue Plan Act, we're not acting on this today – that's not what's being proposed today and members will have time to review the specific legislation that the language in American Rescue Plan and also review the merit of what this bill is proposing. Checks and balances, transparency and accountability for a lot of money that have never seen before that we are expected to spend responsibly over the next year. So to finish my privilege motion Mr. Speaker or request for the colleagues attention and understanding is that we - the privilege motion that I'm making today or the statement I'm making today is that we are not going to act on this today, but there will be time for members to better understand what is being proposed and why it's important that we act quickly because as Chairman Donald explained time is of the essence. And if the money comes in and there's no checks and balances then there will be no opportunity for us to act proactively and ensuring that these funds are responsibly managed. Thank you.

Vice Speaker Blas Jonathan "BJ" T. Attao: Privilege Mr. Speaker.

Speaker Edmund Joseph S. Villagomez: Recognize Vice Speaker.

<u>Vice Speaker Blas Jonathan "BJ" T. Attao:</u> Colleagues, we're discussing the legislation and there's really no motion that has been made yet. So, we need to get to that motion so we can get to a discussion level before we even entertain anything else. Rep. Donald Manglona has no authority in the rules to make a motion to place it on calendar. It's the Floor Leader himself so absent that motion there's no discussion on the legislation itself. So with that thank you members, thank you Mr. Speaker.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Vice Speaker. Representative John Paul Sablan your point of clarification.

<u>Representative John Paul P. Sablan:</u> That was the point of clarification. I mean there's got to be proper motion from the Floor Leader's authority and then we get into a deeper debate on that. Thank you, Mr. Speaker.

Speaker Edmund Joseph S. Villagomez: Okay, I recognize the Floor Leader for the proper motion.

<u>Floor Leader Ralph N. Yumul:</u> Thank you, Mr. Speaker. Obviously, there's a lot of concerns. With that I am going to offer a rule to suspend Rule IX, Section 8 Referral of Bills and Resolution to place House Bill 22-33 on Bill Calendar. So move.

RULE IX. BILLS, RESOLUTIONS AND AMENDMENTS Section 8. Referral of Bills and Resolutions

- (a) Bills and resolutions shall be read by title upon introduction and (except as provided in subsection (b), the Speaker shall refer such measures to an appropriate committee or to more than one committee, jointly or sequentially. The Clerk shall endorse such reference on the measure before duplication and shall enter such reference upon the Journal. In the case of error of reference, correction may be made by the House, with debate, immediately after the reading and approval of the Journal, by unanimous consent, or upon motion of either committee claiming jurisdiction or the committee to which the measure has been erroneously referred.
- (b) The Speaker may place a resolution directly on the Resolution Calendar, rather than refer it to a committee, subject to appeal to the House.

<u>Speaker Edmund Joseph S. Villagomez:</u> A motion has been made by the Floor Leader and has been seconded. Discussion? Recognize Representative Angel Demapan.

Representative Angel A. Demapan: Thank you, Mr. Speaker. Obviously, there were some statements made out of order, but now that we're back in order, I appreciate the feedback that we've received from our colleagues here and one of the comments here is that time is of the essence, but there is 60 days approximately until these funds come to the CNMI. There is some time to refer this bill to committee like we did 32 other bills before this. I believe the committee has ample time within a sixty-day window to educate the public and most of all educate ourselves the members before we vote on this legislation. There are probably potentially advantages and disadvantages and I think we need to hear it. I recognize that the motion is to place it on calendar and not to act on it today, but that just means we act on it on the next legislative. I don't think that between now and the next legislative day the money will come in. I don't think we should shortchange the time period for us to discuss this bill thoroughly. This is a significant bill. It's not just one of the other two thirty bills, the impact is big. We're going to see money that we've never seen before come at one time and I think that the members as much as the public deserve that this bill be thoroughly reviewed in committee as is stated in our rules without suspending the rule. Thank you very much.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Demapan. I recognize Representative Ivan Blanco.

Representative Ivan A. Blanco: Thank you very much, Mr. Speaker. I understand we will be entertaining this bill next Friday, so that does not give the public or any other members to review the merits of the bill. In fact, we don't know if this bill will actually restrict our use of the recovery funds. If the feds are more flexible then we become more restrictive I we would be shooting ourselves in the foot. So, Mr. Speaker and members I respectfully offer a subsidiary that we send this to committee. So move, Mr. Speaker.

The motion was seconded.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Blanco. A secondary motion has been made and seconded. Discussion?

Representative John Paul P. Sablan: Can we request for a roll call subsidiary motion?

Speaker Edmund Joseph S. Villagomez: Short recess real quick.

The House recessed at 10:29 a.m.

RECESS

The House reconvened at 11:12 a.m.

<u>Speaker Edmund Joseph S. Villagomez:</u> We rise back up to session from recess. I now recognize Representative – my apologies – we're live. We're back from session, I now recognize Representative Ivan Blanco.

Representative Ivan A. Blanco: Thank you very much Mr. Speaker. First, I'd like to commend the mover of the bill, surely has good intent and all the cosponsors. After discussions and compromise with several members of the leadership on the merits of the bill and some unanswered questions from the bill, I think it deserves further review. At this time, Mr. Speaker and members I respectfully withdraw my subsidiary motion. Thank you, Mr. Speaker.

Several members voiced "no objection."

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, members. I now recognize the Floor Leader for his withdrawal.

<u>Floor Leader Ralph N. Yumul:</u> Thank you, Speaker. With that in line with Representative Blanco, I offer to withdraw my suspension of Rule IX, Section 8. So move.

The motion was seconded.

There was no discussion and the motion to withdraw the suspension of Rule IX, Section 8 was carried by a majority "aye" vote. There was no "nay" vote.

<u>Speaker Edmund Joseph S. Villagomez:</u> So motions have been both withdrawn, House Bill 22-33 remains on agenda. I now recognize Representative Celina Babauta.

On Department Communication 22-5, the letter from the Secretary of Finance to the Speaker and the members of the House of Representatives on the bill that I introduced along with other members of the leadership to restore the earned income tax credit to qualify tax payers in the commonwealth. I would like to note for the members' awareness if you're not yet aware the America Rescue Plan Act did just get signed into law very recently. That act does fully and permanently fund the earned income tax credit for the CNMI and other territories the value of that earned income tax credit is estimated by finance to be approximately \$25 Million Dollars that's based on 2019 data but,

that's the data that they have. The next step for us is to expeditiously move to repeal that section of our law – our local CNMI law that imposes a 100% tax on the earned income tax credit for working families here. So, I'd like to urge for your support colleagues to make sure that we remove that barrier for our people to receive the EITC and to make sure that these funds are delivered as quickly as possible because people really need this help and it's money that would go right back to the local economy and it would be its own kind of stimulus as well, which I think we all understand is needed at this time. So, I thank you colleagues and I look forward to taking up this measure expeditiously.

Speaker Edmund Joseph S. Villagomez: Alright members we'll rise back to session.

Representative John Paul P. Sablan: Privilege Mr. Speaker.

Speaker Edmund Joseph S. Villagomez: Recognize.

<u>Representative John Paul P. Sablan:</u> Before we head to the Bill Calendar. Can we be informed why we're not touching House Resolution 22-3 on the Resolution Calendar.

<u>Floor Leader Ralph N. Yumul:</u> Thank you, Mr. Speaker. Because the House Rule is the House Rule right now so why are we going to touch it.

Representative John Paul P. Sablan: Should we make a motion to refer this back to the Ad Hoc?

<u>Floor Leader Ralph N. Yumul:</u> No. In all honesty there is some amendments to be made so we are still fixing the rules and I believe there are other amendments that we are planning to put when we amend the rules that's why we're not discussing the rules today.

Representative John Paul P. Sablan: Thank you. So clarified.

<u>Speaker Edmund Joseph S. Villagomez:</u> A motion has been made to withdraw House Bill 22-19 from committee to place it on calendar the EITC bill authored by Representative Christina Sablan and has been seconded. Discussion? Members, ready?

Representative Joseph Leepan T. Guerrero: Privilege Mr. Speaker.

Speaker Edmund Joseph S. Villagomez: Recognize Representative Leepan Guerrero.

Representative Joseph Leepan T. Guerrero: I want too to move my bill to calendar. I mean all bills that have been introduced are vitally important. I don't understand why only House Bill 22-19, we're going to act on today. In due fairness to everyone, we should allow others to place their bill on calendar.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Guerrero. Just for the clarification it's just for placement on calendar. If the author would like to explain the urgency of this bill?

Representative Christina Marie E. Sablan: Yes. Thank you, Mr. Speaker and thank you colleagues. This is a motion that the Floor Leader has made to place the bill on calendar so that we may act expeditiously, but we're not going to act on it today. That's not what the leadership is proposing at this time, but what has just happened as I stated earlier on my comments on the Secretary of Finance's letter regarding this bill is that the American Rescue Plan Act has made available to the Commonwealth as soon as it was enacted into law by President Biden's signature close to half - over half a billion dollars actually and of that \$25 Million is available for the Earned Income Tax Credit to fully and permanently fund the EITC here in the Marianas and for us to make these funds available to our people to qualified, struggling, working tax payers and families; we have to repeal a section of the law that slaps a 100% tax on the EITC. Otherwise, those funds will not get to the people that need it. Now that the funding is available, the money should be transferred to the CNMI government in very short order and people need this money. So, there will be time for all of you to review the American Rescue Plan Act particularly as it pertains to the EITC. It's very straight forward. It's a hundred percent permanent funding for the EITC, but we have to do our part as a commonwealth and restore the EITC in our own law before these funds can be available to our people. So that is the urgency. I would also note for our colleagues information that the American Rescue Plan Act is a massive bill. At one point \$9 Trillion Dollars stimulus package for the American people including the Marianas and all the territories and they recognize the urgency of also responding to the health and social economic impacts of this COVID-19 pandemic. EITC is part of that we also have to act expeditiously. Thank you. I'm happy to answer any questions between now and when we do act on this bill.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Tina Sablan. Further discussion? Representative Ivan Blanco.

Representative Ivan A. Blanco: Thank you very much, Mr. Speaker. Rep. Sablan you did mention earlier that the recovery act that was signed into law will fund the EITC a hundred percent and that's a good thing, but I have not seen the documentation of such and I would think that we would need that in light of what Department of Finance I guess wrote to the Speaker that there's concerns regarding the – I don't know if it's the original bill or the current bill and that they had offered a substitute bill. If I may Mr. Speaker, I can read it.

Speaker Edmund Joseph S. Villagomez: Proceed.

Representative Ivan A. Blanco: Okay. What the Department of Finance has offered is that the tax imposed on the subsection (a) shall not apply to any overpayment arising from a tax credit that is accounted for by any authorized funding source. So, I have not seen the black and white from the law. I think it would be fair if you can share that it would be a hundred percent funded

that we do not end up voting "yes" on it and then "whoops, we were not aware of this particular tax requirement." Thank you, Mr. Speaker.

Speaker Edmund Joseph S. Villagomez: Thank you, Rep. Blanco. Recognize Rep. Tina Sablan.

Representative Christina Marie E. Sablan: Thank you, Mr. Speaker. Thank you, Leader Blanco for raising that question. The Secretary of Finance's comments were submitted when the American Rescue Plan Act was still in reconciliation and at the time what was in the language was a 75% coverage, but that changed. It went through the Senate and then it became a hundred percent permanent funding. And thanks to our Congressman Kilili for also for all of his efforts in making that happen. So the act was just signed into law last week by President Biden and so I would be more than happy to share with you the excerpt of the act that makes it very clear that this is a hundred percent and it's permanent EITC for the territories. I will share that with you. I just got it myself a few days ago. We knew that this is in the works, but now it's in the law and we do have to act quickly. So yes I will get that to you. Thank you.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Rep. Sablan. Any further discussion? Recognize Representative John Paul Sablan.

Representative John Paul P. Sablan: Thank you, Speaker and to the author. I believe we all are in agreeance we should reinstate the EIC and I know that a lot of these documents from the feds have not yet come to our indulgence for review, but I don't see why we don't have confidence on the committee on Ways and Means to review this. Probably the next few days and give us a comprehensive report on the urgency and the need to reenact such public law. I'm sure our good colleague — can we hear from our good colleague, Chairman of Ways and Means. Are you in position of acquiring information for such a proposed legislation?

Speaker Edmund Joseph S. Villagomez: Recognize Representative Manglona.

Representative Donald M. Manglona: Thank you, Mr. Speaker. Based on the information that Rep. Sablan has shared it is the understanding of the committee that we do have the necessary information to act on this legislation. Again, time is of the essence and we're just trying to get the monies out to the people in need. So, Rep. Sablan has shared that she will disseminate that information to the rest of you who may have not seen that yet and so she does have those documents ready for your review. Thank you.

Speaker Edmund Joseph S. Villagomez: Thank you, Rep. Manglona. Rep. John Paul Sablan.

Representative John Paul P. Sablan: Mr. Speaker, I hope that we can avail to that document as soon as possible. Thank you.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Sablan. Representative Tina, please get those documents for them.

Representative Christina Marie E. Sablan: Yes, I will provide that to the members today.

Speaker Edmund Joseph S. Villagomez: Thank you very much. Any further discussion?

Representative Angel A. Demapan: Privilege Mr. Speaker.

Speaker Edmund Joseph S. Villagomez: Recognize Representative Demapan.

Representative Angel A. Demapan: Thank you, Mr. Speaker. Since this body is in the spirit of withdrawing bills from committees and putting them on calendar then I would also reiterate a request that I've made to you Mr. Speaker. As you know this body on February 26, the economic counsel presented to the House and one of the recommendations was the transformation of CDA to CEDA. Prior to that presentation, I already introduced House Bill 22-21. On the same day of the presentation Mr. Speaker, you are appointed to the economic counsel and since then the economic counsel has followed up with my office on the status of House Bill 22-21, which has been referred to the Committee on Commerce and Tourism. Today, the Saipan Chamber of Commerce just 30 minutes ago just transmitted a letter of support to my office, unaware that the bill was referred to Commerce and Tourism, but I will share this letter from the chamber to the Chairwoman and to you Mr. Speaker and the members in support of the bill highlighting that it is truly a generating revenue bill and that providing the new tools and authority to what would become CEDA would realize new and diversified investment in the CNMI. CDA, the entity that will be impacted through the transformation also support this bill. In my discussion with you Mr. Speaker on March 3rd, you got back to me a few days later that you had spoken to the Chair that there would be movement on this bill. Unfortunately, we haven't had time to do that. Yesterday, I want to thank the Floor Leader who yesterday again made a request to the leadership to move 22-21 to the calendar for action. Given that the bill is rather short and very straightforward, but impactful in terms of revenue generation and so as much as we support allowing the committee to do it's work for the bills referred to it but we have opened the door today to withdrawing bills that are critical and time is of the essence and in that regard and that spirit, I'm also asking the Floor Leader at this time to withdraw 22-21 and placement for bill calendar. Thank you very much.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Demapan. If there's no objection from the members I'd like to give the chairwoman the floor to give us an update on the bill. Representative Yangetmai.

Representative Denita K. Yangetmai: Thank you, Mr. Speaker. We've been trying to get the comments – send out the letter for comments from different agencies and we're also doing research on this thing. May I ask you, what is the difference between CDA and CEDA besides the letter E.

Speaker Edmund Joseph S. Villagomez: Recognize Representative Demapan.

Representative Angel A. Demapan: Thank you, Mr. Speaker. The difference is as written in the bill the addition of five new subsections of authority and tools to empower CDA to now have a renewed focus or greater focus on economic diversification through the flexibility of attracting US investments to the commonwealth and to help diversify our economy and strengthen the creation of jobs here in the CNMI. At present without the five additional tools, they're operating on status quo and as you can see the status quo is not attracting. There is no focus on attracting the investments here and so that is the difference is five new tools and authority to expand their role in making sure our economy grows and our people have new jobs. Thank you.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Rep. Demapan and I recognize the Chairwoman.

<u>Representative Denita K. Yangetmai:</u> Thank you. We will be sending out the comments letters and then we will get back to you. And thank you for the one you got now. Thank you.

Speaker Edmund Joseph S. Villagomez: Thank you, Chairwoman. Representative Demapan.

<u>Representative Angel A. Demapan:</u> Thank you, Mr. Speaker and thank you Madame Chair and I am awaiting the Floor Leader's response to my request. Thank you.

Speaker Edmund Joseph S. Villagomez: Can I call for a quick recess? Thank you.

The House recessed at 12:20 p.m.

<u>Speaker Edmund Joseph S. Villagomez:</u> We're back from recess and I recognize the Floor Leader.

<u>Floor Leader Ralph N. Yumul:</u> Thank you, Mr. Speaker. I believe we came to a compromise and I will invoke my Rule II, Section 4 (c) and (d) and that is to withdraw House Bill 22-21 and place it on today's calendar. So move.

RULE II. TERMS AND DUTIES OF OFFICERS.

Section 4. Floor Leader.

- (c) To have the sole authority to recall any bill, report, resolution and/or other legislative document from committee. This authority to recall shall not be subject to appeal to the House.
- (d) To have the sole authority to pass on the calendar and/or agenda on any item. This authority to pass on the calendar and/or agenda shall not be subject to appeal to the House.

The motion was seconded.

Under discussion, the Chair recognized Representative Christina Marie E. Sablan.

Representative Christina Marie E. Sablan: Thank you, Mr. Speaker and Mr. Floor Leader for making the motion. I would like to just make sure that for the record that the members will be able to avail of the supporting documents that Representative Demapan mentioned he had. My understanding too is that Chairwoman Yangetmai is having a Commerce and Tourism meeting this Thursday and that bill may be up for discussion as well and to receive comments. So, I do look forward to learning more about the merits of the bill and possibly taking it up for action next Friday. Thank you.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Tina Sablan. Anymore discussion?

Several members voiced "ready."

There was no further discussion and the motion to withdraw House Bill 22-21 from committee and to place on the Bill Calendar was carried by a majority "aye" vote. There was no "nay" vote.
