1st Day, Fourth Special Session	Tuesday, July 6, 2021

The House of Representatives of the Twenty-Second Northern Marianas Commonwealth Legislature convened its First Day, Fourth Special Session on Tuesday, July 6, 2021 at 2:11 p.m., in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Edmund Joseph S. Villagomez, Speaker of the House, presided.

A moment of silence was observed.

ROLL CALL

The Clerk called the roll and eighteen members were present; Representatives Denita K. Yangetmai and Joseph Leepan T. Guerrero were absent and excused.

<u>Speaker Edmund Joseph S. Villagomez:</u> With 18 members present it constitutes a quorum. Just a note, Rep. Denita is off-island on personal leave and that would reflect on House Communication 22-24 and colleague – Representative Joseph Leepan Guerrero is also on leave, which starts today, his communication will reflect in the next session. Thank you, members. We now move down to item II, Public Comments. The podium is open.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative San Nicolas. For those of you that are –

Representative Patrick H. San Nicolas: Mr. Speaker, if I may?

<u>Speaker Edmund Joseph S. Villagomez:</u> I apologize for that. Recognize Representative San Nicolas.

<u>Representative Patrick H. San Nicolas:</u> This bill Mr. Speaker, I would like to take this opportunity to highlight a report issued today in Saipan Tribune entitled "Domestic and sexual violence still vastly underreported in the CNMI." Mr. Speaker, the article highlights the fact the barrier still prevent victims and survivors from seeking help to report the domestic and sexual violations especially in the LGBTQ community according to Ms. Kiki Igitol Benjamin of the Coalition Against Domestic and Sexual Violation who was a panelist of Health and Welfare. The Committee Pride Talks panel reported the barriers including social anti-LGBT bias, racism, sexism and homophobia. Mr. Speaker, I believe it is incumbent upon us to pass this legislation to help break those barriers the reporting domestic and sexual violence regardless of sexual orientation. I would also Mr. Speaker would like to thank the Chairperson of the Health and Welfare Representative Tina Sablan and the committee members for hosting the first CNMI Pride Talks here in the House of Representatives. Thank you, Madame Chair and thank you Mr. Speaker. I yield back.

<u>Representative Ivan A. Blanco:</u> Thank you very much, Mr. Speaker. Communication 22-45, if I can just seek clarification – is the letter from the Governor's Ofice allocating the full ARPA funding of half a billion dollars for fiscal year FY21 only?

Speaker Edmund Joseph S. Villagomez: Can you repeat that please?

<u>Representative Ivan A. Blanco:</u> So, I missed where I read it, but it mentioned that they're allocating the whole amount of half a billion dollars to different reasons – purposes, but I fail to see where it specifically says whether it's for a particular fiscal year or for both fiscal years FY22 and FY23. If anybody knows any information on this could be clarification on that?

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Blanco. First I'll recognize the Vice Speaker.

<u>Vice Speaker Blas Jonathan "BJ" T. Attao:</u> Thank you. The Chairman of Ways and Means correct me if I'm mistaken, but a portion of the ARPA funds have been distributed for the current fiscal year 2021 and then the remaining will be for fiscal year 2022, but we got to remember that these are outside sources and there's a date attached to it. The expiration date of the funds. I am not certain the exact date of the funds, but I know that they're non-lapsing funds for those that are being designated the funds at the present time for 2021. So, you could carry over funds for 2022 and I guess again, the expiration date; I am not a hundred for sure when they actual expiration date, but we all know that it's for two years. So with that, thank you, Mr. Speaker, and I hope Leader that's enough for you?

Representative Ivan A. Blanco: So clarified. Thank you, guys. Thank you, Speaker. I yield.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Vice Speaker. Thank you, Representative Blanco. Chairman of Ways and Means did you want to add?

<u>Representative Donald M. Manglona:</u> Well, I just wanted to ask him. It seems like just for the operations alone, they've identified \$250 Million. Do you see that, Vice? \$75 Million for the current fiscal year and \$175 allocated for fiscal year 22, that can be found on page seven.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Clerk. With all 18 members voting "yes," House Bill 22-27, HD1 is hereby adopted. Floor Leader.

Representative Joseph A. Flores: Privilege Mr. Speaker before we move down to Miscellaneous.

Speaker Edmund Joseph S. Villagomez: Recognize your privilege.

<u>Representative Joseph A. Flores:</u> Thank you, Mr. Speaker. I just would like to ask the JGO committee regarding one of my bill 22-3. I introduced this bill back in February 19, 2021 on our first session and in the last session your committees encouraged members that have bills to at least attend their committees and try to justify the bill that they are introducing and I did this Mr. Speaker on the first session and up to this day this bill regarding this vehicle registration, we haven't gotten any to whether up to the board calendar for passing or anything, or any subcommittee from the JGO and I would just like to get an explanation as to what the status and is there any controversy regarding this bill? This is a recycled bill. It was passed in the twenty-one. I don't know why what's the reason it's holding up and at the same time, if everything works well, I would like to request from the Floor Leader if this can be placed in the bill calendar for the next session.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Joe Flores and if it's okay, I'd like to recognize the Chairwoman to respond. Thank you.

<u>Representative Celina R. Babauta:</u> Thank you, Mr. Speaker and thank you, Representative Flores. We are proceeding cautiously in the JGO Committee. We're still waiting comments. I have spoken with BMV and they are not in support of this bill. If you could provide research and even the Attorney General's Office has written comments that – there's nothing that this bill proposes to fix. There's nothing broken with the current system and we are prioritizing certain bills. Even my bills are in my committee and I haven't passed it out of committee yet. So, it's not like we are, you know, picking sides or picking bills that we want to pass. Even my bills are still in committee and we are meeting every week. We've scheduled meetings regarding the bills and at this time the stakeholder most effected by that bill does not support it. They do not have the supplies to support that bill at this point. That's what they have told me. And I'm trying to get

their written comments and there's still, I don't know, what's their holdup, but they haven't provided me written comments, but I have spoken with them. Thank you.

Speaker Edmund Joseph S. Villagomez: Recognize Representative Flores.

Representative Joseph A. Flores: Thank you, Mr. Speaker. Mr. Speaker, this bill actually is to try to make people have their registration coincide with the insurance. It's something to make it easy for everybody to coincide with the expiration of the driver's - the vehicle registration and insurance, if can see the motorist out there, I don't understand why motor vehicle is not going to be in support with this, because there's been a practice that motor vehicle that people register their cars and they have their insurance and as soon as they register their car, they go and terminate their insurance because their car has been registered already. And in doing this, it's like we're obligating the motorists to register the car in motor vehicle to be on line with all the, because it was registered out there to have it one year to be registered. And this will actually give the motor vehicle benefit to hire a person to do an investigative - to catch those motor vehicles who are unregistered because they already their motor vehicle would be set for one year. Now every motor vehicles that have been registered one year, but the insurance already registered or insured for six months. This bill is just to make it coincide for the whole year. There's nothing wrong with it. I don't see that motor vehicle is going to make revenue if the motorist wants to make their vehicles coincide in the year \$2500 additional. That's an option that is not mandatory but it's an option for the motors. And in that case, I would like to see it, we've been in the past, we've been passing bills with any other comments from the stakeholders. I don't know why we keep waiting for motor vehicle, let's just move on and let's put in the table, if it fails, it fails, but we're not going to keep waiting until Christmas. Thank you, I yield.

Speaker Edmund Joseph S. Villagomez: I'd like to call for a quick recess.
