The House of Representatives of the Twenty-Second Northern Marianas Commonwealth Legislature convened its First Day, Second Regular Session on Tuesday, August 3, 2021 at 1:41 p.m., in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Edmund Joseph S. Villagomez, Speaker of the House, presided.

<u>Speaker Edmund Joseph S. Villagomez:</u> Please rise for a moment of silence and when we do, I would like to ask everyone to remember the late Representative Ivan Blanco as well as his wife Carmen and children in your prayers. We mourn with them the loss of a humble servant leader, our colleague and friend; the late Representative Ivan Blanco who will be greatly missed, but not forgotten.

The Clerk called the roll and nineteen members were present; Representative Ivan A. Blanco was absent.

RULE IX. BILLS, RESOLUTIONS AND AMENDMENTS Section 8. Referral of Bills and Resolutions

(a) Bills and resolutions shall be read by title upon introduction and (except as provided in subsection (b), the Speaker shall refer such measures to an appropriate committee or to more than one committee, jointly or sequentially. The Clerk shall endorse such reference on the measure before duplication and shall enter such reference upon the Journal. In the case of error of reference, correction may be made by the House, with debate, immediately after the reading and approval of the Journal, by unanimous consent, or upon motion of either committee claiming jurisdiction or the committee to which the measure has been erroneously referred.

(b) The Speaker may place a resolution directly on the Resolution Calendar, rather than refer it to a committee, subject to appeal to the House.

Speaker Edmund Joseph S. Villagomez: Legal Counsel?

<u>Legal Counsel Joseph Taijeron:</u> There's always time to do it and it would take some time to do it in the committee report. So, if we want to just effectuate the change in the bill itself –

<u>Representative Christina Marie E. Sablan:</u> Sure, but what I'm suggesting is prior to transmittal to the Senate that the correction be made.

<u>Legal Counsel Joseph Taijeron:</u> We're prepared to do it in the bill itself 22-70 where the change would be most necessary, we could add the change to the committee report, but that would take additional time.

RULE VII. COMMITTEES GENERALLY

Section 9. Committee Reports; Other documents

(a) Standing or Special Committees shall submit a written report to the Speaker within 60 days from the date the matter was referred to the committee, unless a shorter or longer time is ordered by the Speaker pursuant to a decision by the House Leadership. Subcommittees shall submit reports on matters referred to them as prescribed by the Standing Committee Chair. Standing, special and conference committees shall submit their reports in writing and provide an electronic copy to the Clerk who shall number the reports consecutively in the order received, cause such reports to be reviewed for legal sufficiency, reproduced, and furnished each member of the House at least twenty-four hours prior to the session at which it is to be considered. A committee report shall state findings of facts and conclusions based thereon together with a specific recommendation as to the manner in which the bill, resolution, or other matter referred to the committee should be disposed of by the House. A report recommending a bill or resolution for passage shall clearly state the purpose of the bill. A report on a bill or resolution shall show clearly any proposed amendments and the Clerk shall place such a bill or resolution on the appropriate calendar.

(b) A report shall be considered adopted by a committee when the Chairperson and a majority of the members of the committee have signed the report concurring therein. A member or members not concurring in the report of the majority may so indicate by submitting a minority report which shall be attached to the committee report or by signing with "I do not concur".

(c) When a committee recommends that a bill or resolution be formally filed (indefinitely postponed), the recommendation is reported to the House floor as a committee report to be confirmed by majority vote. Adoption of the committee report by the members has the effect of officially filing the bill.

(d) When, by majority vote, the House adopts a committee report recommending favorable action on a bill or resolution, the bill or resolution as reported by the committee shall be placed on the appropriate calendar for House floor action.

(e) All documents, testimonies, or other evidence submitted to any standing or special committee or subcommittee in connection with any matter referred to the committee or subcommittee shall be the property of the House. The Chair of any committee or subcommittee shall deliver all such documents, testimonies, or other evidence to the House Clerk upon expiration of the term of the House. Such documents, testimonies or other evidence may be attached to committee reports as supporting documents.

RULE IX. BILLS, RESOLUTIONS AND AMENDMENTS Section 9. First Reading of Bills and Resolutions

(a) When a bill or resolution is read in the House the first time, the Clerk shall report the bill by title, unless a majority orders it read in full, or by such subdivisions as the motion to read may indicate. The House shall then proceed to debate the measure, and no other amendment shall be in order until all committee amendments shown in the Committee Report are disposed of, except that such committee amendments shall themselves be subject to amendment. At the conclusion of a debate the House shall vote on passing the measure on First Reading after affording an opportunity for one motion to recommit with or without instructions. If the Measure passes with amendments, the Clerk shall engross such amendments and cause the measure, or any page thereof, to be reprinted as provided in Sections 4 and 6 of this Rule.

(b) If a bill passes First Reading, the Clerk shall place it on the Bill Calendar for Second Reading the next legislative day.

(c) First Reading of a resolution shall be the only and final reading, and upon its passage, the Clerk shall dispose of it pursuant to Section 14 of this Rule.

Section 10. Second Reading of Bills

(a) When a bill is read in the House a second time, it shall be considered in the same manner as for First Reading, except that further amendments shall be in order without regard to whether or not they are proposed by the committee reporting the bill.

(b) Second Reading of a bill shall be the final reading, and upon its passage, which shall be by Call of the Roll, the Clerk shall dispose of it pursuant to Section 14 of this Rule.

The motion was seconded.

There was no discussion and the motion to suspend Rule VII, Section 9 and Rule IX, Sections 9 and 10 was carried by voice vote. There was no "nay" vote.

The Chair recognized the Floor Leader.

The Floor Leader made a motion to pass the following legislation:

H. B. NO. 22-74

To make appropriations for the operations and activities of the Government of the Commonwealth of the Northern Mariana Islands, its agencies, instrumentalities, and independent programs, and to provide budget authority for government corporations for Fiscal Year 2022; and for other purposes.

The motion was seconded.

Under discussion; the Chair recognized Representative Donald M. Manglona.

Representative Donald M. Manglona: Thank you, Mr. Speaker. Good afternoon colleagues, I know there are a couple of amendments that will be introduced today, but before I do I'll just briefly go over some of the actions that the committee has taken to provide you the this budget bill, but before we do colleagues I just want to take this time to share with you that the role our dear colleague Representative Blanco has played in the work of the committee as you know Rep. Blanco shared the Ways and Means in the last legislature and because of his expertise and his experiences as well as his relationship with these agencies I knew I could trust and rely on him to step in when whenever I'm unavailable and to offer his guidance on how we should proceed during this budget process. And while his feet were smaller than mine you know I had bigger shoes to fill and so today we are here to deliberate on this budget bill and that I pray for his continued guidance from up above so that we can all come together and address any concerns that the members may have so that we can pass the best version of this bill and so that we can send it up to the Senate for consideration. So with that, said you know I just want to take this opportunity as well to thank all those who have partaken in this lengthy budget process my appreciation goes out especially to the municipalities, agencies and department heads who came out to testify as well as all those who have provided the committee with a copy of their budget proposal. I would especially like to thank the committee members as well as the LB staff for their tireless efforts in ensuring a balanced budget, which we now have in front of us. So, while we had hoped to see an increase in local resources, we were once again challenged to distribute a budget very much like last year. However, with the great work of Congressman Kilili and those

who assisted in getting the ARPA pass which provided around half a billion dollars to the Commonwealth we were able to make these informed decisions taking into account the governor's spending plan, which was in displayed in volume four. Now while we may see significant changes to the general fund we did so knowing that the department and agency requests were addressed in the ARPA allocations. OMB has acknowledged the provision in the appropriations bill that clarifies the authority of the agency heads to have the reprogramming authority from any funds allocated to personnel down to non-personnel in order to meet the upper agency's operational needs. So with that said, members I'd like to point out several provisions that the committee has proposed. A couple of items on the provisions were carried on from last year, but some of the major additions that we had or included the Medical Referral being transferred to CHCC along with any funding that was proposed based on the governor's executive order emergency power limitations this will only apply within the executive branch and will require a 60-day legislative approval per the constitution. Another provision we added was to require finance to submit financial records of quarterly allotments, monitoring while we do get financial status reports these quarterly reports that we added are particularly for PSS, Department of Labor in regards to CW funding, NMTI, CACC, NMC and MVA; the committee had proposed to allocate \$50,000 to the department or sorry Office of Personnel Management, for the desk audit of the Department of Public Safety and Department of Corrections. Another provision that we added was the OPA 1% fees where we authorize the Secretary of Finance to establish a separate account to deposit all OPA fees so that allotments can be made on a monthly basis. Another provision is to create a business unit into which 5% of money allocated to all subaccounts \$64,570 shall be used for purchase of indigenous art person went to 1 CMC 7203 this would require all agencies that have proposed funding for office furniture under 1 CMC 7203 it says that 5% of that shall be used for indigenous arts and that if the agencies fail to do that then that 5% will be deducted in the preceding fiscal year. We also allocated \$50,000 to PSS to conduct a feasibility study for Hopwood to determine whether Hopwood shall be moved or stay where it's at. FEMA gave them a five-year deadline. We are now in year four and so they will need to make a decision within the year. We've also allocated \$50,000 to the Office of Planning and Development to do a feasibility study or a market study on the regulatory review of the casino gaming industry and as I stated earlier Secretary of Finance is the authorized expenditure authority with the U.S. Treasury and with that in mind there have been a an infusion of funds within the personnel portion of the ARPA allocation and we wanted to emphasize as it was stated in Commonwealth law and since the Secretary of Finance had extended the expenditure authority to department agency heads and the mayors of the municipality we wanted to emphasize that funds can be moved from personnel to non-personnel in order to meet the operational needs of the office. And to tie it all together, one main provision that we had included is that you know although we do not have the authority to appropriate the American Rescue Plan Act funds we made our decisions on the general fund side based on the Governor's spending plan, again you will find that in volume four and so with that in mind the committee has agreed to consider the governor the Governor's proposal and that any changes to that proposal shall require legislative approval. And so with that another in regards to changes in Schedule A we've established the Mental Health Court within the judicial branch as well as providing the adequate staff in order to run the court. We've removed all vacant FTEs that did not have any names listed and were not funded and then we put back those NOPs that we felt is needed by the department or municipality and based on their request during the budget hearings. What will be proposed is to establish the FTEs for NMTI, which was in the House Resolution that Representative Leila introduced and we passed in the House, but it's still sitting in the Senate so these NOPs have not been established yet and so that will be one of the amendments I will be making today. The rest,

again members these are similar to last fiscal year's provisions the ones that I did not mention. With that members, I now would like to offer a floor amendment.

<u>Representative Donald M. Manglona:</u> The fourth amendment, Counsel can you please bring it up? During the public comment Ms. Sonia propose that we include the judiciary in terms of not

having them to go through the same processes and from my recollection in the last legislature they have submitted a proposed regulation procedure, which the House accepted.

<u>Representative Christina Marie E. Sablan:</u> So, this is a three-part amendment, correct? The first one pertaining to NMHC, the second pertaining to NMTI and then this third pertaining to certification of funds.

<u>Representative Donald M. Manglona:</u> Four. Sorry, the first is NMHC, the second is the funding portion, which added the NMHC.

Representative Christina Marie E. Sablan: Okay. So, we're voting on all four at the same time.

Representative Donald M. Manglona: Yes.

Representative Christina Marie E. Sablan: Okay. Thank you. I yield.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Tina Sablan. Any further discussion?

Several members voiced "ready."

There were no further discussion and the motion to adopt the floor amendment offered by Representative Donald M. Manglona was carried by voice vote. There was no "nay" vote.

Under discussion; the Chair recognized Vice Speaker Blas Jonathan "BJ" T. Attao.

Vice Speaker Blas Jonathan "BJ" T. Attao offered the following floor amendment:

1. Page 30, Line 1:

To amend subsection (g)(2) of Section 703. Legislative Branch. To read as follows:

"(2) Of the funds appropriated to the Legislative Bureau Operations, BU#1770, \$100,000 shall be used to fund a Forensic Audit of all federal funds appropriated and/or received by the CNMI from September 2018 to the end of Fiscal Year 2022 beginning March 2020 to June 30, 2021. The forensic audit shall be conducted by a forensic accountant or other qualified certified public accountant and its findings shall be made public and presented to the legislature no later than 180 days after it is awarded the contract by the Legislative Bureau. All audited entities are hereby required to fully cooperate with said audit. The auditor shall report to the presiding officers if any entities fail to cooperate with the audit.

2. Page 30, Line 10:

To Delete in its entirety, subsection (g)(3) of Section 703. Legislative Branch.

"(3) Under the Legislative Bureau Personnel, BU# 1770, the following 3 new positions are hereby authorized: (1) paralegal; (1) legislative assistant and (1) information technology assistant to provide professional services to both houses of the legislature."

<u>Vice Speaker Blas Jonathan "BJ" T. Attao:</u> But the understanding that the three positions will remain with the Legislative Bureau one of those positions will be for an IT person and the other two will be determined by the Legislative Bureau Director and the Legislative Bureau of staff whether the need of one paralegal for each house or one additional legislative assistant for each house.

The motion was seconded.

There were no discussion and the motion to adopt the floor amendment offered by Vice Speaker Blas Jonathan "BJ" T. Attao was carried by voice vote. There was no "nay" vote.

<u>Speaker Edmund Joseph S. Villagomez:</u> House Bill 22-74 is now in the form of House Draft 2. Any further discussion? Recognize Representative Angel Demapan.

Representative Angel A. Demapan: Thank you, Mr. Speaker. And while I commend Chairman Donald and the Committee on Ways and Means for the meticulous job of coming together and formulating this budget bill before us. I have one recommendation for consideration it's not necessarily an amendment to the bill, but before you, each of you have a copy of this detail Schedule A showing three columns, no changes to the original Schedule A; however, just for reference purposes for our government stakeholders and our community I think it's important that we show them in totality how much funds is going to each respective business unit. We do realize that there were some reductions made to certain business units, but that's because there were funds supplemented from the ARPA funds that are set aside for next fiscal year. And so, the detail Schedule A before you is a recommendation to reflect the general fund column, which is available for appropriation in this budget bill and reflect the governor's proposal for ARPA or FY 2022 and then finally the last column reflects the combined total to each business unit just for the sake of every activity to understand and comprehend why changes were made in the general fund and how they get it back under the ARPA allocation. So, with that Mr. Speaker, I asked for the indulgence and the consideration of Chairman Donald and members to replace Schedule A on the bill with the new Schedule A that's before us. Thank you.

Speaker Edmund Joseph S. Villagomez: Thank you, Representative Demapan.

Vice Speaker Blas Jonathan "BJ" T. Attao: May I speak?

Speaker Edmund Joseph S. Villagomez: Recognize the Vice Speaker.

<u>Vice Speaker Blas Jonathan "BJ" T. Attao:</u> In line with Rep. Demapan, if the members can go to the bill as a form of draft 2 under page 42, which is outside sources and under 42 (d) on page 46 it talks about the American Rescue Plan and one of the last portion of the first sentence under line 12 it states "spending plan has set forth in volume four of the Governor's annual budget submission of 2021 as amended in July 2021." The reason for I believe Rep. Demapan's change in this is because not every member that's going to receive or any government entity that's going to be receiving their funds or even they're going to look at the budget bill itself doesn't reflect an appendix that what we're trying to say under Section (d) on page 46 so this led this replacement will actually show them the detail of what's the intent of the trends the actions of the committee

and to assist the recipients of the appropriations act as to why they were increased or decreased and a reflection of what they will be receiving under the ARPA. I believe that's correct now Rep. Demapan? So, with that, I think it's good that we would replace the appendix with the specific appendix so it follows the legislation through and when it does get to the administration at least there's a reflection of what the intent of the distribution of the ARPA funds as well. Thank you, Mr. Speaker.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Vice Speaker. Representative Manglona, did you have your hands raised?

<u>Representative Donald M. Manglona:</u> Yes. Thank you, Vice Speaker. I just want to proceed with caution in terms of including anything other than what we're able to appropriate. It is good to have it for informational purposes, but nothing – what we have in front of us is just the what was taken out of volume four no changes to any ARPA allocations, but thank you again for bringing it up as we know agencies have been calling in regards to their allocations under the general fund, but if we add what we have in Schedule A to what was proposed in volume four that should come up with the totals that will that should be allocated to all entities. Also keep in mind the current fiscal year agencies were given ARPA as well and those funds can be used next fiscal year so any funds that they weren't able to use this fiscal year will be rolled over and added to what's proposed for fiscal year 2022. Thank you, Mr. Speaker.

Speaker Edmund Joseph S. Villagomez: Thank you, Rep. Manglona. Recognize Vice Speaker.

Vice Speaker Blas Jonathan "BJ" T. Attao: Thank you. And thank you for that Rep. Manglona, but if we can refer to the language under Section (d) of American Rescue Plan it already states that absent legislative consent in the form of a House Joint Resolution, the Governor shall make no changes to the allocations of outside source funds in the American Rescue Plan - spending plan has just set forth in volume four; therefore, the replacement of this appendix would will strengthen the language of what the committee came up with under the American Rescue Plan, so that every entity that will be receiving funds whether from the general fund or from the American Rescue Plan will see that those monies it should be at that amount. This is just going to follow the legend the bill itself all the way through, we understand that we're only appropriating the general fund monies that were identified for the literature for preparation purposes, but we're also putting in language on page 46 the consent of the legislature to a joint resolution I think it's formal to say that that we also show the ARP monies and the total that each entity will be receiving inclusive of the ARP. We've already got that language, we might as well show the entities how much they will be receiving and if there's any changes and this bill does go all the way through without any amendments and specifically to this section it strengthens this body in making sure that the entities will be receiving the exact fonts that we've appropriated and the outside sources that they've been identified to receive. I think it's important colleagues. Thank you, Mr. Speaker.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Vice Speaker. Recognize Representative Tina Sablan.

<u>Representative Christina Marie E. Sablan:</u> Thank you, Mr. Speaker. And while I understand the rationale for providing within the budget act information about how the ARPA funds are to be allocated to the different departments and agencies of the government, I do share the Chairman's

concerns about proceeding with caution for all the reasons that he mentioned. I do think also that there may be some confusion about the NOPs that we attempt to provide some guidance and limitations on at least with respect to general fund appropriations. I think that there could be some confusion created to have this schedule substituted wholesale with a new schedule that really hasn't been subject to review by the committee. This is the first time, I'm seeing this we haven't really had a chance to validate the figures and I would not want to just substitute in this this new schedule without the committee having had the opportunity to consult further with our fiscal analyst and verify these numbers and also you know we just adopted some changes. We should go in and make sure those are accurate too. I would not feel comfortable just substituting this without further review. You know perhaps we consider once we have validated these figures attaching this as a Schedule (b) for informational purposes, I do agree that there is value in the members of the public as well as the agencies that are receiving local as well as ARPA funds to see these figures side by side, but I'm not comfortable at this point which is wholesale substituting without further review. Thank you.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Rep. Tina Sablan. Any further discussion? Recognize Vice Speaker.

Vice Speaker Blas Jonathan "BJ" T. Attao: I'm sorry members, I know we only do two rounds, but just on the budget right. I understand Rep. Tina Sablan and good Chair's thoughts of proceeding with caution, but I'm sure that the committee also looked at the ARPA funds and how much specific departments or line-item agencies were going to receive from the ARPA funds; therefore, you were able to adjust the general appropriations because of the impact of the ARPA funds. Failure to see the ARPA funds, I don't think the big – I think it was roughly about \$8 million dollars that was distributed around. Failure for that ARPA funds to be visible for the committee to make decisions you wouldn't have moved \$8 million dollars just like that. I think the subsidized funds from ARPA is a reflection of a lot of the actions that the committee made. It's really important colleagues, we all know 22-33 sitting in the Senate and the attempt of the language on page 46 is to strengthen the opportunity to make sure that we have some influence through 22-33 without acting on 22-33. So, if we're going to do that let's make it full-blown and make sure that the entities understand what they should be receiving. If we don't do that, if we don't show them the appendix of what they should be receiving, how would they know whether they're getting the total amount that was really under volume four? And there's nothing in the ARPA funds that broke down anything to specific government agencies or branches or entities to get the specific amount of funds. I understand we've seen on the ARPA funds that we're supposed to receive about \$150,000 for the legislative branch per member, what if those funds do not come? At least with this appendix is a reflection of the action and the position of this body that we will continue to fight for the monies for the various entities, because at the end of the day it's going to be this body that's going to make the appropriations. CHCC, we just put Medical Referral under CHCC. We put \$2 million dollars under them. ARPA's reflecting additional \$15 million dollars, what if they don't get the money from ARPA \$15 million dollars and we're still going to have to subsidize medical referral failure for the administration to identify funds to be submitted here for appropriation purposes for that specific entity is an example is going to be a bigger challenge, but if we have the appendix follow this legislation the very least we can do is fight on behalf of the various government agencies, departments and branches that it's reflective on the submission of the governor that they will be receiving these funds outside of the general fund. It's not saying that we're appropriating ARPA money, but we're making sure that there's something that we can follow down the road maybe six months from now whether each entity is

receiving the amount they should be receiving. Failure to do that we're going to be back to square one. Thank you, Mr. Speaker.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Mr. Speaker. Further discussion? Recognize Representative Patrick San Nicolas.

<u>Representative Patrick H. San Nicolas:</u> Thank you, Mr. Speaker. On page 33, Section 706 for the second senator district, I really want to refer this to our Legal Counsel on line 11 to see if this one is constitutional or not "the appropriation to the municipal council shall be divided and distributed equally to each member of the municipal council in separate accounts and each municipal council members shall be the expenditure authority of all funds distributed to that person."

Speaker Edmund Joseph S. Villagomez: Counsel.

Legal Counsel Joseph Taijeron: I definitely would have to maybe consult with you and Representative Donald from the first senatorial district because this is the language, I believe that we've been using consistently throughout you know the years. I don't believe we've changed it to reflect something different. It's constitutional to answer your question I believe, if there's a specific issue that you think is unconstitutional, I'll be happy to research that maybe during recess, but I don't see any problem with the equal distribution.

<u>Representative Patrick H. San Nicolas:</u> But right now, the Chairman of the Municipal Council of Tinian has the sole expenditure authority. So, if this is not unconstitutional, I would like to offer an amendment that the Chairman of the Municipal Council shall be the sole expenditure authority, instead of the three members.

Legal Counsel Joseph Taijeron: I can draft up that floor amendment, but i need a little bit of time.

Speaker Edmund Joseph S. Villagomez: Quick recess.

The House recessed at 3:28 p.m.

<u>Speaker Edmund Joseph S. Villagomez:</u> Before we went on recess, Representative Patrick San Nicolas had the floor. I now recognize Representative Patrick San Nicolas.

<u>Representative Patrick H. San Nicolas:</u> Thank you, Mr. Speaker. At this time, Mr. Speaker I would like to make no motion to offer an amendment for section 706 line 11 and I would like to thank the Legal Counsel for his legal opinion. I yield, Mr. Speaker. Thank you so much.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative San Nicolas. Any further discussion? Recognize Chairman Donald Manglona.

<u>Representative Donald M. Manglona:</u> Thank you, Mr. Speaker. Before I introduce the amendment, I just want to thank the good Rep. Demapan, Vice Speaker, Rep. Sablan for suggesting that we include the combination of the general fund and ARPA allocation, which will now be reflected in a Schedule (b).

Representative Donald M. Manglona offered the following floor amendment:

Absent legislative consent in the form of a House Joint Resolution, the Governor shall make no changes to the allocations of outside-sourced funds in the American Rescue Plan Act (ARPA) spending plan <u>as reflected in</u> <u>Schedule B and</u> as set forth in Volume 4 of the Governor's annual budget submission of April 2021 and amended in July 2021, that may directly or indirectly affect the appropriations made herein. I appreciate everyone's efforts thank you especially to the LB staff for working past the normal working hours to help the committee and in putting this final product together. So thank you, Mr. Speaker. I yield.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Manglona. Recognize Representative Yangetmai.

<u>Representative Denita K. Yangetmai:</u> I would like to thank everyone for supporting the passage of the House Resolution 22-10. I think it was brought up by Ivan, he was the first one and then the son passed it on to me and then Leila was pushing me to get it through and I thank everyone for your support. Thank you, Chair.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Yangetmai. Any further under miscellaneous? Recognize Representative Joel Camacho.

<u>Representative Joel C. Camacho:</u> Thank you, Mr. Speaker. I know tomorrow, I believe we have our joint session with the Senate. <u>Representative Denita K. Yangetmai:</u> Sorry, I forgot another one. Thanks for your support on the House Local Bill 22-19 about dog owners to pick up after their dogs. This is in anticipation of the tourists that will be attacking us soon, you know they like to take pictures on the walkway and I don't think they'd like to step into those mountains over there. So, thank you again everyone. And also for the health of our people here. Thank you.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Yangetmai. Any more members? Good. Alright, next Announcements? Under announcements recognize the birthday girl Representative Celina Babauta.
