The House of Representatives of the Twenty-Second Northern Marianas Commonwealth Legislature convened its Fourth Day, Second Regular Session on Friday, October 1, 2021 at 2:08 p.m., in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Edmund Joseph S. Villagomez, Speaker of the House, presided.

<u>Representative John Paul P. Sablan:</u> Thank you, Mr. Speaker. I know that our good Madam Chairwoman had stepped out, but maybe perhaps any member of the Education Committee – I just wanted to find out with the bill if we can get an explanation with the concerns by President Galvin Deleon Guerrero and were those addressed by the committee level suppose on the bill.

Speaker Edmund Joseph S. Villagomez: Can I call for a short recess. Thank you, members.

The House recessed at 2:26 p.m.

RECESS

The House reconvened at 2:26 p.m.

<u>Speaker Edmund Joseph S. Villagomez:</u> Before we went on recess, Representative John Paul Sablan raised some questions and if it's ok Representative John Paul can you restate your concerns?

<u>Representative John Paul P. Sablan:</u> Sure. Thank you, Mr. Speaker. I wanted to ask perhaps from the Madame Chair or any member of the Education Committee with regards to concerns by our good President of the NMC (Northern Marianas College) and if we can get an explanation where these concerns embedded on the proposed legislation when the committee had worked on it. Thank you.

Speaker Edmund Joseph S. Villagomez: Recognize Representative Leila Staffler.

Representative Leila Haveia F.C. Staffler: Thank you, Speaker and thank you, Rep. Sablan. I'm sorry for a little bit of delay. I was rereading and rereading just to make sure. In the Senate committee report that originally asked for the NMC comments, it did include specific areas that addressed their concerns. Section 102 in the law, a tuition waiver for veterans included from the Senate committee report, the language that they asked for specifically that "the college shall waive tuition for eligible veterans as defined in Section 101" and that other than cost of tuition these other fees are not waived. It also explains that part C, "the waiver from the tuition does not apply to a veteran who at the time of registration is entitled to receive, but did not apply for educational benefits under both federal and local legislation." So, that would mean they must exhaust their federal benefits and local scholarship benefits that may be used only for the payment of tuition. It goes on to say that if both federal and local benefits are used in a semester, but maybe those benefits are short, then the waiver can still apply in the same semester. So, in the Senate version, they actually did address those issues and I did ask for comments from NMC to say, "was this what you wanted?" and they said in the comments back that "we agreed with the original comments that we sent to the Senate." And so that was one way that we addressed that issue, but we went a step further even, and included a Section D that "this waiver shall not apply to any courses from which the veteran is withdrawn after the withdrawal period or for any courses, for which the veteran has failed to receive a passing grade." And so that way the accountability is back on the person to make sure that they, you know, meet the expectations of that and the scholarship won't be wasted. I hope that answers your question.

Speaker Edmund Joseph S. Villagomez: Recognize.

<u>Representative John Paul P. Sablan:</u> Thank you, Mr. Speaker. Thank you, Madame Chair for the very thorough explanation. I think perhaps some of us haven't had the opportunity to review the second communication that you have from President if you are able to share that with us and I yield for now, Mr. Speaker. Thank you.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative John Paul Sablan. Recognize Representative Leila Staffler.

<u>Representative Leila Haveia F.C. Staffler:</u> Thank you. It is included in the committee report dated August 27th. NMC did reply that they fully support the following position that were submitted in March of 2021. And if you look at the committee report, those areas were addressed. And so, we did not go further into that area because they confirmed that it was addressed. So, I hope that answers it. Thank you.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Staffler. Any more discussions on the floor? Recognize Representative Celina Babauta.

<u>Representative Celina R. Babauta:</u> Thank you, Mr. Speaker. I just wanted to register a concern, Section 101 entitled "Definitions. Eligible veteran means a CNMI resident who is an active member of the United States Military who served in active federal service under Title 10 or Title 32 of the United States code." I just wanted to register my concern that this will exclude the U S Army reservists currently serving in the CNMI.

<u>Vice Speaker Blas Jonathan "BJ" T. Attao:</u> Mr. Speaker, just a point of clarification to state my –

Speaker Edmund Joseph S. Villagomez: Recognize Vice Speaker.

<u>Vice Speaker Blas Jonathan "BJ" T. Attao:</u> Sorry for cutting you off Rep. Babauta. I know that you're discussing the legislation itself right now. We're only on the committee report and if we do adopt the committee report, that'll be the right timing when we get to Bill Calendar to discuss the specific concerns, but till we address the committee report then we can start talking about the bill itself.

Representative Celina R. Babauta: Thank you.

<u>Representative Edwin K. Propst:</u> Mr. Speaker, before we debate the bill, is it okay if we take a short recess?

Speaker Edmund Joseph S. Villagomez: Short recess.

<u>Speaker Edmund Joseph S. Villagomez:</u> Before we went on recess Representative Ed Propst had the floor and I'll recognize Representative Ed Propst.

<u>Representative Edwin K. Propst:</u> Thank you, Speaker. We've resolved our differences. Thank you. We're good. Thank you.

<u>Speaker Edmund Joseph S. Villagomez:</u> You don't want to put that on the floor? Just kidding. Any other member for discussion? Recognize Representative Celina Babauta.

Representative Celina R. Babauta: Thank you, Mr. Speaker. And you guys have heard me go against this bill. We have heard today from the President of the Northern Marianas Insurance Association, I thank you, Sir for your comments. You know, my concern for one and I hope the association considers this is that what if, you know, in the future, they want to write six-month policies as other stateside insurances do. That's something for them to consider. Also, the author has touted that this is a revenue generating bill and how can he say that when this bill offers a significant discount to two or more vehicles and the fact that the Association President has supported this bill is all the more reason why we don't even need legislation. They could easily write it into their policies, but I want the president of the association to know that the JGO Committee, which had jurisdiction over this bill was never given the opportunity to debate and discuss the merits of this bill. The pros and cons that you speak of. We were never allowed that opportunity because the author requested the Floor Leader to exercise his authority, to yank it out of the committee. And so, it was yanked before we addressed any flaws of the bill and I will yield to the Association President because he has, you know, made the effort to come here and state the position of the association and he also mentioned that there was division in their association. So, I'm ready to yield to the president of the association, knowing now that I have

informed him that there was never an opportunity to deliberate on this bill and to address any concerns that the association may have had. Thank you, Mr. Speaker.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Celina Babauta. Any further discussion? Recognize the author.

Representative Joseph A. Flores: Thank you, Mr. Speaker. From the Chairwoman from JGO, she mentioned regarding me saying it's a generating revenue bill. Yes. It will be a generating revenue bill if a vehicle that the person has more than two vehicles he's going to make it coincide with the same year with those vehicles that will be generating because he will be paying \$25 in order for them to change the registration to make it on the same month that the vehicles is to be expired. That's where the generating comes in. As far as putting together with the expiration of the insurance and the registration that's the main purpose of this bill. The option is for you to put two vehicles in the same month. That's where you, if you can afford it, that's when you avail to it. If you don't want to do it, you don't have to do it, but it's there for you to have to do it. And also, her mentioning that the Committee of JGO never had the opportunity to hear the concern of the insurance. The insurance were never even informed regarding this. This bill was introduced since January. It was hanged up a couple of months ago. How many – it last more than 60 days. That's a lot of the ample time for them to look for the committee. I even came to their committee hearing and even present my comments. After that it didn't go anywhere. That's why I moved. I had it yanked it out so I can have it move forward and have this bill. This bill is generating bill. This bill was introduced last legislature on the 21. So, it's my goal to have this goal. I know this could be a policy, but even motor vehicle would not do it for what the customers are trying to do to have their registration and their insurance coincide the same day. So, doing this is like we're obligating it for them to do it. There's no charges it's just them putting the months together and have it expired the same day. The only charges that's going to be there is if you have more than two vehicles to coincide expiration date with the month that you prefer. That's all. Thank you, Mr. Speaker.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Flores. Any more discussion? Recognize Representative Celina Babauta for the second round.

<u>Representative Celina R. Babauta:</u> Thank you, Mr. Speaker. The fact that it is optional is not revenue generating in my opinion, because if nobody wants to do it, there's going to be no revenue coming in. Also, the author has repeatedly said, this is a revenue generating bill and next time I hope that he can back it up with cost benefit analysis for the committee to consider. That is all.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Celina Babauta. Any further discussion? Alright with no further discussion, Clerk please call the roll.
