The Floor Leader withdrew his previous motion and offered a motion to accept Senate Communications 22-61 to 22-64 and 22-67 so they may become property of the House.

The motion was seconded.

*Under discussion; the Chair recognized the Vice Speaker.* 

Vice Speaker Blas Jonathan "BJ" T. Attao: Thank you, Mr. Speaker. This is regarding Senate Communication 22-66 transmitting for the House action Senate Joint Resolution 22-5 entitled, "Approving the Governor's request to create a new program and business unit for retirees bonus and to reprogram \$1.3 million from the general fund for the payment of retirees \$500.00 bonuses." Mr. Speaker and colleagues, first of all, I'd like to extend our appreciation to the Senate for taking action on this legislation. Unfortunately, as we're all aware, any distribution of funds should begin in the House of Representatives and failure for those actions and anything that has to do with revenues that's moving from the Senate is deemed illegal under the constitution. It's the authority of the House of Representatives to move those funds. In addition to that, the Governor's letter to the Speaker and the Senate President had reflected that the specific accounts be utilized, which is the discretionary accounts for the Governor and Lieutenant Governor and other accounts within the Department of Finance should be reprogrammed. Unfortunately, those documents were not provided to us. In addition to that in the letter, it says that there'll be supplanting or backfilling their accounts through ARPA funds. We all know that under ARPA, we cannot use any of the funds to address pensions, which in this case is being viewed as pension, a \$500 bonus to the pensions that our retirees are receiving this body is not against assisting the retirees. It's been very clear that this body has introduced multiple legislations in support of our retirees i.e. 19-21, 20-28, 21-76 that never left the legislative body. So, just in the analysis, the reprogramming of funds involves the reallocation of appropriated funds from one agency or the executive branch department program and function of other subject classes to another, which already entitled that they're moving funds through changing the planning of the budget act under 22-8 and so we need to address that. The request by the Governor, we do not know which programs or activities are affected in fiscal year 2022 enacted budget whose funding levels will be reduced to the level of \$1.3 Million Dollars. In addition, we do not know the fund status of these accounts as of the date of the Governor's letter to the presiding officers with the legislature. Alternatively, the Governor offered as mentioned to use appropriate discretionary funds of the Governor and Lieutenant Governor, as well as funding sources from the Department of Finance. No financial information have been provided by the Governor to determine the amount of money available and the discretionary funds, as well as the funding sources of the Department of Finance. We do not know the fund status of these funds as of date, when the Governor's request was submitted to the presiding officers of the legislature. The Governor indicated to backfill these programs in the general fund that will be used for reprogram purposes using ARPA funds. No indication from the ARPA activities as to which activities will be used to reduce from the \$175 million spending plan for FY 2022, which is I

believe appendix, B. And with that if they were to supplant the money from ARPA, it would actually increase our general revenues, an additional \$1.3 million. So, we would still have to amend the budget. Anything above \$200,000 or below \$200,000 shall be submitted to the legislature to address the budget appropriation. So, with that being said, that additional \$1.3 million that will be supplanted into the budget act, 25% of that is obligated to go to PSS. So, that would still leave the account short by 25% to address the retirees \$1.3 million. So, with that being said, and the conclusion due to the lack of financial information, Mr. Speaker and members, to make the important decision of whether or not the general fund has the ability to pay the \$1.3 million on bonuses for retirees, I am requesting that we obtain the following financial information to make our assessment and decision-making. One, the actual general fund collections and expenditures, including encumbrances for the two-months ended November 30, 2021 as well as communitive surpluses or deficits for the past months of FY 2022. Number two, the fun status reports as of December 15th, 2021 for the activities in the general fund and ARPA that will be affected by the \$1.3 million reprogramming requests. Three, fund status report as of December 15th, 2021 of the funding sources under the Department of Finance in FY 2022 and lastly, a fiscal identify the base and physically identify the business unit number and the name of the program or activity for which the \$1.3 million worth or the retirees bonus to be accounted for FY 2022 so that the actual letter will be submitted to the legislature with the exact business units that we will be removing \$1.3 million to address the \$500.00 bonuses to the retirees. In addition to that, for the record that were \$1.3 million that will be supplanted back into the general fund is still short by 25% because we still need to address those monies to be heading to PSS. Thank you, Mr. Speaker and thank you colleagues for allowing me the time.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Vice Speaker. Any further under a Senate Communications? Recognize Representative John Paul Sablan.

Representative John Paul P. Sablan: Thank you, Mr. Speaker and thank you Vice Speaker. So perhaps maybe we can as you Mr. Speaker, what is your course of action to proceed with this? I know there's so many concerns with regards to the Senate Joint Resolution and identifying what business units are the administration proposes to tap to provide in the amount of \$1.3. Do we squash this Senate Communication? What is the course of action moving forward? Thank you.

<u>Speaker Edmund Joseph S. Villagomez:</u> For now, I'd like to keep it on the agenda for further review and Vice Speaker?

<u>Vice Speaker Blas Jonathan "BJ" T. Attao:</u> Thank you, Rep. JP Sablan. That's the reason why with our conclusion, there's a list of four needs and requests from the administration to provide this body so that they can identify the actual accounts that they will be taking the \$1.3 million and how will they be putting back the \$1.3 million to address the shortfall of that \$1.3 million going to the \$500 bonuses to the retirees. Again, nobody here has ever voted against the support of the retirees. We, as a body have introduced multiple legislations to address the needs of the retirees. So, we just want the actual information so that these business unit can be created properly and we know exactly which, line item, department or agencies, will be losing \$1.3 million and how they will be addressed with through ARPA and in addition that we have to make sure that the 25% ceiling increases for PSS because it'll change the ceiling numbers of the appropriations act of 2022. Is that clear?

Representative John Paul P. Sablan: Thank you, Mr. Speaker. Thank you, Vice for the clarity.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative John Paul Sablan. I recognized Representative Tina Sablan.

Representative Christina Marie E. Sablan: Thank you, Mr. Speaker. I would like to just echo my concerns as well about which the Vice Speaker did an excellent job laying out already about this Governor's request to create this new program and issue retiree bonuses. You know, unfortunately my impression, I think a lot of us may share this impression is that the Governor made this promise to retirees for \$500 for each of them for a bonus, but without actually checking to make sure that the funds were available in the first place and, you know, we now know ARPA comes, the American Rescue Plan Act comes with many restrictions. And one of my questions would be whether, you know, this proposal, this work around that he's now presenting to the legislature would even be feasible and if we can really use American Rescue Plan act funds to backfill as he put it the short fall that would be created by this reprogramming from the general fund and again, without us even knowing what the Governor would be reprogramming funds from which accounts would be affected it's really difficult for us and unreasonable to ask us to approve this without further information. So, thank you, Mr. Vice Speaker for laying that out. I completely agree with the additional requests for information that you've proposed and I hope to be getting that information from the administration as soon as possible. Thank you and I yield.

So, I understand that a Ways and Means is once again, submitting a request to the Secretary of Finance and you know, I would hope that there would be some briefing for this body shortly, ideally before the holidays. Representative Christina Marie E. Sablan: Thank you, Mr. Speaker. I wanted to first express my thanks to the members of the committee and for this body for considering this bill to establish. A formerly established by law, a prescription drug monitoring program for the Commonwealth. The CNMI is one of the last jurisdictions to move in this direction and the purpose of this bill is

not just to create a database of prescription histories and practices, but really to provide an effective and efficient public health tool that providers, pharmacists, dispensers, public health officials can use to ultimately improve patient safety. We worked very closely with the Commonwealth Healthcare Corporation in drafting and reviewing this bill. The program, there is already a program in place at CHC. They do have funding. They are working with the centers for disease control, but this takes it to the next necessary step, which is to formally establish the program by law, within the administration of the Commonwealth Healthcare Corporation The bill draws on best practices and legislative models from other jurisdictions. The idea, the primary purposes of this tool is to identify potential misuses or overdose risks as well as to monitor and report prescription practices in the Commonwealth and develop interventions, effective interventions to prevent and treat prescription drug misuse or addiction and again, the ultimate goal is to improve patients. We did solicit public comments and receive public comments and we conducted several public meetings of the Health and Welfare Committee during which we reviewed the comments received, and also had a chance to do question and answer and receive presentations from the overdose data to action program that is currently running now at the CHC. So, I would ask for your support for this legislation and if any members have any questions, I'd be happy to address them. Thank you.

#### **MISCELLANEOUS BUSINESS**

Vice Speaker Blas Jonathan "BJ" T. Attao: Thank you, Mr. Speaker. Thank you colleagues. Just want to bring up a concern that was brought up last week and over the weekend regarding the Department of Corrections. So, we all know that there's a few officers that had tested positive and some inmates that have tested positive COVID-19 and their manpower is dwindling pretty quick. They've actually got assistance from the Department of Public Safety. I believe 10 to 20 individuals were officers were sent to assist the Department of Corrections, unfortunately, many of those individuals also caught the COVID-19 virus. So, their manpower's additionally depleted again. So, they're running not even skeleton crew right now. They're really scratching the grounds right now in regards to manpower. A lot of their people who are able to go home for a couple hours, but have to go back to report back to the office because of the inability to service with the manpower that they have. So, Mr. Speaker and colleagues, I think the rightful committee should look into this issue and maybe look at the opportunity if there's a financial assistance coming through the request of this body or to the Speaker's office on the \$500 for the retirees bonuses that maybe we can request also additional, maybe some sort of an emergency hiring for the Department of Corrections to assist them in their situation right now. Unfortunately, we have to provide those services. They have a grant that they have to abide by and with the shortage of manpower, I don't know if we're going to be able to even live up to the grant expectations because of the lack of manpower that they're facing over there. So, I just would like to share that colleagues to each and every one of you and especially you Mr. Speaker, as the head of our House. Thank you again members.
