The House of Representatives of the Twenty-Second Northern Marianas Commonwealth Legislature convened its Second Day, First Special Session on Wednesday, April 27, 2022 at 10:06 a.m., in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Edmund Joseph S. Villagomez, Speaker of the House, presided.

The Chair appointed Representative Donald M. Manglona to serve as Floor Leader Pro Tempore.

<u>Speaker Edmund Joseph S. Villagomez:</u> Please rise for a moment of silence and I ask that you please keep our good colleague Representative John Paul Sablan and his family in your prayers as his mother passed away earlier this morning. Thank you.

The Floor Leader made a motion to adopt the following Standing Committee Report:

**S. C. R. NO. 22-44:** Reporting on H. B. Under discussion; the Chair recognized Representative Christina Marie E. Sablan.

<u>Representative Christina Marie E. Sablan:</u> Thank you. Mr. Speaker and colleagues, in preparing this committee report, your Health and Welfare Committee reviewed, written and oral comments that were received on the bill from practicing psychologists, licensed in the CNMI, as well as comments from the Commonwealth Health Care Corporation, the Community Guidance Center, the Health Care Professions Licensing Board among other stakeholders. The committee conducted several public meetings and receive testimonies on the bill during committee hearings

as well. Additionally, several members of the committee myself included, attended a meeting of the Healthcare Professions Licensing Board, which had placed review of the bill on their agenda that day earlier this month or last month I should say to share our own comments on the bill and answer questions of the board, which would play a significant role in overseeing the implementation of PSYPACT here in the CNMI. And finally, we closely reviewed PSYPACT informational resources available online at the PSYPACT website and looked at the increasing number of states now more than half of the states in the country that have enacted legislation to participate in PSYPACT. The CNMI, for the members information, would be the first among the territories to join PSYPACT if this bill is signed into law. I do want to offer just a very minor technical correction to the committee report if I may, Mr. Speaker. On page two of the report, the very bottom of the page second line to the last, the word "being" should actually read "become" and if that could just be considered technical for the Clerk to make before the report is transmitted. I would appreciate that. Thank you. I yield.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Tina Sablan. Legal Counsel and Clerk, please note that as a technical. Thank you. Recognize Floor Leader.

<u>Floor Leader Pro Tem Donald M. Manglona:</u> My apologies, Mr. Speaker and members. Your House Committee in regards to Standing Committee Report 22-44 your House Committee on Health and Welfare recommends that the House passes House Bill 22-80 in its current form with the technical amendments made by Rep. Sablan.

Representative Christina Marie E. Sablan: Thank you, Mr. Speaker. I fully support this joint resolution and want to thank our colleagues in the Senate and particularly Senator Edith Deleon Guerrero for championing this form of relief. We all know and have felt the pain ourselves of rising gas prices in the CNMI and this would help. This would alleviate some of that pain at the gas pump. I do want to note that we also have a House joint resolution that is still pending in the Senate that proposes a new local stimulus in the form of not debit cards, but by cash payments to qualify taxpayers in the CNMI, as well as their dependents and I'd like to ask our Senate colleagues to consider that resolution and past that as well. The administration has so far, at least acknowledged that there's a need for a local stimulus. It sounds like they're still leaning in the direction of debit cards, which we know came with all kinds of inconveniences and hardships and now we're learning from constituents about debit cards that have expired and they weren't aware that there was an expiration date. So, the funds that they've been saving you know, all of these inconveniences would not be an issue if we would just give taxpayers who need this assistance, the freedom and the flexibility to decide how these funds should be spent. So, I wanted to state that for the record and ask our colleagues also for your assistance in reaching out to the Senate to show their support for a new local stimulus that our people really need. Thank you.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Tina Sablan. Recognize the Floor Leader.

<u>Floor Leader Pro Tem Donald M. Manglona:</u> Thank you, Mr. Speaker. I just wanted to enter for the record that there might be a possible conflict of interest. So, I will be abstaining from this vote. Thank you.

<u>Representative Leila Haveia F.C. Staffler:</u> Thank you, Speaker. And I want to thank all of the colleagues for coming together in celebration of Ms. Mihara. Her birthday was this weekend and she celebrated with the family and they're really grateful for us honoring her in this way, especially while she's alive, we can give her this awesome gift that we'll recognize all the years

## H. B. No. 22-95, SS1

A Bill for an Act to amend the Appropriations Act of Fiscal Year 2022 (Public Law 22-08) to establish a business unit for Retirees' Bonus and to reappropriate personnel lapses within departments and line-item vetoes within Public Law 22-08 to fund the Retirees' Bonus; and for other purposes. [*See SEN. COMM. 22-92*]

## The motion was seconded.

The Chair called for a short recess.

The House recessed at 10:34 a.m.

## RECESS

#### The House reconvened at 10:36 a.m.

<u>Speaker Edmund Joseph S. Villagomez:</u> Before we went on recess the Vice Speaker had the floor, so I recognized the Vice Speaker.

Vice Speaker Blas Jonathan "BJ" T. Attao: Thank you. Thank you, Mr. Speaker. Just a brief history of a 22-95, SS1 the Senate passed their version that took lapse funds for WGI's - a potential job WGIS for the remainder of the fiscal year and that was a concern that was brought up by a few government employees that their anniversaries are coming up after the fact of these legislation being passed by the Senate. So, we reached out to OPM and they raised the same concerns. So, with those concerns, we contacted the Secretary of Finance. The Secretary of Finance assured that those monies were actually pre-date backwards. So, the first and second quarter monies that we're supposed to have been reserved for WGI's we're already there. Fortunately, I guess those funds are not used up yet because the anniversary date comes up in May, June, July, August, and September. So those monies are available in addition to those monies that were line item vetoed by the Governor during the budget process under 22-8. So those that freed up the money, the actual amount of money is actually greater than the \$2.6 million that's needed to address the retiree bonuses and the 1% to OPA. So, just a little brief history so that there's knowledge that this is not going to affect the government employees that are due up for their WGI's and even in the submission of the budget proposal, which became 22-8 the WGI's were being addressed by the ARPA funds. So, this won't touch the WGI's that will

be or the government employees that will be receiving their WGI's forward after this bill becomes a law. So with that being said, Mr. Speaker, I'm ready to support 22-95, SS1 and thank you for allowing me to speak.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Vice Speaker. I now recognize Representative Celina Babauta.

<u>Representative Celina R. Babauta:</u> Thank you, Mr. Speaker and thank you for the explanation Vice Speaker, but due to what may be perceived as a conflict of interest, I will abstain from voting while I fully support the bonuses for the retirees, my husband is a retiree and I will indirectly benefit from this bonus. So, I will be abstaining. Thank you.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Celina Babauta. Any more discussions on the floor? Recognize Representative Tina Sablan.

<u>Representative Christina Marie E. Sablan:</u> Thank you, Mr. Speaker. I just wanted to express my appreciation to our colleagues in the House and especially Vice Speaker BJ Attao and Chairman Donald Manglona for the leadership that has been shown in one, supporting the retiree bonus and two, making sure that this bonus was appropriated the right way. Meaning, in the form of legislation as an amendment to the budget act, originating in the House as constitutionally required. Identifying the sources of funding and without granting unlimited 100% reprogramming power to the Governor, which now the Administration acknowledges the Department of finance acknowledges was never necessary in the first place. I also appreciate our Senate colleagues and the Department of Finance for at last bringing to the table the information that we've been asking for identifying the sources of funding and again, acknowledging that this 100% reprogramming power was not needed to make this bonus available to our retirees. I do wish we could have come to this table together sooner, but it is what it is and I'm glad that we're all at the same table now. I'm ready to support this bill. Thank you.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Tina Sablan. Recognize Leader Demapan.

<u>Representative Angel A. Demapan:</u> Thank you, Mr. Speaker. And in that same regard, I also want to express my appreciation to the members of the Senate and our colleagues here in the House and the Administration for finally coming together and finding a resolution to this matter. We've seen it go in numerous, different directions and it became really worrisome for our own retirees and not so much for the legislature. So, to finally get to this point and I'm hoping that at the end of this roll call this bill will be sent to the Governor for action and I too am ready to support this bill. Thank you, Mr. Speaker.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Leader Demapan. I recognize the Floor Leader.

<u>Floor Leader Pro Tem Donald M. Manglona:</u> Thank you, Mr. Speaker. And as the author of this bill, you know, initially 22-95 was introduced to counter the 22-91 and what the Senate had proposed was the a hundred percent reprogramming authority, but you know, as Rep. Sablan had mentioned, you know, all we ever really wanted was to ensure that the monies will be taken out from or will be identified and that's what this substitute did and again, I would like to thank the

Vice Speaker for going the extra mile to ensure that WGI's will not be affected for employees not having, not meeting their anniversary date yet, but moving forward, you know, a part of a transparent and accountability, part of being transparent and accountable for the funds, it's important to identify where these monies are coming from so that we can carefully plan out the next budget or the next requests that we receive from any agencies. And so, with that, with what the Senate had substituted, we're more than ready to support this version. It's something that we, I know our retirees have been waiting for and, we thank them for their patients. And so, I fully support this bill. Thank you.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Floor Leader. Recognize Representative Richard Lizama.

<u>Representative Richard T. Lizama:</u> Thank you, Mr. Speaker and thank you everyone for this bill that we're now do pass for the retirees. I want to speak on behalf of the retiree, as myself, a retiree, but I have not received my pension due to my situation or position right now, but I want to thank them for being patient and I know that they are the backbone of the CNMI progress and they economy. With this \$1,000 bonus that will be given to each retiree will benefit them for sure. As we all know that they have been suffering due to COVID-19 pandemic and the prices have gone up due to the war in Ukraine. So, I salute them and thank you for your patience and a job well done. Thank you.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Lizama. Any further discussions on the floor? Ready?

Speaker Edmund Joseph S. Villagomez: Ready? I now recognize the Clerk to please call the roll.

To have the Commonwealth of the Northern Mariana Islands (CNMI) join the Psychology Interjurisdictional Compact (PSYPACT) to improve and expand access to mental health care in the CNMI; and for other purposes. [S. C. R. NO. 22-44]

## Under discussion; the Chair recognized Representative Christina Marie E. Sablan.

Representative Christina Marie E. Sablan: Thank you, Mr. Speaker. Colleagues, this legislation House Bill 22-80 represents the first step that the Commonwealth must take in order to join the Psychology Interjurisdictional Compact known as PSYPACT, which would greatly improve and expand access to mental health care services for residents in the CNMI. We are aware of a significant and urgent need for increased mental health care across the nation, really, but acutely so here in the Marianas, especially in the aftermath of multiple typhoon disasters and a global pandemic in a relatively short period of time. The CNMI is considered an underserved area and mental health care providers here report that their patients commonly must endure long wait times from months to even over a year before they're able to get care. PSYPACT helps bridge the gap in underserved areas like ours. The compact enables residents in participating PSYPACT states to more easily access, a larger pool of licensed mental health care professionals in participating states particularly through the practice of tele-psychology as well as licenses to conduct temporary practice in participating PSYPACT states. PSYPACT also expands access to specialize mental health services that are often not available in areas like ours, such as services for people with autism or for LGBTQ youth and while PSYPACT helps ease regulatory barriers in order to allow practice across state lines across jurisdictions, it also provides a mechanism for rigorous screening and vetting providers and ensuring the competent and ethical practice of psychology across PSYPACT state. So, colleagues, this bill has received strong support across our community of mental health care professionals, including providers in private practice, in our school system and in the Commonwealth Health Care Corporation and the Community Guidance Center. The Healthcare Professions Licensing Board, which would play a central role in the implementation of PSYPACT here in the CNMI has also expressed their support for the passage of this bill and I'd like to thank everyone who took the time to review this legislation, all the members of the committee, the staff for their diligence and presenting this bill to the full House and I asked for your support as well today, colleagues Happy to answer any questions. Thank you.
