The House of Representatives of the Twenty-Second Northern Marianas Commonwealth Legislature convened its First Day, Fourth Special Session on Monday, July 18, 2022 at 2:09 p.m., in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

Under discussion; the Chair recognized Representative Donald M. Manglona.

<u>Representative Donald M. Manglona:</u> Thank you, Mr. Speaker. Good afternoon, colleagues. This is in regards to Governor's Communication 22-146. As you may know that the initial budget submission in April of this year addressed personal funding for fiscal year 2023 and had failed to allocate funds for the operations of the government. Upon meeting with the Secretary of Finance, he did mention that the operations will be addressed in the revised budget submission. If you look at the revised budget submission that was submitted on the fifth of this month, no operational budget was proposed for any of these agencies. However, the administration took the time to allocate funding for salary increases of cabinet members, which we all know is not allowed. Nor in the budget submission, did the Administration consider the 25% to the settlement fund for the retirees nor the \$7 Million needed for Medicaid match since ARPA can't be used. Even NMTI was unfunded in the initial submission, as well as the revised submission. My dear colleagues, it is a position of the committee to ensure that we allocate funding for these activities. Not too long ago, the Governor promised the retirees bonuses in which he did not

identify the funding source for, but where is his promise now to protect the 25% for next fiscal year? Additionally, if we don't find the Medicaid match, the funds for the Medicaid match, hundreds of people will be affected and coverage may end earlier, despite getting an extension. The committee will be meeting next week on Tuesday to address these issues and I invite you all to participate. Non-members are also invited in order to address these issues as we make the tough decisions to cut from areas in order to address these activities. Thank you, Ms. Speaker.

The Chair recognized Representative Leila Haveia F.C. Staffler.

Representative Leila Haveia F.C. Staffler: Thank you, Speaker. And thank you colleagues for allowing me to share my thoughts on Governor's Communication 22-132, where he vetoed the House Local Bill 22-31 to appropriate unobligated funds under the Saipan local law in particular of interest to myself was the part where he vetoed the \$80,000 for the ongoing Kagman Watershed Project. The reasoning he gave was, "Correlating departments and agencies in this project will be prioritized to provide adequate federal funding assistance within the coming months." basically saying that there hasn't been a following assurances from the federal partners in completing this project, which I know are not true because we met with the funding and the federal partners who have been part of this very long project since 2001 or 2003. The money that this would've been appropriated to assist would be used to help maintain the project site because since pandemic, it has been overgrown and the many beautiful birds and animals that we love are also taking over in the spaces, which will make it harder to complete the project in the future. So, this \$80,000 is very critical to maintaining the site so that it can be finally finished. This watershed project, although is named Kagman Watershed is actually a project that will help many people in the entire Saipan community, fishermen and farmers alike. This project is something that was created as a pilot that would be the model for the Pacific in managing watersheds and collaborating with farming resources as well. And so, I really disagree with this veto and hope that we, as a body can do something about it. Thank you.

The Chair recognized Representative Christina Marie E. Sablan.

Representative Christina Marie E. Sablan: Thank you, Mr. Speaker and colleagues. Briefly, I wanted to comment on the same items that Representative Manglona and Representative Staffler mentioned in their comments. I would absolutely support and another override of the Governor's now second veto of appropriations that we've approved twice now in the Saipan and Northern Islands Delegation for the Kagman Watershed Project and also for the Mayor's Office for the operations of that office and again, I support overriding that veto and giving it another shot. I also share Chairman Manglona's disappointment in the reckless and completely irresponsible budget that the Governor has submitted for this upcoming fiscal year. We should all be troubled by that colleagues that there is money for increases for certain members of the cabinet. Certain selected employees and you know, just for personnel, but really nothing for operations that is just no way to run a government. No money for the retirees, 25% pension, no money for the Medicaid match, I mean, the list really goes on and on all the problems, all the things that are wrong and unacceptable about this budget and I stand with the Chairman and with the other members of the committee in making sure that we do everything that we can within our power to pass a budget that is responsible and that reflects the priorities of this body. Next, I wanted to comment on the Governor's Communications 22-136 to 139 and 141 to 143. Colleagues, these are no less than seven executive orders purporting to renew the state of significant emergency and public health emergency and to authorize the Secretary of Finance to reprogram or transfer

funds from the accounts of any department, agency office, board, commission, corporation, instrumentality, or other entity of all branches of the government to meet the threat of COVID-19. These executive orders are dated January 10, January 18, February 10, March 13, April 8th, May 8th and June 7th, 2022. They're stamped received by the Office of the Speaker on June 28th, 2022 and it's worth noting Mr. Speaker and colleagues that as far as we can tell, none of these executive orders was published in the Commonwealth Register and the last publication of such an order related to COVID-19 appears in October, 2021.

I find it interesting and highly suspect that we are just now receiving this flurry of executive orders after this body, primarily through the Ways and Means Committee has been making inquiries with the Governor's Office and with Finance on contracts and procurement practices related to the Commonwealth's COVID-19 response. At our most recent meeting just last week with the Governor's authorized representative to FEMA, I specifically asked whether the CNMI was still in a state of emergency because we haven't received any notices of declarations and even the GAR didn't know and said that he had also just inquired himself. So, here are my questions, colleagues. Starting with what happened? Did the Governor just forget to notify the legislature that he was continuing the state of emergency? Did he just decide it wasn't that important? Did he backdate these emergency declarations? And if he did, are these executive orders even legally valid? And moreover, how significant can these emergency declarations be? How significant can the emergency be if he's forgetting or otherwise failing to let the people know about it or hiding it? What funds, colleagues, have been reprogrammed without any real oversight or accountability during this period of purported emergency and what contracts have been awarded and paid under fast tracked emergency protocols? Are these executive orders really meant to provide cover for that? It may well be that the state of emergency is necessary. The GAR kind of suggested as much to ensure that the Commonwealth remains eligible for federal reimbursements and that I can appreciate, but what worries me and what should be worrisome to all of us is that we have been operating under state of emergency procurement status for more than two straight years now. That's two straight years of emergency and soul source contracts with very little oversight. Two straight years of practically unchecked reprogramming power. Colleagues, the rest of the Commonwealth is moving towards normalcy, but the government is lagging far behind and there is really nothing normal about how we're spending public money and who's really benefiting from it. Thank you. I yield Mr. Speaker.

The Chair recognized Vice Speaker Blas Jonathan "BJ" T. Attao.

<u>Vice Speaker Blas Jonathan "BJ" T. Attao:</u> Thank you, Mr. Speaker. Just in line with the Rep. Staffler's concerns with the line-item veto under Governor's Communication 22-132. The exact same language was utilized in the previous veto message from the Administration. The money that are supposed to go to the Mayor's Office was vetoed because of the language that, or the notion that the money should be going to the SHEFA Program – the Administration are very much aware that these monies that were collected back in 2020 were monies that were already taken out for SHEFA. Matter of fact, the Administration was the entity that removed the \$1.5 million dollars that went directly to SHEFA before the delegation ever appropriate those monies back in the 21st Legislature. I think it's important that we notify that these monies have already been given to SHEFA and we're just addressing some of the needs that the Mayor's Office had requested through the delegation chairman. Furthermore, we've continuously appropriated funds to SHEFA with other monies, other flexible monies that we received in the delegation level. So, that message to me is obsolete already because those monies that are being appropriated in these,

in these specific local bill had already addressed the SHEFA monies of \$1.5 Million. Furthermore, with the Kagman Watershed Program those monies were appropriated by the delegation level, because it's a responsibility of the local level to pay that matching. We cannot use other federal grants to pay for the percentage of the local level matching. Therefore, that \$80,000 that was appropriated to the watershed program was the guaranteed percentage that we were obligated at this period of time. As a matter of fact, the delegation needs to find additional funding sources, because we need to pay that to the tune of almost \$17 Million, I think we've paid off already about \$4 Million Dollars. So, that leaves us with approximately \$13 Million Dollars left to pay for that watershed project that the feds are actually taking the lead on. So, I support another override on the Governor's Communication, 22-132 for the same amount that should be going to the Mayor's Office for its operations and the watershed program. Thank you. Mr. Speaker.

The Chair recognized Representative Celina R. Babauta.

<u>Representative Celina R. Babauta:</u> Thank you, Mr. Speaker. Echoing the sentiments of those who have spoken today with respect to Governor's Communication 22-132 and the executive orders. As far as we can tell the executive, these dubious executive orders backdated and essentially executive orders are law, but certainly the constitution did not authorize the Governor to apply these laws or executive orders retroactively and that is very concerning to the legislature. I do, if there are no objections, Mr. Speaker, I would like to offer a motion to override at this time, Governor's Communication 22-132 in line with the sentiments expressed this afternoon. Thank you.

The Chair recognized the Floor Leader.

The Floor Leader made a motion to override Governor's Communication 22-132 pertaining to House Local Bill 22-31.

There was no further discussion; the Chair recognized the Clerk for a roll call vote.
