## A LOCAL APPROPRIATION BILL FOR AN ACT FOR THE FIRST SENATORIAL DISTRICT

To appropriate sixty thousand dollars (\$60,000) from the Poker Licensing Fee Account (specifically under BU 3302); and for other purposes.

## BE IT ENACTED BY THE FIRST SENATORIAL DISTRICT DELEGATION PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:

#### SECTION 1. SHORT TITLE.

The purpose of this Act is to appropriate sixty thousand dollars (\$60,000) from the Poker Licensing Fee Account (specifically under BU 3302) and for other purposes.

#### SECTION 2. APPROPRIATIONS.

Notwithstanding 10 CMC §1901, the Rota Legislative Delegation hereby appropriates sixty thousand dollars (\$60,000) from the Poker Licensing Fee Account (specifically under Business Unit 3302) as follows:

(a) Forty Thousand Dollars (\$40,000) for Medical Subsistence Allowance for the Rota hemodialysis and terminally-ill patients under the expenditure authority of the Secretary of Finance- and

(b) Twenty Thousand Dollars (\$20,000) strictly for the Rota inter-island medical referral patients and escorts from Rota, not for hemodialysis or terminally ill patients who receive the Medical Subsistence Allowance. The expenditure authority of the funds under this subsection shall be the CHCC Chief Executive Director or designee.

#### SECTION 3. FISCAL YEAR.

The funds allocated under this Act shall be without fiscal year limitation(s).

#### SECTION 4. SEVERABILITY.

If any provision of this Act or the application of any such provision to any person or circumstance should be held invalid by a court of competent jurisdiction, the remainder of this Act or the application of its provisions to persons or circumstances other than those to which it is held invalid shall not be affected thereby.

#### SECTION 5. SAVINGS CLAUSE.

This Act and any repealer contained herein shall not be construed as affecting any existing right acquired under contract or acquired under statutes repealed or under any rule, regulation or order adopted under the statutes. Repealers contained in this Act shall not affect any proceeding instituted under or pursuant to prior law. The enactment of the Act shall not have the effect of terminating, or in any way modifying, any liability, civil or criminal, which shall already be in existence on the date this Act becomes effective.

#### SECTION 6. EFFECTIVE DATE.

This Act shall take effect upon its approval by the Governor or its becoming law without such approval.
