

HOUSE LOCAL BILL NO. 22-10

**A LOCAL APPROPRIATION BILL FOR AN ACT
FOR THE THIRD SENATORIAL DISTRICT**

To re-appropriate lapse funds under Section 2(B)(5) of Saipan Local Law 21-5;
and for other purposes.

**BE IT ENACTED BY THE THIRD SENATORIAL DISTRICT DELEGATION PURSUANT
TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:**

1 **SECTION 1. PURPOSE.**

2 The purpose of this Act is to re-appropriate lapse funds under Section 2(B)(5) of Saipan
3 Local Law 21-5 for the Saipan and Northern Islands Municipal Council.

4 **SECTION 2. APPROPRIATION.**

5 Notwithstanding any provision(s) of law, statutes, rules or regulations to the contrary
6 and pursuant to funds allocated to the Third Senatorial District the Saipan and Northern Islands
7 Legislative Delegation (SNILD) hereby re-appropriates lapse funds under Section 2(B)(5) of
8 Saipan Local Law 21-5 in the amount of \$9,452.00 for the operations/personnel of the Saipan
9 and Northern Islands Municipal Council; expenditure authority of the funds shall be the
10 Chairperson of the Saipan and Northern Islands Municipal Council or his/her designee.

11 **SECTION 3. EXPENDITURE AUTHORITY.**

1 The expenditure authority for the funds under Section 2 unless specified in this Act shall
2 be the Secretary of Finance.

3 **SECTION 4. REPROGRAMMING.**

4 Funds appropriated under this act shall not be reprogrammed for any other purpose and
5 notwithstanding any provision of law, all funds appropriated under this Act shall be without
6 fiscal year limitation.

7 **SECTION 5. MANAGEMENT OF FUNDS.**

8 (A) The Secretary of Finance shall regulate and control the expenditure of the funds
9 appropriated by this Act to ensure that appropriated funds are not expended contrary to the law,
10 fiscal management policies, and practices of the Commonwealth.

11 **SECTION 6. REPORTING OF EXPENDITURES.**

12 Expenditures of the funds allocated under Section 2 of this Act shall be responsible to
13 report all expenses to the Secretary of the Department of Finance by the end of the 2021
14 calendar year. Provided further that failure to provide all expenses entities that were afforded
15 funds under this Act shall not be able to avail to any future funds appropriated by the Saipan
16 and Northern Islands Legislative Delegation.

17 **SECTION 7. SEVERABILITY.**

18 If any provision of this Act or the application of any such provision to any person or
19 circumstance should be held invalid by a court of competent jurisdiction, the remainder of this
20 Act or the application of its provisions to persons or circumstances other than those to which it
21 is held invalid shall not be affected thereby.

HOUSE LOCAL BILL NO. 22-10

1 SECTION 8. SAVINGS CLAUSE.

2 This Act and any repealer contained herein shall not be construed as affecting any
3 existing right acquired under contract or acquired under statutes repealed or under any rule,
4 regulation or order adopted under the statutes. Repealers contained in this Act shall not affect
5 any proceeding instituted under or pursuant to prior law. The enactment of the Act shall not
6 have the effect of terminating, or in any way modifying, any liability, civil or criminal, which
7 shall already be in existence on the date this Act becomes effective.

8 SECTION 9. EFFECTIVE DATE.


9 This Act shall take effect upon its approval by the Governor or its becoming law without


