Dear Mr. Chairman and Mr. Speaker:

This is to inform you that I have signed into law with disapproved items, House Local Bill 22-4, D1 entitled, "To appropriate Two Hundred Two Thousand Nine Hundred Ninety-Six US Dollars (\$202,996.00) of the Earned Bond Interest Income collected for the Second Senatorial District that has been identified by the Commonwealth Development Authority as available for appropriations; and for other purposes." The bill was passed by the Tinian and Aguiguan Legislative Delegation of the Twenty-Second Northern Marianas Commonwealth Legislature.

Regrettably, I have disapproved the following part of the enactment for the foregoing reasons:

# VETOED PART OF THE ENACTMENT

## SECTION 2 (b)

This provision sought to appropriate \$62,996.00 for various municipal capital improvement projects.

Citing the Attorney General's comments on H.L.B. 22-4, D1, a more detailed listing of what capital improvement projects are to be funded with the \$62,996.00 should be provided in order to ensure that the funding is properly accounted for in a transparent manner. Because there is no indication of what specific CIPs are to be funded by this appropriation, I respectfully request that the Tinian and Aguiguan Legislative Delegation appropriate these funds in a future legislation with the inclusion of a detailed project list.

# BE IT ENACTED BY THE SECOND SENATORIAL DISTRICT DELEGATION PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:

### SECTION 1. PURPOSE.

The purpose of this Act is to appropriate Two Hundred Two Thousand Nine Hundred Ninety-Six US Dollars (\$202,996.00) of the Earned Bond Interest Income collected for the Second Senatorial District that has been identified by the Commonwealth Development Authority as available for appropriation.

### SECTION 2. APPROPRIATION.

Notwithstanding any provisions, law, statutes, rules or regulations to the contrary, the Tinian and Aguiguan Legislative Delegation hereby appropriates Two Hundred Two Thousand Nine Hundred Ninety-Six US Dollars (\$202,996.00) of the Earned Bond Interest Income

collected for the Second Senatorial District, that has been identified by the Commonwealth Development Authority available for appropriation as follows:

 (a) \$140,000 for the Tinian Marpo Heights and Carolinas Heights village homestead expansion; and

(b) \$62,996.00 for various municipal capital improvement projects.

### SECTION 3. EXPENDITURE AUTHORITY.

The expenditure authority of the funds appropriated in Section 2 shall be the Mayor of Tinian and Aguiguan or his/her designee.

### SECTION 4. REPROGRAMMING.

Funds appropriated under this act shall not be reprogrammed for any other purpose.

Notwithstanding any provision of law, the project funded under this Act shall be without fiscal year limitation.

### SECTION 5. SEVERABILITY.

If any provision of this Act or the application of any such provision to any person or circumstance should be held invalid by a court of competent jurisdiction, the remainder of this Act or the application of its provisions to persons or circumstances other than those to which it is held invalid shall not be affected thereby.

### SECTION 6. SAVINGS CLAUSE.

This Act and any repealer contained herein shall not be construed as affecting any existing right acquired under contract or acquired under statutes repealed or under any rule, regulation or order adopted under the statutes. Repealers contained in this Act shall not affect any proceeding instituted under or pursuant to prior law. The enactment of the Act shall not have the effect of terminating, or in any way modifying, any liability, civil or criminal, which
