

AN ACT

To authorize government agencies, boards, and commissions to promulgate regulations to utilize electronic means to participate in official meetings.

BE IT ENACTED BY THE TWENTY-SECOND NORTHERN MARIANAS COMMONWEALTH LEGISLATURE:

Section 1. Findings and Purpose. The Legislature finds that the complications brought by the effects of the coronavirus pandemic have made business as usual pertaining to meeting quorum a struggle for government agencies, boards, and commissions. The Legislature further finds that due to the directives regarding social distancing and the limited availability of inter-island flights, government entities need to allow meeting appearances by electronic means, such as online videoconferencing or teleconferencing. Through this Act, the Legislature intends that electronic appearances in government meetings shall be allowed only when a member or members of a board, agency, or commission are physically present in the Commonwealth of the Northern Mariana Islands (CNMI), but are unable to attend a meeting in person at the meeting place.

Therefore, the purpose of this Act is to authorize government agencies, boards, and commissions to promulgate regulations to allow members to participate in meetings by electronic means when said members are present in the CNMI.

Section 2. <u>Amendment</u>. Title 1, Division 2, Part 2, Chapter 1, Section 2901, of the Commonwealth Code is amended by adding a new subsection (i) to read:

"(i) Boards, agencies, and commissions shall adopt regulations to provide for meeting appearances via internet or online video conferencing, teleconferencing, or other electronic means of communication, in the event that a

member is in the Commonwealth of the Northern Mariana Islands but unable to attend a meeting in person at the meeting place."

Section 3. Severability. If any provisions of this Act or the application of any such provision to any person or circumstance should be held invalid by a court of competent jurisdiction, the remainder of this Act or the application of its provisions to persons or circumstances other than those to which it is held invalid shall not be affected thereby.

Section 4. Savings Clause. This Act and any repealer contained herein shall not be construed as affecting any existing right acquired under contract or acquired under statutes repealed or under any rule, regulation, or order adopted under the statutes. Repealers contained in this Act shall not affect any proceeding instituted under or pursuant to prior law. The enactment of the Act shall not have the effect of terminating, or in any way modifying, any liability, civil or criminal, which shall already be in existence on the date this Act becomes effective.

Section 5. <u>Effective Date</u>. This Act shall take effect upon its approval by the Governor, or its becoming law without such approval.
