established the Resident Executive and is mandated with the following duties and responsibilities.

- Coordinate the development, distribution, adoption and translation of a comprehensive history of the Marianas.
- Ensures local participation in executive managerial decision-making in the government and private sector.
- Assist and promote local entrepreneurial development.
- Establish a community foundation for the advancement of the indigenous people.
- Coordinate the translation and distribution of such official documents as the Constitution of the Commonwealth of the Northern Mariana Islands and the Covenant and the analyses thereof.
- Plan for the establishment of the Indigenous Cultural Center and the Indigenous Hall of Fame.
- 7. Coordinate an annual cultural festival.
- Develop and implement a long-range plan to assist and promote the entry of the indigenous people into professional and technical institutions

of higher education.

9. Serve as an advocate of positions taken by indigenous people on issues brought before them.

The office of resident executive for indigenous affairs shall commence immediately upon ratification of this section.

The resident executive is authorized to hire staff and promulgate rules and regulations in carrying out the duties and responsibilities of the office.

The governor shall include in the budget of the executive branch the funding necessary to fully implement the provisions of this section.



















A second Chamorro thatch house was constructed in Susupe shaping the future "Sengsung Chamorro".









A traditional kitchen for the demonstration of Chamorro traditional medicines and local food including a garden





FISCAL YEAR 2020 BUDGET EXPENDITURES



Fiscal year 2020 expenditures reflects personnel, utility, all others, and budget cuts/unspent.

Personnel expenditure was less than appropriated due to reduction of employment and non-hiring of personnel. Furthermore, due to cost-cutting measures and budget cuts, a portion of the utility, was included in the 39% of the pie.

For all others, portion of the funds was affected by the budget reduction.
