MISSION

To improve communication, coordination and response of the CNMI government to the United States military, facilitate the military's integration into the community, and to ensure the relationship between the military and the CNMI is one based on mutual respect and benefit

VISION

Enhance partnership for mutually beneficial collaboration while preserving the cultural values of the people of the Commonwealth of the Northern Mariana Islands

ORGANIZATION

Headed by a Special Assistant to the Governor for Military Affairs, appointed by and serving at the pleasure of the Governor. Its staff make-up comprises of a dynamic team of educated and experienced professionals ranging from veteran, civilian, and family members of service members / veterans. The workforce was absorbed from the former Civil Military Liaison Office and with new recruits.

AUTHORITY AND MANDATE

Authority: Executive Order 2019-09

Mandate: Serves as a Single point of contact and Central Clearinghouse between the United States Department of Defense (DoD) and the Commonwealth Government to ensure a mutually beneficial relationship, through various levels of engagement: (1) Coordinates and facilitates communications and engagements between both parties on all military and military-related activities in the Commonwealth; (2) Facilitates military integration into the community, (3) Integrates Department of Defense-related economic activities for residents and the Commonwealth; and (4) Functions as the custodian of all military and military-related records, among other mandates

Department of Defense

The Department of Defense Office of Economic Adjustment serves as one of our most valuable support partners.




Commonwealth Government


FEDERAL RESOURCES



\$9.037 MILLION
