

#### THE LEGISLATIVE BUREAU

The Legislative Bureau was established by the ratification of the 1985 Constitutional Amendment 10. This amendment is incorporated into the Commonwealth Constitution as Article 2 Section 17.

The Bureau was created, as a non-partisan entity to provide required services to the members of both House of the Legislature in connection with their duties and responsibilities during sessions and committee meetings. These services include providing professional staff to draft bills, prepare committee reports, provide legal assistance, and main the records, files, library, and other documents of the Legislature.

The Bureau was designed to be independent and free from any political, harassment or pressure, so it was given its own operational budget by the ratification of House Legislative Initiative 6-2. The Legislative Bureau continues to develop into the independent supporting agency it was created to be, providing efficient and stable operational continuity during and between changing composition of the Legislature.
