Dear Mr. President:

Your Committee on Fiscal Affairs, to which was referred House Joint Resolution, entitled:

"To authorize the establishment of an additional sixteen (16) positions as needed by the CMA and partially funded by the CMS program for Compliance and Medicaid Enterprise Systems (MES); and for other purposes."

begs leave to report as follows:

I. RECOMMENDATION:

After considerable discussion and deliberation, your Committee recommends passing House Joint Resolution 22-4 in the form of Senate Draft 1.

II. ANALYSIS:

A) Purpose:

The purpose of House Joint Resolution 22-4 is to establish sixteen (16) additional positions as needed by the Commonwealth Medicaid Agency (CMA) and partially funded by the Centers for Medicare and Medicaid Services (CMS) program for Compliance and Medicaid Enterprise Systems (MES).

B) Committee Findings:

Your Committee finds that, pursuant to the Further Consolidated Appropriations Act (PL 116-94), the U.S. Congress increased the caps in Section 1108 and the Federal Medical Assistance Percentage (FMAP) for the Medicaid program of the Commonwealth of the Northern Mariana Islands (CNMI). Additionally, the U.S. Congress included provisions that require the Commonwealth Medicaid Agency to submit data to the Transformed Medicaid Statistical Information System (T-MSIS), appoint a Program Integrity (PI) Lead for the Office, establish a Medicaid Fraud Control Unit (MFCU), submit data to the Centers for Medicare and Medicaid Services (CMS) Unified Program Integrity Contractor (UPIC) West, report any instances of suspected fraud, waste, and abuse, and to further administer and comply with the Medicaid Program as provided for in Title XIX of the Social Security Act and the regulations of the CMS.

On March 17, 2021, the U.S. Congress held a hearing on "Averting a Crisis: Protecting Access to Health Care in the U.S. Territories" where the members stated their support for the Territories to receive the same funding as the states in regards to healthcare, but also stated their concerns about program administration, integrity, and compliance within the Territories. Your Committee further finds that submitters from the CNMI have proclaimed that the Medicaid Enterprise System (MES) has been making "reasonable and appropriate progress" to resolve the concerns of the U.S. Congress members by establishing the following: a Medicaid Management Information System (MMIS) that is designed to submit data collected to the Transformed Medicaid Statistical Information System (T-MSIS) system; the designation of a Program Integrity Lead, and establishing a Joint Operating Agreement (JOA) with the CMS Unified Program Integrity Contractor (UPIC) West which reports to the CMS for fraud, waste, abuse and other related compliance; the establishment of a new Medicaid budget category for "MES and Compliance" and provides the authority of the Medicaid Director to prioritize MES to ensure progress is continually being made.

Your Committee finds that the CMS approved of the plans submitted by CMA that was created to implement an Eligibility and Enrollment (E&E) and Medicaid Management Information System (MMIS), a Decision Support System/ Data Warehouse (DSS/DW), and a Health Information Technology (HIT) program grant that reflects the progress made.

Your Committee convened on May 13, 2021 to discuss the provisions of House Joint Resolution No. 22-4. Senator Justo S. Quitugua stated he received a letter from the Director of the Medicaid Office which recommended that the House must initiate a resolution that requires to establish a computerized management system. In addition, the Medicaid Office notably requested for more FTEs in the 2021 budget, but the Legislature did not allocate funds due to a limited budget. In response to this, the Medicaid Office is requesting for more FTEs again. It is for this reason that your Committee recommends passage of the proposed provisions in the form of House Joint Resolution No. 22-4, Senate Draft 1.

C) Legislative History:

Representative Leila H.F.C. Staffler formally introduced House Joint Resolution No. 22-4 on April 23, 2021, and was passed by the House of Representatives on April 23, 2021 during its First Day, First Special Session in its current form.

House Joint Resolution No. 22-4 was transmitted to the Senate on April 26, 2021 and subsequently referred to the Senate Standing Committee on Fiscal Affairs for disposition.

D) Public Hearing and Comment:

Although a public hearing was not scheduled for House Joint Resolution 22-4, a Committee Meeting which is open to the public, was held on May 13, 2021 to deliberate on the provisions stated in the proposed legislation. The meeting notices and agenda were officially posted on various legislative forums and social media to invite members of the general public to provide comments as indicated under *Item IV. Comments* of the agenda; however, no written comments were received by your Committee.

E) Estimated Fiscal Cost:

The passage of House Joint Resolution No. 22-4, Senate Draft 1 may result in additional costs to the CNMI government for the purpose of fulfilling the intent of funding the additional sixteen positions as needed by the CMA as needed by the CMS program for Compliance and Medicaid Enterprise Systems (MES).

authorized by a legislative joint resolution in accordance with Section 7, Article X
of the N.M.I. Constitution";

NOW, THEREFORE, BE IT RESOLVED, by the House of

- Representatives of the Twenty-Second Northern Marianas Commonwealth
 Legislature, the Senate concurring, that the Legislature in accordance with Section
 7, Article X of the N.M.I. Constitution authorizes:
- 1. In addition to those NOPs authorized by P.L. 21-35, the establishment of an additional sixteen (16) positions as needed by the CMA and partially funded by the CMS program for Compliance and Medicaid Enterprise Systems (MES). The authorized positions will include a Medicaid Enterprise Systems Program Manager, five (5) health information systems and technology personnel, two (2) MES program administrative assistants, and eight (8) additional Medicaid eligibility, enrollment, claims examiners, program integrity, and data specialists; and
 - 2. The Medicaid program and Office of Personnel Management is further authorized to establish additional NOPs and such full-time equivalent positions and specialized classifications and compensation for specialized health information systems professionals within the Civil Services system and to temporarily hire, as exempt positions, personnel required to successfully plan, design, develop, implement and operate a Compliance and MES Systems. All

positions must be funded at least on a 50-50% basis by the Federal and 1 2 Commonwealth governments; and 3 BE IT FURTHER RESOLVED, that the Speaker of the House of 4 Representatives and the President of the Senate shall certify and the House Clerk 5 and the Senate Legislative Secretary shall attest to the adoption of this joint 6 resolution and thereafter the House Clerk shall transmit a copy to Helen C. Sablan, 7 Director, CNMI State Medicaid Agency, Director of the Office of Personnel 8 Management, David DLG Atalig, Secretary of Finance, Virginia C. Villagomez,

Special Assistant, Office of Management and Budget, and the Honorable Ralph
