# I. <u>RECOMMENDATION</u>:

After considerable discussion, your Committee recommends that H. B. No. 22-05 be passed by the House in the form of House Draft 1.

# II. ANALYSIS:

# A. Purpose:

The purpose of House Bill No. 22-05 is to amend 1 CMC §20175 to include additional members to serve on the Advisory Council for Planning and Development.

In addition to non-substantive technical amendments, the Committee made the following amendments to strengthen the intent of House Bill No. 22-05.

#### C. Committee Findings:

Your Committee finds that the Office of Planning and Development (OPD), an office established pursuant to Public Law 20-20, was created to improve the planning process, increase effectiveness of government and private actions, improve coordination among agencies and other levels of government, to provide wiser use of our resources, and to guide future development of the CNMI. Such developments include economic, infrastructure, and physical development of the CNMI. Furthermore, OPD is mandated to develop the CNMI Sustainable Development Plan which shall contain objectives, standards, and principles with respect to the most desirable use of land with the CNMI for residential, recreational, agriculture, commercial, and other purposes. The future development of our Commonwealth, cognizant of the limited resources we possess, is critical for future generations to come.

Your Committee further finds that pursuant to 1 CMC §20175, the Planning and Development Advisory Council was established within the Office of Planning and Development to prepare the previously mentioned CNMI Sustainable Development Plan. This advisory council consists of secretaries, directors, and other various representatives from different government agencies/entities, autonomous and non-autonomous. Furthermore, the advisory council currently consists of fifteen members. Your Committee finds that it would be appropriate to include additional members to the Planning and Development Advisory Council to provide additional members, the advisory council will be able to come up with a more effective and efficient development plan for future developments to come for the CNMI.

It is the intent of your Committee to amend the proposed legislation to allow for respective members of the council to appoint a designee in the event that such member is unable to participate on the activities of the advisory council. Providing such flexibility will still allow for each entity's perspective to be equally represented during deliberations. Therefore, your Committee agrees with the intent and purpose of House Bill No. 22-05 and recommends its passage in the form of House Draft 1.

### D. Legislative History:

House Bill No. 22-05 was introduced by Representative Joseph Lee Pan T. Guerrero on Februrary 19, 2021 to the full body of the House and was referred to the House Standing Committee on Judiciary and Governmental Operations for disposition.

A similar legislation, namely House Bill 21-106, was introduced on March 13, 2020 to the full body of the House and was referred to the House Standing Committee on Judiciary and Governmental Operations for disposition. In a session held on August 26, 2020, the House passed the proposed legislation legislation in the form of House Bill 21-106, House Substitute 1. Upon passage, the proposed legislation was transmitted to the Senate and referred to the Senate Standing Committee on Judiciary, Government, Law & Federal Relations. In a session held on December 1, 2020, the Senate passed House Bill 21-106, HS1 without amendments. Soon after, the legislation was transmitted to the Governor and was vetoed on January 19, 2021. No further action was taken.

E. Cost Benefit:

The enactment of House Bill No. 22-05, HD1 will result in additional cost to the CNMI government due to the need for additional resources (staff, equipment, etc.) that are necessary to effectuate the provisions of this Act. However, the benefits of adding additional members to the Planning and Development Advisory Council heavily outweigh the costs.

#### **III.** CONCLUSION:

The Committee is in accord with the intent and purpose of H. B. No. 22-05, and recommends its passage in the form of House Draft 1.

#### A BILL FOR AN ACT

To amend 1 CMC §20175 to include additional members to serve on the Planning and Development Advisory Council (PDAC); and for other purposes.

## BE IT ENACTED BY THE 22<sup>ND</sup> NORTHERN MARIANAS COMMONWEALTH LEGISLATURE:

1 Section 1. Findings and Purpose. The Legislature finds that pursuant to 2 Public Law 20-20, the Office of Planning and Development (OPD) was established 3 to improve the planning process in the CNMI, to increase the effectiveness of government and private actions, to improve coordination among different 4 5 agencies and levels of government, to provide for wise use of the CNMI's resources, and to guide the future development of the CNMI. Public Law 20-20 6 also mandates that OPD create the CNMI Comprehensive Sustainable 7 8 Development Plan, which shall provide short and long-range guidance for 9 the economic, infrastructure, and physical development of the CNMI, and 10 which shall contain a statement of development objectives, standards, and 11 principles with respect to the most desirable use of land within the CNMI

1 for residential, recreational, agricultural, commercial, industrial, and other uses completely serviced by an access and circulation network and 2 infrastructure consistent with proper protection to enhance the quality of 3 4 the environment and preserve the CNMI's natural beauty and historical 5 heritage; and that ensures that such new developments can be accommodated 6 by the current infrastructure of the islands and will not unduly burden such 7 infrastructure in the years come. Additionally, OPD is responsible for working with 8 identified planning partners to create a Comprehensive Sustainable Development 9 Plan and implementation procedures that ensure the protection of the scarce resources 10 including land, natural resources, and human resources.

11 Furthermore, the specified Public Law established the Commonwealth 12 Planning and Development Advisory Council (PDAC) within the Office of 13 Planning and Development (OPD) which consists of department secretaries, agency 14 directors, administrators, and representatives from various government agencies 15 and organizations to assist in the preparation of the Comprehensive Sustainable Development Plan. The plans formulated by the Office of Planning and 16 17 Development are intended to help stimulate the CNMI's economy as well as ensure 18 effective and coordinated implementation of planning elements. Since OPD's 19 inception, and following numerous planning meetings with the PDAC and the 20 community, there was a recognition of the need to include additional stakeholders to take part in the planning discussions necessary for the creation of the 21

1	Comprehensive Sustainable Development Plan to ensure the coordination and
2	efficacy objectives outlined in Public Law 20-20.
3	Therefore, the purpose of this Act is to amend 1 CMC §20175 to include
4	additional members to serve on the Advisory Council for Planning and
5	Development.
6	Section 2. Amendment. 1 CMC §20175 is hereby amended to read as
7	follows:
8	"§ 20175. Advisory Council for Planning and Development.
9	(a) In the Commonwealth Office of Planning and Development,
0	there shall be a Commonwealth Planning and Development Advisory
1	Council to be chaired by the Council member voted on by a majority vote
2	of the members of the Council and shall be comprised of the following
3	members, or their respective designee:
4	(1) Director of the Office of Planning and Development;
5	(2) Administrator of the Office Bureau of Environmental and

7	(3) Secretary of the Department of Public Works;
8	(4) Secretary of the Department of Public Lands;

9	Section 3. <u>Severability</u> . If any provision of this Act or the application of
10	any such provision to any person or circumstance should be held invalid by a court
11	of competent jurisdiction, the remainder of this Act or the application of its
12	provisions to persons or circumstances other than those to which it is held invalid
13	shall not be affected thereby.
14	Section 4. Savings Clause. This Act and any repealer contained herein
15	shall not be construed as affecting any existing right acquired under contract or
16	acquired under statutes repealed or under any rule, regulation or order adopted
17	under the statutes. Repealers contained in this Act shall not affect any proceeding
18	instituted under or pursuant to prior law. The enactment of this Act shall not have
19	the effect of terminating, or in any way modifying, any liability civil or criminal,
20	which shall already be in existence at the date this Act becomes effective.

Section 5. Effective Date. This Act shall take effect upon its approval by

2 the Governor or upon its becoming law without such approval.
