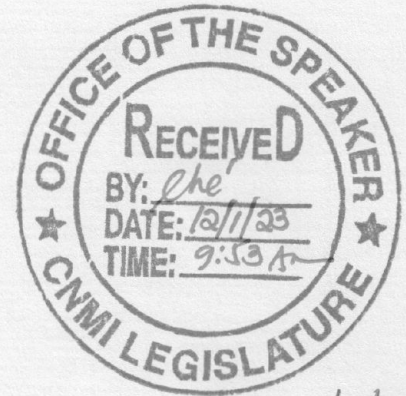



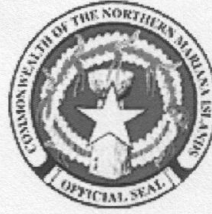

**A LOCAL APPROPRIATION BILL FOR AN ACT
FOR THE THIRD SENATORIAL DISTRICT**

To re-appropriate Ninety Thousand Dollars (\$90,000.00) allotted under Saipan Local Law 20-26, Section 2(r)(1), specifically under Business Unit 7190D; and for other purposes.

**BE IT ENACTED BY THE THIRD SENATORIAL DISTRICT DELEGATION PURSUANT TO
CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:**

1 **SECTION 1. PURPOSE.**

2 The purpose of this Act is to re-appropriate Ninety Thousand Dollars (\$90,000.00) allotted
3 under Saipan Local Law 20-26, Section 2(r)(1), specifically under Business Unit 7190D.

4 **SECTION 2. RE-APPROPRIATION.**

5 Notwithstanding any provisions, statutes, laws or regulations to the contrary, the Saipan
6 and Northern Islands Legislative Delegation hereby re-appropriates Ninety Thousand Dollars
7 (\$90,000.00) allotted under Saipan Local Law 20-26, Section 2(r)(1), specifically under Business
8 Unit 7190D, as follows:

- 9 (a) Fifty Thousand Dollars (\$50,000.00) for the proposed relocation, construction and maintenance of
10 two modular forty-foot container restrooms at Sugar Dock Beach in Chalan Kanoa; and

1 (b) Twenty-Five Thousand Dollars (\$25,000.00) for the installation of street lights and public address
2 systems in Precinct II recreational areas and roadways.

3 (c) Fifteen Thousand (\$15,000.00) for the Marianas Racing Association, expenditure authority shall
4 be the Secretary of the Department of Finance or his/her designee.

5 **SECTION 3. EXPENDITURE AUTHORITY.**

6 The expenditure authority for the funds under Section 2, unless specified otherwise, of this
7 Act shall be the Secretary of the Department of Lands and Natural Resources in consultation with
8 the Director of the Division of Parks and Recreation.

9 **SECTION 4. REPROGRAMMING.**

10 Notwithstanding any laws, provisions or regulations to the contrary, funds appropriated
11 under this Act shall not be reprogrammed for any other purpose.

12 **SECTION 5. REPORTING.**

13 The expenditure authority shall submit to the Chairperson of the Saipan and Northern
14 Islands Legislative Delegation a detail report showing the expenditure of the funds at the
15 completion of appropriations in Section 2 of this Act.

16 **SECTION 6. FUND DISTRIBUTION.**

17 Funds appropriated under Section 2 of this Act shall be distributed accordingly to the
18 intended purpose and or entity upon this Act becoming law.

19 **SECTION 7. FISCAL YEAR.**

20 The funds allocated under this Act shall be without fiscal year limitation(s).

21 **SECTION 8. SEVERABILITY.**

22 If any provision of this Act or the application of any such provision to any person or

1 circumstance should be held invalid by a court of competent jurisdiction, the remainder of this Act
2 or the application of its provisions to persons or circumstances other than those to which it is held
3 invalid shall not be affected thereby.


4 **SECTION 9. SAVINGS CLAUSE.**

5 This Act and any repealer contained herein shall not be construed as affecting any existing
6 right acquired under contract or acquired under statutes repealed or under any rule, regulation or
7 order adopted under the statutes. Repealers contained in this Act shall not affect any proceeding
8 instituted under or pursuant to prior law. The enactment of the Act shall not have the effect of
9 terminating, or in any way modifying, any liability, civil or criminal, which shall already be in
10 existence on the date this Act becomes effective.

11 **SECTION 10. EFFECTIVE DATE.**


12 This Act shall take effect upon its approval by the Governor or it becoming law without



II. ANALYSIS:

A. Purpose:

The purpose of this Act is to re-appropriate Fifty Thousand Dollars (\$50,000.00) allotted under Saipan Local Law 20-26, Section 2(r)(1), specifically under Business Unit 7190D for the proposed relocation, construction and maintenance of two modular forty-foot container restrooms at Sugar Dock Beach in Chalan Kanoa.

B. Committee Findings:

Your Committee on Ways and Means to which House Local Bill No. 23-27: "To re-appropriate Fifty Thousand Dollars (\$50,000.00) allotted under Saipan Local Law 20-26, Section 2(r)(1), specifically under Business Unit 7190D; and for other purposes." was referred to verify and confirm that the amount specified in the local appropriation Act is accurate and available for appropriation. The Committee received the Year to Date balance of \$1,014,102.35 as of August 11, 2023 under Saipan Local Law 20-26, Section (2)(r)(1), specifically under Business Unit 7190D, that is available for appropriation.

Therefore, the Committee recommends that House Local Bill No. 23-27 be transmitted to the Saipan and Northern Island Legislative Delegation for action. Year to Date Balance as of August 11, 2023 has been attached as part of this committee report.


C. Legislative History:

House Local Bill 23-27 was introduced by Representative Manny Gregory T. Castro and Representative John Paul P. Sablan on September 7, 2023 and was subsequently referred to the House Standing Committee on Ways and Means for disposition.
