**A LOCAL APPROPRIATION BILL FOR AN ACT
FOR THE THIRD SENATORIAL DISTRICT**

To amend Section 2(e) of Saipan Local Law 23-04 to ensure that the proper work order number is being funded.

**BE IT ENACTED BY THE THIRD SENATORIAL DISTRICT DELEGATION PURSUANT TO
CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:**

1 **SECTION 1. PURPOSE.**

2 The purpose of this Act is to amend Section 2(e) of Saipan Local Law 23-04 to ensure that
3 the proper work order number is being funded.

4 **SECTION 2. AMENDMENT.**

5 Section 2(e) of Saipan Local Law 23-04 is hereby amended to read as follows:

6 “(e) \$10,000.00 to complete the power pole distribution in Precinct 4, Capitol Hill area
7 under work order number 808634.”

8 **SECTION 3. SEVERABILITY.**

9 If any provision of this Act or the application of any such provision to any person or
10 circumstance should be held invalid by a court of competent jurisdiction, the remainder of this Act

1 or the application of its provisions to persons or circumstances other than those to which it is held
2 invalid shall not be affected thereby.


3 **SECTION 4. SAVINGS CLAUSE.**

4 This Act and any repealer contained herein shall not be construed as affecting any existing
5 right acquired under contract or acquired under statutes repealed or under any rule, regulation or
6 order adopted under the statutes. Repealers contained in this Act shall not affect any proceeding
7 instituted under or pursuant to prior law. The enactment of the Act shall not have the effect of
8 terminating, or in any way modifying, any liability, civil or criminal, which shall already be in
9 existence on the date this Act becomes effective.

10 **SECTION 5. EFFECTIVE DATE.**


11 This Act shall take effect upon its approval by the Governor or it becoming law without
12 such approval.
