A LOCAL APPROPRIATION BILL FOR AN ACT FOR THE SECOND SENATORIAL DISTRICT

To re-appropriate Eighty-Seven Thousand, Four Hundred Sixty-Five Dollars (\$87,465.00) allotted under Tinian Local Law 20-7, and Thirty Thousand Dollars (\$30,000.00) allotted under Tinian Local Law 22-04 § 2(a); and for other purposes.

BE IT ENACTED BY THE SECOND SENATORIAL DISTRICT DELEGATION PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:

1 SECTION 1. PURPOSE.

- 2 The purpose of this Act is to re-appropriate Eighty-Seven Thousand, Four Hundred Sixty-
- 3 Five Dollars (\$87,465.00) allotted under Tinian Local Law 20-07, and Thirty-Thousand Dollars
- 4 (\$30,000.00) allotted under Tinian Local Law 22-04 § 2(a) identified as the Earned Bond Interest
- 5 Income collected for the Second Senatorial District and certified by the Tinian Municipal
- 6 Treasurer on January 19, 2024.

7 SECTION 2. RE-APPROPRIATION.

- 8 Notwithstanding any provision(s) of law, statutes, rules or regulations to the contrary, the
- 9 Tinian and Aguiguan Legislative Delegation hereby re-appropriates funds identified as Earned

HOUSE LOCAL BILL 23-40, D1

- 1 Bond Interest Income collected for the Second Senatorial District in the combined total amount of
- 2 One-Hundred Seventeen Thousand, Four Hundred Sixty-Five Dollars (\$117,465.00). Of this total
- 3 amount, Eighty-Seven Thousand Four Hundred Sixty-Five Dollars (\$87,465.00) are unspent
- 4 amounts allotted under Tinian Local Law 20-7, and Thirty Thousand Dollars (\$30,000.00) are
- 5 unspent amounts allotted under Tinian Local Law 22-04 § 2(a). The funds (\$117,465.00) are
- 6 hereby re-appropriated to the Office of the Mayor of Tinian as follows:
- 7 (a) \$50,000.00 for the Tinian Veteran's Memorial Park;
- 8 (b) \$37,465.00 for the Youth Center Tennis Court resurfacing;
- 9 (c) \$15,000.00 for the slaughterhouse generator, slab & installation; and
- 10 (d) \$15,000.00 for the San Jose Village Cemetery storage.

11 SECTION 3. EXPENDITURE AUTHORITY.

- The expenditure authority for funds under Section 2 shall be the Mayor of Tinian and
- 13 Aguiguan.

14 SECTION 4. REPROGRAMMING.

- Notwithstanding any laws, provisions or regulations to the contrary, funds appropriated
- under this Act shall not be reprogrammed for any other purpose.

17 SECTION 5. REPORTING.

- 18 The expenditure authority shall submit to the Chairperson of the Tinian Legislative
- 19 Delegation a detailed report showing the expenditure of the funds at the completion of
- 20 appropriations in Section 2 of this Act.

21 SECTION 6. FUND DISTRIBUTION.

HOUSE LOCAL BILL 23-40, D1

- Funds appropriated under Section 2 of this Act shall be distributed accordingly for the
- 2 intended purpose and or entity upon this Act becoming law.

3 SECTION 7. FISCAL YEAR.

4 The funds allocated under this Act shall be without fiscal year limitation(s).

5 SECTION 8. SEVERABILITY.

If any provision of this Act or the application of any such provision to any person or

7 circumstance should be held invalid by a court of competent jurisdiction, the remainder of this Act

or the application of its provisions to persons or circumstances other than those to which it is held

9 invalid shall not be affected thereby.

SECTION 9. SAVINGS CLAUSE.

This Act and any repealer contained herein shall not be construed as affecting any existing

right acquired under contract or acquired under statutes repealed or under any rule, regulation or

order adopted under the statutes. Repealers contained in this Act shall not affect any proceeding

instituted under or pursuant to prior law. The enactment of the Act shall not have the effect of

terminating, or in any way modifying, any liability, civil or criminal, which shall already be in

existence on the date this Act becomes effective.

SECTION 10. EFFECTIVE DATE.

18 This Act shall take effect upon its approval by the Governor or it becoming law without

19 such approval.
