A BILL FOR AN ACT

To re-appropriate fund balances from Public Laws 10-15, 10-38, 11-11, 11-67, 11-79, 11-120, and 12-63 for various road projects within Precinct 1; and for other purposes.

BE IT ENACTED BY THE THIRTEENTH NORTHERN MARIANAS COMMONWEALTH LEGISLATURE:

1 **Section 1. Purpose.** The purpose of this bill is to re-appropriate fund balances
2 from Public Laws 10-15, 10-38, 11-11, 11-67, 11-79, 11-120, and 12-63 for the various
3 road projects within Precinct 1.

4 **Section 2. Re-appropriation.** There is hereby re-appropriated from Public Laws
5 10-15 (Afetna Road Project), 10-38 (Police and Fire Substation Kagman II, and Lighting
6 for Dan Dan Homestead-Baseball Field), 11-11 (construction of roads, drains C. Dela
7 Cruz to F. Camacho), 11-67 (San Antonio Power Upgrade and Power Expansion Obyan),
8 11-79 (Nang Ocha Road), 11-120 (San Vicente Basketball Court), and 12-63
9 (Construction of Kagman III Homestead Waterline) the total unexpended fund balance of
10 \$127,023.00 for the design and construction of the various road projects within Precinct

11 **1. (Please see attached for Project Listings)**

12 The Secretary of Public Works shall be the expenditure authority and such funds
13 shall be available without fiscal year limitation.

14 **Section 3. Severability.** If any Section of this Act should be declared invalid by
15 a court of competent jurisdiction, the remainder of this Act shall not be affected thereby.

1 **Section 4. Savings Clause.** This Act and any repealer contained herein shall not
2 be construed as affecting any existing right acquired under contract or acquired under
3 statutes repealed or under any rule, regulation or order adopted under the statutes.
4 Repealer contained in this Act shall not affect any proceeding instituted under or
5 pursuant to prior law. The enactment of this Act shall not have the effect of terminating,
6 or in any way modifying, any liability civil or criminal, which shall already be in
7 existence at the date this Act becomes effective.

8 **Section 5. Effective Date.** This Act shall take effect upon its approval by the
9 Governor or upon it becoming law without such approval.

19. Santos Acres road in Papago
20. Road leading from Joaquin Remedio Babauta to Judge Atalig and Jose Pinaula's residence
21. Lower Dan Dan - Juan S. Tenorio road to Donald Flores (Public Access Road)
22. Road South of Faustina Ada leading down to Joaquin Dlg. Aldan and Mr. Richard Pierce

23. The road from the Water tank to the Police Academy behind the NMC administration building
24. To widen the road leading inward from King's Plaza Dan Dan to CMS
25. Road leading to Katmelo Country
