## A BILL FOR AN ACT

To rename the "Ma'afala Breadfruit Program" as the "Ivan A. Blanco Breadfruit Program".

## BE IT ENACTED BY THE 22<sup>ND</sup> NORTHERN MARIANAS COMMONWEALTH LEGISLATURE:

| 1 | Section 1. Short Title. This Act shall be cited as the "Ivan Blanco                  |

| 2 | Breadfruit Program Act of 2021".   |
| 3 | Section 2. Findings and Purpose. The Legislature finds that the "Ma'afala            |
| 4 | Breadfruit Program" is a program that is dedicated to advocating the importance of   |
| 5 | breadfruit in our lives. Cognizant of the health benefits and sustainability yielded |
| 6 | by such a nutritious fruit, in 2013, the late Governor Eloy S. Inos established the  |
| 7 | "Breadfruit Initiative Task Force" and appointed the dedicated Ivan A. Blanco to     |
| 8 | lead such a task force. Under his appointed leadership, the late Honorable Ivan A.   |
| 9 | Blanco helped ensure the establishment of the CNMI's very own breadfruit             |
| 0 | program. Upon its creation, the late Honorable Ivan A. Blanco has exerted his        |
| 1 | efforts in preserving and continuing the program for years to come.                  |
| 2 | The Legislature also finds that the late Honorable Ivan A. Blanco was a man          |
| 3 | who selflessly dedicated himself to public service. Throughout his tenure in public  |

| 1  | service, ranging from appointed positions in the CNMI government to an elected     |

| 2  | position amongst our local leaders, the late Honorable Ivan A. Blanco was a man    |
| 3  | committed to establishing a sustainable future for generations to come.            |
| 4  | Furthermore, he was a man of high integrity and great character. One of the        |
| 5  | programs he was passionately supporting was the CNMI's breadfruit program.         |
| 6  | From his time at the Grants Management Office all the way through to his untimely  |
| 7  | passing as a devoted member of the Northern Marianas Commonwealth                  |
| 8  | Legislature, the Honorable Ivan A. Blanco committed a significant amount of his    |
| 9  | time and efforts to ensure that the breadfruit program, currently known as the     |
| 10 | "Ma'afala Breadfruit Program", prevails. To memorialize all that he stood for, it  |
| 11 | would be appropriate to rename this well-founded and well-intended program in      |
| 12 | his honor as a token of our gratitude for his selfless devotion and unwavering     |
| 13 | dedication.  |
| 14 | Therefore, the purpose of this Act is to rename the "Ma'afala Breadfruit           |
| 15 | Program" as the "Ivan A. Blanco Breadfuit Program".                                |
| 16 | Section 3. Enactment. Notwithstanding any laws or regulations to the               |
| 17 | contrary and subject to codification by the CNMI Law Revision Commission, the      |
| 18 | following provision is hereby enacted:   |
| 19 | "§101. The "Ma'afala Breadfruit Program" is hereby renamed as the "Ivan            |
| 20 | A. Blanco Breadfruit Program".   |
| 21 | Section 4. Severability. If any provisions of this Act or the application of       |
| 22 | any such provision to any person or circumstance should be held invalid by a court |

1 of competent jurisdiction, the remainder of this Act or the application of its

2 provisions to persons or circumstances other than those to which it is held invalid

3 shall not be affected thereby.

4 Section 5. Savings Clause. This Act and any repealer contained herein

5 shall not be construed as affecting any existing right acquired under contract or

6 acquired under statutes repealed or under any rule, regulation, or order adopted

7 under the statutes. Repealers contained in this Act shall not affect any proceeding

8 instituted under or pursuant to prior law. The enactment of the Act shall not have

the effect of terminating, or in any way modifying, any liability, civil or criminal,

which shall already be in existence on the date this Act becomes effective.

11 Section 6. Effective Date. This Act shall take effect upon its approval by

12 the Governor, or its becoming law without such approval.
