## A LOCAL APPROPRIATION BILL FOR AN ACT FOR THE FIRST SENATORIAL DISTRICT

To appropriate \$434,000 of the funds specifically allotted to the First Senatorial District under 4 CMC §2307(a); and for other purposes.

# BE IT ENACTED BY THE FIRST SENATORIAL DISTRICT DELEGATION PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:

#### 1 SECTION 1. PURPOSE.

2 The purpose of this act is to appropriate \$434,000.00 of the funds

3 specifically allotted to the First Senatorial District under Public Law 18-56, and the

4 balance of \$501,967 is reserved for another appropriation by the Delegation.

#### 5 SECTION 2. APPROPRIATION.

6 Three hundred Thousand dollars allocated to the First Senatorial District is7 appropriated as follows:

8 (a) \$50,000 to the Rota Liaison Office under the expenditure authority of

9 the RLO/Medical Referral Coordinator for the following:

10 (1) \$10,000 for the purchase of beds, washing machine, and dryer.

1	2) \$20,000 for the renovation of the Samoan Houses
2	3) \$15,000 for the daily operations
3	4) \$5,000 for fuel and lubricants and for vehicle maintenance
4	(b) \$7,000 for the Indigenous Affairs Office under the expenditure
5	authority of the Resident Executive.
6	(c) \$25,000 for the purchase of a vehicle for the Rota OPM office under the
7	expenditure authority of the Director of Personnel.
8	(d) \$100,000 for air conditioning units for Sinapalo Elementary School
9	under the expenditure authority of the Commissioner of Education.
10	(e) 130,000 for the purchase of vehicles for the Department of Land and
11	Natural Resources-Rota under the expenditure authority of the Resident
12	Director.
13	(f) \$40,000 for the Rota Little League under the expenditure authority of
14	the Rota Little League President
15	(g) \$60,000 the Department of Community and Cultural Affairs-Rota under
16	the expenditure authority of the Resident Director
17	1. \$50,000 for youth programs identified by the Sports Division
18	2. \$10,000 to purchase computers for the Sinapalo Youth Center
19	(h) \$12,000 for the Department of Labor for training and work placement
20	programs under the expenditure authority of the Resident Director.
21	(i) \$10,000 for bed sheets and pillowcases for the Rota Health Center under

1	the expenditure authority of the Resident Director.
2	
3	SECTION 3. NO REPROGRAMMING.
4	The funds allocated under Section 2 shall not be reprogrammed for any
5	other purpose.
6	
7	SECTION 4. SEVERABILITY.
8	If any provision of this Act or the application of any such provision to any
9	person or circumstance should be held invalid by a court of competent jurisdiction,
10	the remainder of this Act or the application of its provisions to persons or
11	circumstances other than those to which it is held invalid shall not be affected
12	thereby.
13	SECTION 5. SAVINGS CLAUSE.
14	This Act and any repealer contained herein shall not be construed as
15	affecting any existing right acquired under contract or acquired under statutes
16	repealed or under any rule, regulation or order adopted under the statutes.
17	Repealers contained in this Act shall not affect any proceeding instituted under or
18	pursuant to prior law. The enactment of the Act shall not have the effect of
19	terminating, or in any way modifying, any liability, civil or criminal, which shall
20	already be in existence on the date this Act becomes effective.
21	SECTION 6. EFFECTIVE DATE.

This Act shall take effect upon its approval by the Governor or its becoming
