A LOCAL APPROPRIATION BILL FOR AN ACT FOR THE SECOND SENATORIAL DISTRICT

To re-appropriate Twenty-Five Thousand Dollars (\$25,000.00) allotted under Tinian Local Ordinance 20-3; and Five Thousand Dollars (\$5,000.00) allotted under Tinian Local Law 20-15 Section 2(i); and Five Thousand Dollars (\$5,000.00) allotted under Tinian Local Law 20-17 Section 2(b); and for other purposes.

BE IT ENACTED BY THE SECOND SENATORIAL DISTRICT DELEGATION PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:

1 SECTION 1. PURPOSE.

- The purpose of this act is to re-appropriate Twenty-Five Thousand Dollars
- 3 (\$25,000.00) allotted under Tinian Local Ordinance 20-3; and Five Thousand
- 4 Dollars (\$5,000.00) allotted under Tinian Local Law 20-15; and Five Thousand
- 5 Dollars (\$5,000.00) allotted under Tinian Local Law 20-17.

6 SECTION 2. RE-APPROPRIATIONS.

- Notwithstanding any provisions, statues, laws or regulations to the contrary.
- 8 the Tinian and Aguiguan Legislative Delegation hereby re-appropriates the

2	(a) Twenty-Five Thousand Dollars (\$25,000.00) allotted under Tinian Local
3	Ordinance 20-3 §108 ""Appendix A" Activity No.2" Man Amko Generator; and
4	(b) Five Thousand Dollars (\$5,000.00) allotted under Tinian Local Law 20-
5	15 §2(i) for the Tinian Teen Center Operations and Activities; and
6	(c) Five Thousand Dollars (\$5,000.00) allotted under Tinian Local law 20-
7	17 §2(b) for Tinian Guest House Patio/Kitchen construction to the following
8	programs:
9	(1) Twenty Thousand Dollars (\$20,000.00) for the Tinian Little
10	League Asia Pacific 50/70 Tournament in Korea and/or other public
11	programs; and
12	(2) Fifteen Thousand Dollars (\$15,000.00) for the Mayor's
13	Discretionary Account.
14	SECTION 3. EXPENDITURE AUTHORITY
15	For the funds appropriated under Section 2 of this Act, the Mayor of the
16	Municipality of Tinian and Aguiguan shall be the expenditure authority.
17	SECTION 4. SEVERABILITY.
18	If any provision of this Act or the application of any such provision to any
19	person or circumstance should be held invalid by a court of competent jurisdiction,
20	the remainder of this Act or the application of its provisions to persons or
21	circumstances other than those to which it is held invalid shall not be affected

1 thereby.

2 SECTION 5. SAVINGS CLAUSE.

- This Act and any repealer contained herein shall not be construed as
- 4 affecting any existing right acquired under contract or acquired under statutes
- 5 repealed or under any rule, regulation or order adopted under the statutes.
- 6 Repealers contained in this Act shall not affect any proceeding instituted under or
- 7 pursuant to prior law. The enactment of the Act shall not have the effect of
- 8 terminating, or in any way modifying, any liability, civil or criminal, which shall
- 9 already be in existence on the date this Act becomes effective.

10 SECTION 6. EFFECTIVE DATE.

- 11 This Act shall take effect upon its approval by the Governor or upon its
- becoming law without such approval.
