A LOCAL APPROPRIATION BILL FOR AN ACT FOR THE THIRD SENATORIAL DISTRICT

To re-appropriate Precinct IV remaining project fund balances from SLL 17-3, SLL 17-16, SLL 18-18, SLL 18-23, and SLL 19-3 for the Pau Pau Beach Park project set forth in SLL 19-11.

BE IT ENACTED BY THE THIRD SENATORIAL DISTRICT DELEGATION PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:

1 SECTION 1. PURPOSE.

- The purpose of this Act is to re-appropriate the remaining fund balances
- 3 from SLL 17-3 Business Unit No. 3374G in the amount of \$611.00; SLL 17-16
- 4 Business Unit No. 3752E in the amount of \$85.00; SLL 18-18 Business Unit No.
- 5 3752P in the amount of \$80.00; SLL 18-23 Business Unit No. 3400D in the amount
- 6 of \$28,336.92; and SLL 19-3 Business Unit No. 3500D and 3500N in the amounts
- 7 of \$829.50 and \$10,000.00 to fully fund the Pau Pau Beach Park project set forth
- 8 in SLL 19-11.
- 9 **SECTION 2. APPROPRIATION.**
- Notwithstanding any provision of law to the contrary, the Saipan and

- 1 Northern Islands Legislative Delegation hereby appropriates the remaining fund
- 2 balances from SLL 17-3, SLL 17-16, SLL 18-18, SLL 18-23, and SLL 19-3 totaling
- 3 in the amount of \$39,942.42 for the Pau Pau Beach park project set forth in SLL
- 4 19-11.

5 SECTION 3. EXPENDITURE AUTHORITY.

- The expenditure authority for the funds under Section 2 of this Act shall be
- 7 the Secretary of the Department of Public Works.

8 SECTION 4. FUND DISTRIBUTION.

- 9 Funds appropriated under Section 2 of this Act shall be distributed
- accordingly to the intended purpose and or entity upon this Act becoming law.

11 SECTION 5. FISCAL YEAR.

The funds allocated under this Act shall be without fiscal year limitation(s).

13 SECTION 6. SEVERABILITY.

- If any provision of this Act or the application of any such provision to any
- person or circumstance should be held invalid by a court of competent jurisdiction,
- 16 the remainder of this Act or the application of its provisions to persons or
- 17 circumstances other than those to which it is held invalid shall not be affected
- 18 thereby.

19 SECTION 7. SAVINGS CLAUSE.

- This Act and any repealer contained herein shall not be construed as
- 21 affecting any existing right acquired under contract or acquired under statutes

- 1 repealed or under any rule, regulation or order adopted under the statutes.
- 2 Repealers contained in this Act shall not affect any proceeding instituted under or
- 3 pursuant to prior law. The enactment of the Act shall not have the effect of
- 4 terminating, or in any way modifying, any liability, civil or criminal, which shall
- 5 already be in existence on the date this Act becomes effective.
- 6 SECTION 8. EFFECTIVE DATE.
- 7 This Act shall take effect upon its approval by the Governor or its becoming
- law without such approval. 8
