**A LOCAL APPROPRIATION BILL FOR AN ACT  
FOR THE THIRD SENATORIAL DISTRICT**

To re-appropriate the amount of Ninety Two Thousand Six Hundred Fifty-Five Dollars and Eighty Cents (\$92,655.80) allotted under Saipan Local Law 20-01 and Eleven Thousand Four Hundred Fifty-Nine Dollars and Sixteen Cents (\$11,459.16) allotted under Saipan Local Law 20-23 and Five Thousand Dollars (\$5,000.00) allotted under Saipan Local Law 20-23; and for other purposes.

**BE IT ENACTED BY THE THIRD SENATORIAL DISTRICT DELEGATION  
PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE  
COMMONWEALTH CODE:**

**1 SECTION 1. PURPOSE.**

2           The purpose of this Act is to re-appropriate the amount of Ninety Two  
3 Thousand Six Hundred Fifty-Five Dollars and Eighty Cents (\$92,655.80) allotted  
4 under Saipan Local Law 20-01 and Eleven Thousand Four Hundred Fifty-Nine  
5 Dollars and Sixteen Cents (\$11,459.16) allotted under Saipan Local Law 20-23 and  
6 Five Thousand Dollars (\$5,000.00) allotted under Saipan Local Law 20-23;

**7 SECTION 2. RE-APPROPRIATIONS.**

8           Notwithstanding any provisions, statutes, laws or regulations to the  
9 contrary, the Saipan and Northern Islands Legislative Delegation hereby re-

1 appropriates the following amounts:

2 (A) Ninety Two Thousand Six Hundred Fifty-Five Dollars and Eighty Cents

3 (\$92,655.80) allotted under Saipan Local Law 20-01, specifically from

4 Business Unit 4962X.

5 (B) Eleven Thousand Four Hundred Fifty-Nine Dollars and Sixteen Cents

6 (\$11,459.16) allotted under Saipan Local Law 20-23, specifically from

7 Business Unit 4963G.

8 (C) Five Thousand Dollars (\$5,000.00) allotted under Saipan Local Law 20-

9 23, specifically from Business Unit 4963I.

10 The total amount set forth in Section 2(A), 2(B), and 2(C) shall be used for the  
11 asphalt paving of Kahet Avenue in Kagman 3, Phase 4.

12 **SECTION 3. EXPENDITURE AUTHORITY.**

13 The expenditure authority for the funds under Section 2 of this Act shall be  
14 the Secretary of the Department of Public Works.

15 **SECTION 4. FUND DISTRIBUTION.**

16 Funds appropriated under Section 2 of this Act shall be distributed  
17 accordingly to the intended purpose and or entity upon this Act becoming law.

18 **SECTION 5. FISCAL YEAR.**

19 The funds allocated under this Act shall be without fiscal year limitation(s).

20 **SECTION 6. SEVERABILITY.**

21 If any provision of this Act or the application of any such provision to any



1 person or circumstance should be held invalid by a court of competent jurisdiction,  
2 the remainder of this Act or the application of its provisions to persons or  
3 circumstances other than those to which it is held invalid shall not be affected  
4 thereby.

5 **SECTION 7. SAVINGS CLAUSE.**

6 This Act and any repealer contained herein shall not be construed as  
7 affecting any existing right acquired under contract or acquired under statutes  
8 repealed or under any rule, regulation or order adopted under the statutes.  
9 Repealers contained in this Act shall not affect any proceeding instituted under or  
10 pursuant to prior law. The enactment of the Act shall not have the effect of  
11 terminating, or in any way modifying, any liability, civil or criminal, which shall  
12 already be in existence on the date this Act becomes effective.


13 **SECTION 8. EFFECTIVE DATE.**


