**A LOCAL APPROPRIATION BILL FOR AN ACT
FOR THE SECOND SENATORIAL DISTRICT**

To appropriate funds specifically allotted to the Second Senatorial District under Public Law 18-30, as amended; and for other purposes.

BE IT ENACTED BY THE SECOND SENATORIAL DISTRICT DELEGATION

PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE

COMMONWEALTH CODE:

1 **SECTION 1. FINDINGS AND PURPOSE.**

2 The Tinian and Aguiguan Legislative Delegation finds that there is
3 available for appropriation the amount of Forty-Four Thousand Seven Hundred
4 Eighty-Three dollars (\$44,783.00 USD) of the funds specifically allotted to the
5 Second Senatorial District under Public Law No. 18-30, as amended, pursuant to
6 Dept./Agency Comm. 21-10. Accordingly, the purpose of this Act is to appropriate
7 Forty-Four Thousand Seven Hundred Eighty-Three dollars (\$44,783.00 USD) of
8 the funds specifically allotted to the Second Senatorial District under Public Law
9 No. 18-30, as amended, for personnel and operations of Office of the Mayor of the
10 Municipality of Tinian and Aguiguan.

1 **SECTION 2. APPROPRIATIONS.**

2 There is hereby appropriated Forty-Four Thousand Seven Hundred Eighty-
3 Three dollars (\$44,783.00 USD) of the funds allotted to the Second Senatorial
4 District under Public Law No. 18-30, as amended, to be expended by the Office of
5 the Mayor of Tinian and Aguiguan for personnel and operations.

6 **SECTION 3. EXPENDITURE AUTHORITY.**

7 The expenditure authority for all funds appropriated under this Act shall be
8 the Mayor of Tinian and Aguiguan.

9 **SECTION 4. FISCAL YEAR.**

10 The funds appropriated under this Act shall be appropriated without fiscal
11 year limitation(s).

12 **SECTION 5. SEVERABILITY.**

13 If any provision of this Act or the application of any such provision to any
14 person or circumstance should be held invalid by a court of competent jurisdiction,
15 the remainder of this Act or the application of its provisions to persons or
16 circumstances other than those to which it is held invalid shall not be affected
17 thereby.

18 **SECTION 6. SAVINGS CLAUSE.**

19 This Act and any repealer contained herein shall not be construed as
20 affecting any existing right acquired under contract or acquired under statutes
21 repealed or under any rule, regulation or order adopted under the statutes.

1 Repealers contained in this Act shall not affect any proceeding instituted under or
2 pursuant to prior law. The enactment of the Act shall not have the effect of
3 terminating, or in any way modifying, any liability, civil or criminal, which shall
4 already be in existence on the date this Act becomes effective.


5 **SECTION 7. EFFECTIVE DATE.**

7 becoming law without such approval.


