A LOCAL APPROPRIATION BILL FOR AN ACT FOR THE SECOND SENATORIAL DISTRICT

To make limited appropriations for the personnel and operations of the Tinian Casino Gaming Control Commission for Fiscal Year 2022 pursuant to 10 CMC § 2581 [Tinian Local Law 21-9] and 1 CMC § 1405(a) [Public 11-17].

BE IT ENACTED BY THE SECOND SENATORIAL DISTRICT DELEGATION PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:

1 SECTION 101. FINDINGS. The Tinian and Aguiguan Legislative 2 Delegation (TALD) is cognizant of the Delegation's obligation to enact a Tinian 3 Local Budget for fiscal year 2022 on or before October 1, 2021. However, the 4 TALD did not receive any notice of estimated gaming revenue projection for fiscal 5 year 2022 until March 1, 2022. The Office of the Tinian Municipal Treasurer 6 transmitted a communication dated March 1, 2022 to the TALD identifying local 7 revenue for fiscal year 2022 in the amount of \$254,500.00 that is available for 8 appropriation following a payment of a casino license fee. Pursuant to 10 CMC § 9 2581(b)(3), as established by Tinian Local Law 21-9, casino licensees are required 10 to renew their licenses upon its expiration. Failure to renew a conditional or plenary

1 license upon expiration shall be grounds for the revocation, suspension or 2 termination of a casino license. 3 The Tinian and Aguiguan Legislative Delegation finds that the identified 4 local revenue for fiscal year 2022 is insufficient to satisfy in full all the personnel 5 and operation expenses of the Tinian Casino Gaming Control Commission 6 (TCGCC), Office of the Mayor of Tinian & Aguiguan, and the Tinian Municipal 7 Treasurer up to the end of the fiscal year on September 30, 2022. Accordingly, the TALD finds that it is necessary to appropriate the identified local revenue for the 8 9 personnel and operation expenses of the Commission Division and the Division of 10 Enforcement – Administration of the TCGCC for the months of July 1, 2022 to September 30, 2022. Any remaining funds available after September 30, 2022 shall 11 12 be carried forward to fund the operations of TCGCC-Commission Division and 13 Division of Enforcement – Administration in fiscal year 2023. 14 **SECTION 102. PURPOSE.** This Act appropriates limited local funds 15 generated pursuant to 10 CMC § 2581 [Tinian Local Law 21-9, the Revised Tinian 16 Casino Gaming Control Act of 1989], for the personnel and operations of the Tinian 17 Casino Gaming Control Commission - Commission Division and Division of Enforcement - Administration for the months of July 1, 2022 to September 30, 18 19 2022. Any remaining funds available after September 30, 2022 shall be carried 20 forward to fund the personnel and operations of TCGCC-Commission Division and 21 Division of Enforcement – Administration in fiscal year 2023.

1	SECTION 103. ESTIMATED LOCAL REVENUES. Pursuant to							
2	Delegation Matter 21-06, the estimated local revenues deposited pursuant to 10							
3	CMC §§ 2581 [Tinian Local Law 21-9, the Revised Tinian Casino Gaming Control							
4	Act of 1989], for the Municipality of Tinian and Aguiguan for Fiscal Year 2022 are							
5	hereby identified and classified as resources in this local appropriations Act.

7	1. Casino license fee \$250,000.00							
8	2. Casino Service Industry Fee (FY2022) \$ 1,500.00							
9	3. Lapses from FY2021 \$ 3,000.00

11	SECTION 104. MUNICIPAL GOVERNMENT LIMITED							
12	APPROPRIATIONS.							
13	(a) The amount of \$185,706.00 for the personnel and operations of the							
14	Tinian Casino Gaming Control Commission - Commission Division and the							
15	Division of Enforcement - Administration is hereby appropriated as set forth in the							
16	worksheet attached hereto as "Schedule A" and incorporated by reference in this							
17	Act.							
18	(b) The amount appropriated in subsection (a) of this Section shall include							
19	the personnel and operations of the Tinian Casino Gaming Control Commission -							
20	Commission Division and Enforcement Division – Administration beginning July							
21	1. 2022 and ending on October 1. 2022.							

1	(c) Notwithstanding any law or regulation to the contrary, the amount of							
2	\$68,794.00 is hereby appropriated and carried forward to fund the personnel and							
3	operations the Tinian Casino Gaming Control Commission, Commission Divisio							
4	and Division of Enforcement – Administration in fiscal year 2023.							
5	SECTION 105. PUBLIC PROGRAMS. Public programs and activitie							
6	funded by the funds generated pursuant to 10 CMC § 2581 [Tinian Local Law 21							
7	9, the Revised Tinian Casino Gaming Control Act of 1989] are hereby limited t							
8	the programs listed in "Schedule A."							
9	SECTION 106. ADMINISTRATIVE GUIDELINES.							
10	(a) The funds appropriated under Section 104 this Act shall be distributed							
11	and allotted by the Office of the Municipal Treasurer in accordance with the							
12	expenditure class codes approved in the individual activities budget workshee							
13	attached hereto.							
14	(b) The funds appropriated herein shall be allotted at the beginning of each							
15	month to each budget activity at a pro-rated rate of the amount appropriated subject							
16	to the availability of funds and approval of the respective expenditure authorities as							
17	provided in Section 109 of this Act;							
18	SECTION 107. REDUCTION IN THE LEVEL OF							
19	APPROPRIATIONS. In order to provide expenditure authorities with flexibility							
20	in determining the allocation of funding for their operations, expenditure authorities							
1	must reduce their expenditures to achieve the level of appropriation under this Act							

1	(a) Expenditure authorities may reduce previous levels of expenditure by:
2	(1) A reduction in work hours;
3	(2) A reduction in wages;
4	(3) Furlough;
5	(4) A reduction in force;
6	(5) A reduction in expenditures for "all others"; or
7	(6) A combination of reductions under subsections (1) through (5).
8	(b) The reduction in work hours shall not apply to inspectors employed by
9	the Tinian Casino Gaming Control Commission, Division of Enforcement -
10	Administration, as required by Articles 2 and 10 of Tinian Local Law 21-9, the
11	Revised Tinian Casino Gaming Control Act of 1989, upon the reopening of any
12	casino.
13	SECTION 108. APPROPRIATION WORKSHEET. Unless otherwise
14	provided in this Act, the funds appropriated pursuant to Section 104 hereof shall be
15	expended in compliance with the appropriations worksheet attached hereto as
16	"Schedule A" and incorporated by reference herein. In case of any conflict between
17	the attached worksheet and the Administrative Provisions of this Act, the
18	Administrative Provisions shall prevail.
19	SECTION 109. EXPENDITURE AUTHORITY.
20	Notwithstanding any law to the contrary, the Mayor of Tinian & Aguiguan
21	shall be the expenditure authority of the funds appropriated to the personnel and

2 Administration of the Tinian Casino Gaming Control Commission. 3 SECTION 110. MANAGEMENT OF FUNDS. 4 (a) The Tinian Municipal Treasurer shall regulate and control the 5 expenditure of public funds that are appropriated and allocated by this Act, so that no activity may expend appropriated funds contrary to this Act or fiscal 6 7 management policies; and 8 (b) Vacant positions or FTEs shall not be announced or filled without 9 certification of available funds by the Tinian Municipal Treasurer and approved for 10 expenditure by the respective expenditure authority. Zero-funded positions or FTEs 11 shall not be filled and funds appropriated herein shall not be reprogrammed to fund 12 zero-funded positions or FTEs. 13 (c) Notwithstanding any law to the contrary and immediately upon approval 14 of this Act, all employment positions or contracts may be amended or adjusted to 15 reflect any increase or change in salary enumerated in the appropriation worksheet 16 set forth in "Schedule A" of this Act subject to certification of availability of funds. 17 (d) Notwithstanding any law to the contrary, the funds appropriated 18 pursuant to this Act shall not be used to increase the salary of any employee or 19 position from its current level or new level as set forth and appropriated by this Act. 20 SECTION 111. REPROGRAMMING AND PROPORTIONATE 21 **REDUCTION OF FUNDS.** Except as provided in Section 110 of this Act, in the

operations of the Commission Division and the Division of Enforcement -

1 event that the estimated revenue collected is ten (10) percent below the projected 2 or estimated revenue indicated in Section 103 of this Act, the respective expenditure 3 authority shall have full reprogramming authority of all funds in order to properly 4 manage expenditures so as to not create a deficit. In such an event, the Mayor shall 5 proportionately reduce the amounts appropriated herein. 6 SECTION 112. SUPPLEMENTAL APPROPRIATIONS. In the event 7 that the Municipal Treasurer determines that the estimated local revenues collected 8 will be increased by \$100,000 or more of the projected or estimated revenue 9 indicated in Section 103 of this Act, the Municipal Treasurer shall transmit within 10 fifteen (15) calendar days a special budget message to the Tinian & Aguiguan 11 Mayor's Office, the Chairman of the Tinian Legislative Delegation and the 12 Chairman of the Tinian Municipal Council proposing to increase the reserve for the 13 fiscal year or provide additional budget authority for the fiscal year. Any increases 14 in revenues shall be held in reserve, unless appropriated by the Tinian and 15 Aguiguan Legislative Delegation. 16 SECTION 113. NO CONTINUING APPROPRIATIONS. The Tinian 17 Casino Gaming Control Commission and the Tinian Municipal Treasurer through 18 the Mayor shall provide revenue projections and proposed appropriations on or 19 before June 1, 2022. The Tinian and Aguiguan Legislative Delegation, shall pass a 20 balanced budget by October 1, 2022 unless all casino operations have shut down or 21 gaming funds are not available. Except as provided in Section 104(c) of this Act,

1 no expenditures shall be made absent an appropriation measure signed into law for 2 fiscal year 2023. 3 SECTION 114. CRIMINAL PENALTIES. Without limitation on the 4 applicability of any other part of the Planning and Budget Act of 1983, as amended, 5 the criminal penalties set forth therein (1 CMC § 7701 et seq.) shall apply to this 6 Act. 7 SECTION 115. SEVERABILITY. If any provision of this Act or the 8 application of any such provision to any person or circumstance should be held 9 invalid by a court of competent jurisdiction, the remainder of this Act or the 10 application of its provisions to persons or circumstances other than those to which 11 it is held invalid shall not be affected thereby. 12 SECTION 116. SAVINGS CLAUSE. This Act and any repealer contained 13 herein shall not be construed as affecting any existing right acquired under contract 14 or acquired under statutes repealed or under any rule, regulation or order adopted 15 under the statutes. Repealers contained in this Act shall not affect any proceeding 16 instituted under or pursuant to prior law. The enactment of the Act shall not have 17 the effect of terminating, or in any way modifying, any liability, civil or criminal, 18 which shall already be in existence on the date this Act becomes effective. 19 **SECTION 117. EFFECTIVE DATE.** This Act shall take effect upon its 20 approval by the Governor or upon it becoming law without such approval.
