A LOCAL APPROPRIATION BILL FOR AN ACT FOR THE SECOND SENATORIAL DISTRICT

To appropriate Ten Thousand Dollars (\$10,000.00) allotted under Tinian Local Law 23-13 and One Hundred Fourteen Thousand Dollars (\$114,000.00) from revenues collected from poker fees in the Second Senatorial District; and for other purposes.

BE IT ENACTED BY THE SECOND SENATORIAL DISTRICT DELEGATION PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:

1 SECTION 1. PURPOSE.

- The purpose of this Act is to appropriate Ten Thousand dollars (\$10,000.00
- 3 USD) allotted under Tinian Local Law 23-13 §2(B) which was line-item vetoed.
- 4 The Tinian and Aguiguan Legislative Delegation recognizes Governor Palacios'
- 5 veto message. Accordingly, the Delegation seeks to appropriate One Hundred
- 6 Fourteen Dollars (\$114,000.00 USD) from revenues collected from poker fees in
- 7 the Second Senatorial District. The certification of funds was prepared on August
- 8 26, 2004 and was certified by the Secretary of Finance on August 29, 2024. For a
- 9 combined total of One Hundred Twenty-Four Thousand Dollars (\$124,000.00)
- 10 This appropriation of local funds is not part of the FY2024 Budget Act. Therefore,

1	this local appropriation of local funds does not contravene ICMC§ 7401 and 1
2	CMC §7404(d) or any other provision of the CNMI Budget Act.
3	SECTION 2. APPROPRIATIONS.
4	Notwithstanding any provision(s) of law, statutes, rules or regulations to the
5	contrary and pursuant to funds allocated to the Second Senatorial District from
6	poker fees, the Tinian and Aguiguan Legislative Delegation hereby appropriates
7	under Ten Thousand Dollars (\$10,000.00) allotted under Tinian Local Law 23-13
8	§2(B) to the following:
9	(A) Five Thousand Dollars (\$5,000.00) to Tinian Municipal Council for
0	operations.
1	(B) Five Thousand Dollars (\$5,000.00) to Tinian and Aguiguan Legislative
2	Delegation for operations.
3	And One Hundred Fourteen Thousand Dollars (\$114,000.00) of the revenues
4	collected for the Second Senatorial District from the poker fees as follows:
5	(C) \$114,000.00 to the Mayor of Tinian for personnel and operations,
6	expenditure of the funds under Section 2 shall be the Mayor of Tinian.
7	SECTION 3. EXPENDITURE AUTHORITY.
8	(A) The expenditure authority for funds under Section 2(A) shall be the
9	Chairman of the Tinian Municipal Council.
0	(R) The expenditure authority for funds under Section 2(R) shall be the

1	Chairman of the Tinian and Aguigian Legislative Delegation.
2	(C) The expenditure authority for funds under Section 2(C) shall be the
3	Mayor of Tinian and Aguiguan.
4	SECTION 4. REPROGRAMMING.
5	Funds appropriated under this act shall not be reprogrammed for any other
6	purpose and notwithstanding any provision of law, all funds appropriated under this
7	Act shall be without fiscal year limitation(s).
8	SECTION 5. REPORTING OF EXPENDITURES.
9	The recipient of the funds allocated under Section 2 of this Act shall be
0	responsible to report all expenses responsible to report all expenses to the Secretary
1	of the Department of Finance by the end of the 2024 calendar year. Provided further
2	that failure to provide all expenses, entities that were afforded funds under this Act
3	shall not be able to avail to any future funds appropriated by the Tinian & Aguiguan
4	Legislative Delegation.
5	SECTION 6. SEVERABILITY.
6	If any provision of this Act or the application of any such provision to any
7	person or circumstance should be held invalid by a court of competent jurisdiction,
8	the remainder of this Act or the application of its provisions to persons or
9	circumstances other than those to which it is held invalid shall not be affected
0	thereby.

SECTION 7. SAVINGS CLAUSE.

1

2 This Act and any repealer contained herein shall not be construed as

3 affecting any existing right acquired under contract or acquired under statutes

4 repealed or under any rule, regulation or order adopted under the statutes. Repealers

5 contained in this Act shall not affect any proceeding instituted under or pursuant to

6 prior law. The enactment of the Act shall not have the effect of terminating, or in

7 any way modifying, any liability, civil or criminal, which shall already be in

8 existence on the date this Act becomes effective.

9 SECTION 8. EFFECTIVE DATE.

This Act shall take effect upon its approval by the Governor or upon its

11 becoming law without such approval.
