**A LOCAL APPROPRIATION BILL FOR AN ACT
FOR THE THIRD SENATORIAL DISTRICT**

To re-appropriate the remaining fund balance of \$221,649.00 under Saipan Local Law 22-16 (Project Code 2001E); and for other purposes.

BE IT ENACTED BY THE THIRD SENATORIAL DISTRICT

DELEGATION PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1 OF

THE COMMONWEALTH CODE:

1 **SECTION 1. PURPOSE.**

2 The purpose of this Act is to re-appropriate the remaining fund balance of
3 \$221,649.00 under Saipan Local Law 22-16 (Project Code 2001E) for the
4 construction, renovation, and/or repair of speed bumps, bus shelters, restroom
5 facilities, crosswalks, installation of street lights and traffic signages, and road
6 repairs/improvements within Precinct V, and for other purposes.

7 **SECTION 2. RE-APPROPRIATION.**

8 Notwithstanding any provisions, statutes, laws, or regulations to the
9 contrary, the Saipan and Northern Islands Legislative Delegation hereby re-

1 appropriates the remaining fund balance of \$221,649.00, which shall be allocated
2 as follows:

3 (a) \$221,649.00 allotted under Saipan Local Law 22-16,
4 specifically under Project Code 2001E, for the construction,
5 renovation, and/or repair of speed bumps, bus shelters, restroom
6 facilities, crosswalks, installation of street lights and traffic
7 signages, and road repairs/improvements within Precinct V.

8 **SECTION 3. EXPENDITURE AUTHORITY.**

9 The expenditure authority for the funds under Section 2 (d) of this Act shall
10 be the Secretary of the Department of Public Works.

11 **SECTION 4. REPROGRAMING.**

12 Notwithstanding any laws, provisions or regulations to the contrary, funds
13 appropriated under this Act shall not be reprogrammed for any other purpose.

14 **SECTION 5. REPORTING.**

15 The expenditure authority shall submit to the Chairperson of the Saipan and
16 Northern Islands Legislative Delegation a detail report showing the expenditure of
17 the funds at the completion of appropriations in Section 2 of this Act.

18 **SECTION 6. FUND DISTRIBUTION.**

19 Funds appropriated under Section 2 of this Act shall be distributed
20 accordingly to the intended purpose and or entity upon this Act becoming law.

21 **SECTION 7. FISCAL YEAR.**

1 The funds allocated under this Act shall be without fiscal year limitation(s).

2 **SECTION 8. SEVERABILITY.**

3 If any provision of this Act or the application of any such provision to any
4 person or circumstance should be held invalid by a court of competent jurisdiction,
5 the remainder of this Act or the application of its provisions to persons or
6 circumstances other than those to which it is held invalid shall not be affected
7 thereby.

8 **SECTION 9. SAVINGS CLAUSE.**


9 This Act and any repealer contained herein shall not be construed as
10 affecting any existing right acquired under contract or acquired under statutes
11 repealed or under any rule, regulation or order adopted under the statutes. Repealers
12 contained in this Act shall not affect any proceeding instituted under or pursuant to
13 prior law. The enactment of the Act shall not have the effect of terminating, or in
14 any way modifying, any liability, civil or criminal, which shall already be in
15 existence on the date this Act becomes effective.

16 **SECTION 10. EFFECTIVE DATE.**

17 This Act shall take effect upon its approval by the Governor or it becoming
18 law without such approval.


