**A HOUSE RESOLUTION**

To congratulate and commend the CNMI Senior League All-Star Team for becoming the 2018 Senior League Asia-Pacific Champions held in the Asia-Pacific Regional Little League Baseball Tournament in Clark, Pampanga, Philippines and earning the coveted ticket to play in the Senior League Baseball World Series in Easley, South Carolina from July 28 to August 4, 2018.

1           **WHEREAS**, on Thursday, July 5, 2018, the CNMI Senior League All-Star  
2   Team rallied to defeat the Philippines Senior League All-Star Team by a score of 4  
3   to 2 to win the 2018 Senior League Asia-Pacific Championship at Clark, Pampanga,  
4   Philippines; and

5           **WHEREAS**, the 2018 Senior League Asia-Pacific Championship Team

10          **WHEREAS**, the 2018 Senior League Asia-Pacific Championship Team is  
11   led by Manager Doru Camacho, Coach Juan Manibusan and Assistant Coach  
12   Vicente Camacho; and

1           **WHEREAS,** the CNMI Senior League All-Star Team was successful  
2 because of solid coaching and execution of fundamentals and discipline; and

3           **WHEREAS,** the fans of the CNMI Senior League All-Star Team showed  
4 enthusiasm, support and courtesy for the game of baseball and all of the players and  
5 coaches; and

6           **WHEREAS,** the performance of the CNMI Senior League All-Star Team  
7 demonstrated to parents and communities throughout the Asia-Pacific Region that  
8 athletic participation builds character and leadership in children; and

9           **WHEREAS,** the achievements of the CNMI Senior League All-Star Team  
10 is the cause of enormous pride for the Commonwealth of the Northern Mariana  
11 Islands and especially for the island of Saipan; and

12           **WHEREAS,** the CNMI will be one of the 12 regional champions – six  
13 from the United States Teams and six from the International Teams – who will play  
14 for the title of Senior League Baseball World Champion beginning July 28 in  
15 Easley, South Carolina; and

16           **WHEREAS,** the Members of the Twentieth Northern Marianas  
17 Commonwealth Legislature and the People of the Commonwealth are immensely  
18 proud of the CNMI Senior League All-Star Team for winning the 2018 Senior  
19 League Asia-Pacific Championship and wishes them the best of luck at the Senior  
20 League Baseball World Series in Easley, South Carolina;
