A HOUSE RESOLUTION

To recognize, honor, and express appreciation to Rufina Tuloi Borja Seman for 50 years of exemplary and distinguished service in education.

3 dedication, compassion, and exemplary teaching; and

5 the Head Start program in Saipan, nurturing children during their most formative
6 years and promoting school readiness; and

7 **WHEREAS**, she has served 19 years, and continues to serve with
8 distinction at San Vicente Elementary School in Saipan, where she remains a
9 steadfast mentor, role model, and pillar of the school community; and

10 **WHEREAS**, throughout her career, Rufina Tuloi Borja Seman has
11 exemplified professionalism, patience, and a profound passion for teaching, leaving
12 an enduring legacy in every community she has served; and

13 **WHEREAS**, her dedication has significantly advanced the educational
14 attainment and well-being of generations of students, their families, and the broader
15 community; and

16 **WHEREAS**, this August Body is honored and privileged to recognize,
17 commend, and express appreciation to Rufina Tuloi Borja Seman for 50 years of
