- <u>Speaker Fitial</u>: These are all information from the Governor's Office. Any comments or deliberation on these messages? Representative Attao?

<u>Rep. Attao</u>: I am just wondering why Governor's communications on exemptions are not part of today's agenda?

<u>Speaker Fitial</u>: I have asked the Clerk to reproduce copies of all those communications from the Governor regarding exemptions and distribute them to all the members for their information. I believe those communications do not warrant the deliberation of the House. Representative Benavente?

Rep. Benavente: The law presently requires the Governor to certify to the Legislature each time he allows the exemptions or authorizes the exemptions on the Public Law. I believe at this time that it does require that it become and official communication of the House and therefore needs to appear in the session Agenda. I think that by just having it passed out to the individual members, it does not comply with the intent of the law, and I ask the Speaker to allow those exemptions to appear on the Agenda so that it becomes official communications between the Administration and the Legislature or in this case, the House of Representatives.

<u>Speaker Fitial</u>: I will make sure that these communications appear in the next session. But let me ask, Representative Benavente, is this for information for the Legislature only

or for the Legislature to deliberate on the exemptions and what is the Legislature do? Can the Legislature do anything to change the action taken by the Governor in issuing those waivers to respective businesses?

Rep. Benavente: Mr. Speaker, the intent of the law is to allow the Legislature to review those exemptions. And yes, it may not do so directly at that moment but it may than when the Legislature questions the authority of the Governor in granting of the exemptions, it may then propose to amend the law. That is what was intended -- that the Legislature be allowed and at the same time to review the exemptions being made by the Governor. That is why that is important, because at any time that we, here at the Legislature, disagree with the exemptions that the Governor made, we may immediately introduce a legislation that would further amend the existing law to make sure that the intent of the legislation is followed. That is why it is critical at this point. Several members of the Legislature in the past have expressed their concern on the exemptions. I think that needs to continue and that this Legislature makes sure that the intent of that legislation is to be followed. Thank you.

<u>Speaker Fitial</u>: I will ask the Clerk to include those in Messages from the Governor in tomorrow's session.

Rep. Benavente: Thank you, Mr. Speaker.

Rep. Jones: Mr. Speaker?

Speaker Fitial: Representative Jones?

Rep. Jones: I agree with Representative Benavente's in put. However, I agree with you also that this information is to namely inform us the action taken by the Governor. However, to change the exemption made by the Governor, I believe it is not within the authority of this Legislature and therefore, for us to dwell into the exemption by the Governor may not have that authority to do so. However, perhaps the appropriate committee may take it up on itself to look into any concerns raise by any member of this House or unless any member would like to raise any concern that a committee should undertake to insure that the referenced is concern should be taken upon the committee. But I am raising this input because I understand that you would like to ensure that we minimize as much as time possible not to deliberate anything other than bills and resolutions that are urgently affecting the CNMI. Thank you, Mr. Speaker.

Speaker Fitial: Let me explain the reason why I ask the Clerk not to include those Messages from the Governor with respect to waivers. Because the concern of Representative Benavente can also be satisfied by just distributing all these messages to the individual members of the House and if any member, since all members have copies of these messages may wish to address any concern they may have on each or every messages from the Governor regarding waivers, they could do so. You don't necessarily have to list them in the Order of Business since all the members already have copies. So, your concern is also satisfied by the fact that all members received copies of all these Messages from the Governor.

Rep. Benavente: If I may make one more point, Mr. Speaker?

Speaker Fitial: Go ahead.

Rep. Benavente: Again, the law that requires that the Governor certify to the Legislature and therefore, I believe that there should be some kind of official communication being sent by the Governor and being received by this Legislature. At the same time, in the past, as we have done is, we have assigned those communications to the committee for the committee's further deliberation. I don't believe that we will then give us by just passing out the certification to the members would automatically have the committee review. I don't see why there is any problem with providing those. As a matter of fact, I think it is important to comply with the existing law that this becomes an official communication of the Governor and the House of Representatives.

<u>Speaker Fitial</u>: So, we will include the messages on waivers from the Governor on next session. Any further deliberation on the Messages from the Governor? If none, let us proceed on to Item 6 under Senate Communications.
