HOUSE OF REPRESENTATIVES TWELFTH NORTHERN MARIANAS COMMONWEALTH LEGISLATURE FIRST REGULAR SESSION, 2000

SECOND DAY

February 15, 2000

The House of Representatives of the Twelfth Northern Marianas Commonwealth Legislature convened in its Second Day, First Regular Session, 2000, on Tuesday, February 15, 2000, at 10:30 a.m. in the House Chamber, Capitol Hill, Commonwealth of the Northern Mariana Islands.

The Honorable Benigno R. Fitial, Speaker of the House, presided.

A moment of silence was observed.

In accordance with Rule XIII, § 2(a) all eighteen member were present.

ADOPTION OF JOURNALS

The Chair recognized the Floor Leader.

<u>Floor Leader Babauta</u>: Thank you, Mr. Speaker. Mr. Speaker, I move for the adoption of the First Day, First Regular Session journal.

The motion was seconded.

Rep. Benavente: Mr. Speaker, I ask that members be allowed to make the necessary typo or grammatical errors that appears on the journal. <u>Floor Leader Babauta</u>: Thank you, Mr. Speaker. Mr. Speaker, I move to omit all pertinent messages from the Governor.

<u>Floor Leader Babauta</u>: The motion is to omit the pertinent messages from the Governor, Mr. Speaker.

<u>Floor Leader Babauta</u>: From the Order of Business, unless members need to discuss on certain messages.

Speaker Fitial: Discussion? Representative Attao?

Rep. Attao: Mr. Speaker, I would like for the Chairman on JGO together with Commerce and Tourism to take a look at Governor's Communication 12-27. And if possible, Mr. Speaker, to report to the full House the findings on these exemptions.

<u>Speaker Fitial</u>: There is a request from Representative Attao requesting the Committees on Commerce and Tourism and Judiciary and Governmental Operations to look into Governor's Communication 12-27 and report their findings. I don't know whether this is germane to the main motion but it would be also of benefit to the House to get to know what is in Governor's Communication 12-27. Representative Peter?

Rep. Peter: Thank you, Mr. Speaker. Before we continue on on all the exemptions on Messages from the Governor, I would like to ask if any of us know whether these messages sent to us are after the approval of the request or prior? Does any of us know whether these messages come here after they are approved? Because I don't think there is any sense discussing these messages if they are already being approved. Thank you, Mr. Speaker.

<u>Speaker Fitial</u>: Can I ask the Floor Leader to effectuate a motion to resolve into the Committee of the Whole so that we can ask our legal counsel to expound on these issues?

Floor Leader Babauta: So move, Mr. Speaker.

The motion was seconded and carried by voice vote.

The House resolved into the Committee of the Whole at 10:43 a.m.

COMMITTEE OF THE WHOLE

The House dissolved into plenary session at 11:10 a.m.

<u>Speaker Fitial</u>: We are still on the motion to omit these Messages from the Governor on waivers, exemptions. Further discussion? Representative Benavente?

Rep. Benavente: Thank you. I guess we've spent few minutes, more than few minutes, to discuss some of the problems we have in regards to the Governor's Communications and in fact, I have already committed two committee's to look into some of the communications or one particular communication. I think, Mr. Speaker, I have no problem with the leadership in trying to limit the contents of the Order of Business and I agree that that should be done. But I still feel that the certification require under P. L. 11-6 for the Governor to inform the Legislature needs to appear on the Agenda for the opportunity of the members to air their concern(s) from some of those communications or certification. I would like to suggest to the Speaker that the leadership inform the Governor that there is certain certification that is not necessary to be submitted to the Legislature and therefore, that would cut down some of these communications. But I still feel that under the existing law where it requires the Governor to certify to the Legislature that those communications appear in the Order of Business during our sessions. Thank you.

<u>Speaker Fitial</u>: Point well-taken. Just to inform the members that our present Rules did not require these types of messages to appear on the Order of Business where the House action is not warranted. But I will take your request to inform the Governor. We are meeting this afternoon with the Governor, at four o'clock, so rest assured Representative Benavente this would be one of the items of discussion this afternoon with the Governor. We are voting on the motion to omit from the Order of Business these messages from the Governor that do not warrant the action of the House.

Rep. Benavente: Clarification on the motion.

<u>Speaker Fitial</u>: The motion is to omit from the Order of Business the messages from the Governor concerning exemptions.

<u>Rep. Benavente</u>: Are we going to omit all of the communications? I heard you say before you made that statement that you would be omitting those that are not necessary. Are we following the original motion, which was made by the Floor Leader that all of the communications be omitted from the Order of Business?

<u>Speaker Fitial</u>: I have it down here that the Floor Leader moved to omit from the Order of Business these messages appearing on Item 5 respecting exemptions.

Rep. Hofschneider: Clarification, Mr. Speaker.

Speaker Fitial: Recognized, Representative Hofschneider.

<u>Rep. Hofschneider</u>: Would that mean, heretofore, forever in the Twelfth Legislature we will not see this kind of communication on the Calendar?

<u>Speaker Fitial</u>: In the Order of Business. But, every communication that we receive from the Governor respecting exemption will be given privilege to all members. Ready? Roll call.
