MISCELLANEOUS BUSINESS

<u>Speaker Fitial</u>: I just want to bring this out, I received a letter from Representative Benavente yesterday, asking me to respond to a letter he received from Chairman Don Young. I have a respond in writing but I just want to share this with you. The questions raised in the letter, concerns the statements which Representative Benavente, as the Speaker of the Eleventh Legislature delivered in front of the Resources Committee Hearing last September, I believe. Representative Benavente is asking me to respond to those inquires, I think fairness, if Representative Benavente would want to have me help him to respond, I would be more than glad to help. But he was the one who made those statements in front of the August Body in Washington, so, I think it is all fair that he respond directly to those inquires. Representative Benavente, you are recognized.

<u>Rep. Benavente</u>: I still believe that the letter from Chairman Don Young is being referred to the Speaker of the House and not necessarily Speaker Diego T. Benavente. And although I made – it refers to my testimony during the last hearing, I still remember that my testimony at the time did not state any specifics about the garment industry and which the questions in the letter from Chairman Don Young, since he point out. And therefore, I do not feel that the letter in any way referring to the statement I made during the last hearing. I think it is merely requesting the present leadership for the information or for those questions to be answered. I also understand that the same question was sent out to all of the individuals who testified in front of the Committee. So, again, that show that Chairman Don Young, I don't believe is intending for me to respond to that question. I think the intent is clearly for the present leadership of the House. But, if you wish or if Chairman Don Young wishes, I will be more than happy to respond to some of those questions that are being asked in the letter. Once again, Speaker Fitial, I truly feel that the letter being address to the Speaker of the House and not necessarily to me. Thank you.

<u>Speaker Fitial</u>: Let me just clarify one thing. I did not testify last September. I was there but I did not testify. And one of the questions asks was, "who helped you prepare your testimony?"

Rep. Benavente: If I may, Mr. Speaker?

Speaker Fitial: Go ahead.

<u>Rep. Benavente</u>: I guess that part we can respond to separately. But I think most of the other questions are very specific, on what the Commonwealth, what the leadership here, or what those individuals who testified has as far as taking some of the concerns that were being raised at the time or the Chairman is raising now in his letter. I noticed that, and I think what happened was that, basically that letter was sent out to every individual that testified, the same thing. And as I have said, my testimony was very limited. It didn't get into any specifics. In fact, Tony and I, basically drafted the testimony that we provided to the Congress, so, no one else help me. That, probably we can just write on simple sentence.

<u>Speaker Fitial</u>: I still feel that the inquiry was address to people who testified before Don Young's Committee. So, those questions, I don't know the exact statement or testimony you presented before the Committee. I do not have a copy of your testimony. But it is very clear to me that all those people who where asked to respond to those questions where those people who testified before the Committee. But, if you still insist that I will answer those questions on your behalf because the letter was addressed to you personally. It did not addressed to me because they know that I did not testify before the Committee.

Rep. Benavente: If I may?

Speaker Fitial: Yes.

<u>Rep. Benavente</u>: Once again, I think the question is referring to what this leadership, I would be presently have plans for with regards to some of the questions being raised and that is why I feel that it should be this leadership than to provide the respond. But, Mr. Speaker, if you feel that that letter should be responded by my self than I'll be more than happy to do that. And may be it is more proper that you respond as well if you wish to state your ideas and your plans or your respond to those specific questions. I can send two letters. If you still feel that I should respond to it, I'll be more than happy to do so.

Speaker Fitial: Thank you. Representative Pangelinan?

<u>Rep. Pangelinan</u>: To set a compromise, Mr. Speaker, if no one of you is willing to respond, I am willing to volunteer to respond to this.

<u>Speaker Fitial</u>: I understand that the letter was written by Don Young directly to former Speaker Benavente asking him to answer few questions which where raised during the hearing last September. And, I was not even part of the Legislature at that time, although I was present at that hearing. I wanted to help because Representative Benavente wishes that I also helped out in responding and I don't have to do, do I have to?

Rep. Hofschneider: Yes, definitely. Is that recognition?

Speaker Fitial: Yes.

<u>Rep. Hofschneider</u>: Mr. Speaker, first of all, is that a previous letter? No? Can we get a copy of that? Is the letter written in a way that it is a follow up questions to those who testified in fact?

Speaker Fitial: Yes.

Rep. Hofschneider: Then don't.

Rep. Benavente: If I may?

Speaker Fitial: Yes.

<u>Rep. Benavente</u>: I think it does have that but it also contains other questions that I guess it is been looked into by the Committee on who is involve with what faction and so that is why the question of who prepared this statement or is being ask? I don't think that that question for example is really going to me or to this Legislature because I thought that was pretty clear that it was our staff who worked on that. But, certainly other individuals who made presentation during the time but not just the government officials, or the private sectors or even the other individuals who appeared before the committee that is what they are trying to get. And so, again, that is why I am saying that that particular question being directed to me as the former Speaker. The other questions, I think should be answered by the present leadership on what their plans or how would they be able to answer some of the questions with regards to the garment industry for example. But again, Mr. Speaker, the questions was addressed to me and I'll be more than happy to respond to the questions.

<u>Speaker Fitial</u>: I think I have a better suggestion, since we now have a new leadership let us just consider that letter mood.

Rep. Attao: Mr. Speaker?

Speaker Fitial: Representative Attao?

<u>Rep. Attao</u>: Can we have a copy of that letter so that we will know what is going on?

Speaker Fitial: I will distribute copies of that letter to all the members. So, let us move on.

Rep. Benavente: May I be recognize under privilege?

Speaker Fitial: Under privilege.

<u>Rep. Benavente</u>: Because you suggested that we should treat the letter as mood, I don't think that that would be a good idea, it would be disrespectful to the Chairman. What I would do is respond to the Chairman informing him that the letter should now be addressed to the new Speaker of the House. Thank you.

Speaker Fitial: Thank you. Announcement? Floor Leader?

Floor Leader Babauta: Before we go to the next Item, can I request for a short recess?

Speaker Fitial: Yes. Short recess.
