<u>Floor Leader Babauta</u>: Thank you, Mr. Speaker. Mr. Speaker, I move for the passage on First and Final Reading House Bill No. 12-46.

The motion was seconded.

H. B. NO. 12-46: TO VACATE SECTION 214 OF EXECUTIVE ORDER 94-3 TO COMBINE THE CIVIL SERVICE COMMISSION WITH THE OFFICE OF PERSONNEL MANAGEMENT; AND FOR OTHER PURPOSES.

Speaker Fitial: Discussion? Representative Apatang?

<u>Rep. Apatang</u>: Thank you, Mr. Speaker. Just for clarification, if this bill passes the House would the Civil Service Commission be overseer of the personnel office and the appointee for personnel officer?

<u>Speaker Fitial</u>: The Committee on Judiciary and Governmental Operations (JGO), Chairman Jones, there is a question imposed by Representative Apatang regarding House Bill No. 12-46.

<u>Rep. Jones</u>: Can the question be repeated if you don't mind colleague?

<u>Rep. Apatang</u>: Thank you. For clarification purpose of this bill, will the Civil Service Commission be overseer of personnel service system and the commission appoints the director of personnel?

<u>Rep. Jones</u>: Yes, and I would like to give the other portion of the response to the author of the bill.

Speaker Fitial: What is the other portion?

<u>Rep. Jones</u>: The other portion is the appointment.

Speaker Fitial: Well, proceed.

<u>Rep. Peter</u>: Thank you, Mr. Speaker. The answer to both his questions are 'yes', they will be appointed as it used to be. Thank you.

Rep. Apatang: Thank you.

Speaker Fitial: Further discussion? Representative Benavente?

<u>Rep. Benavente</u>: Point of order, Mr. Speaker, unless we've amended the Rules, I believe we need to amend the Rule to suspend the requirements for First and Final Reading. Before we act on this bill, I think we need to suspend the provisions of the Rule.

<u>Speaker Fitial</u>: That is correct. That is why I asked if the motion was for First and Final Reading because if it is, then we must suspend the pertinent rule to allow the deliberation of this House Bill on First and Final Reading. Floor Leader recognized.

<u>Floor Leader Babauta</u>: Mr. Speaker, I so move to suspend Rule VII, Sections 9 and 10 for the passage of House Bill No. 12-46 on First and Final Reading.

The motion was seconded and carried by voice vote.

<u>Speaker Fitial</u>: The motion carries. You have to effectuate the motion now because that was only for suspension. So, we need to effectuate a motion for the passage. Floor Leader recognized.

Floor Leader Babauta: So move, Mr. Speaker, for the passage of House Bill No. 12-46.

Speaker Fitial: Discussion?

Rep. Attao: Mr. Speaker, I have question here under discussion.

Speaker Fitial: Discussion on the passage motion?

<u>Rep. Attao</u>: Mr. Speaker, on page 1, "Section 2. <u>Repealer</u>. Section 214 of Executive Order 94-3 is hereby vacated and provisions of law affected by Section 214 is hereby restored", looking at Executive 94-3, Mr. Speaker, there are two sections that call for under Personnel Management and I would like the legal counsel or probably the author to enlighten the members as to whether or not Section 307 of Executive Order 94-3 is affected?

Speaker Fitial: What is Section 307 of the Executive Order?

<u>Rep. Attao</u>: Section 307, Mr. Speaker, part of it is the Department of Finance under the Procurement provision.

Rep. Peter: Mr. Speaker?

Speaker Fitial: Representative Peter?

<u>Rep. Peter</u>: I would like to request that we go into the Committee of the Whole and ask the legal counsel to respond to that question.

There was no objection raised.

The House resolved into the Committee of the Whole at 2:13 p.m.
