INTRODUCTION OF RESOLUTIONS

Speaker Fitial: I would just like to inform you that I received a communication from Representative Benavente, requesting on behalf of the staff that I do not call sessions on weekends and holidays. I just want to inform the members that we have a thirty-day session during the First Regular Session and today's our Tenth Day. If we are to meet in session, only on weekdays the thirty-day session will be over at the end of March, I believe March 29. There is a scheduled meeting with Philippine Airline officials on March 25th. That is already been fixed, March 25th and possibly also with President Joseph Estrada. This meeting is to discuss Philippine Airline's interest in providing direct flights service between Philippine and Saipan, CNMI. Like I said. March 25th will fall on our thirty-day Regular Session so besides looking at the legislations that have already been introduced and are now being reviewed by the Standing Committees, we will be quite very busy beginning next week considering those bills. I know the Committees are working very hard to report these bills out beginning next week. So, it will be very, very tight to accomplish all that we want and all that we need to accomplish during the thirty-day Regular Session if we only meet during weekdays. So, I beg the indulgence of the members to consider meeting on weekends and also holiday's if need be. Representative Benavente?

<u>Rep. Benavente</u>: I guess I now understand why we are trying to hold sessions on weekends. I would like to request though if possible, that maybe we go into the Committee of the Whole and have our legal counsel's assist us in the definition of the thirty-day session as provided in our Rules or in the Constitution because I believe that that does not necessarily mean that we are meeting for thirty straight days. I believe that the provision of the thirty-day session in the Constitution or in the Rules would provide for the authority of members of the Legislature to legally act on matters and I think it tends towards Committee actions. Again, unless I can be proven wrong right away, I hope that maybe we can ask our legal counsel to assist us in this discussion in the Committee of the Whole. Because as I have said and done in the past, if there is an urgent matter for us to discuss on weekends, I am sure that there is no problem with any member here, certainly not a problem with me, but I believe we can entertain major legislations four or five of them in one day if the Committee provide that and not necessarily have sessions or meetings everyday. So, may I request a comment from the legal counsel on the definition of the thirty-days?

Speaker Fitial: If there is no objection -

Floor Leader Babauta: So move, Mr. Speaker, there is no objection.

There was no objection raised.

The House resolved into the Committee of the Whole at 10:34 a.m.
