<u>Chairman Palacios</u>: I think you should announce that March 16 is the arrival of Japanese Diet. I think we should have the meeting today.

<u>Speaker Fitial</u>: Let me just say this, a member of the Japanese Parliament, Mr. Takahashi will be arriving on the 16th of this month. This is in response to the Resolution, which we adopted about a week or two weeks ago and we will be discussing business opportunities in the Commonwealth for Japanese business people. So, like I mentioned yesterday, we will be hosting a reception for these dignitaries when they arrive on the 16th. I would like to create an Ad Hoc Committee to

look into this particular visit by the dignitaries. Among the people arriving is the Chairman of the Japan Entrepreneurial and Presidents Association (JEPA) this is an association of more than 15,000 business people from Japan and the Chairman will be arriving with the Japanese Law Maker on the 16th. So, I would like to create an Ad Hoc Committee to be responsible for the preparation of our reception on the 16th when they arrive. So, I would like to appoint maybe three members only because too many not be comfort. So, Chairman Palacios, you will be Chairing the Ad Hoc Committee since you are the Chairman of Federal and Foreign Affairs and besides your Resolution was the subject of the visit. So, you select your own members to this Ad Hoc Committee please include also the other side of the Chamber. No further Announcement? Representative Ichihara?

<u>Chairwoman Ichihara</u>: I would like to announce that the Education Committee will be meeting on Tuesday at 8:00 a.m. and Health and Welfare at 1:30 p.m., Tuesday.

Speaker Fitial: Representative Apatang?

<u>Rep. Apatang</u>: Just for a clarification, are we working with the Administration with regards to the coordination of this Japanese Officials coming over?

Speaker Fitial: Yes, we are working with the Governor's Office, the MVA and HANMI.

Rep. Apatang: Thank you.

Speaker Fitial: Representative Attao?

Rep. Attao: Mr. Speaker, I know the Chairman of the respective Committee's are very busy now a days. However, Mr. Speaker, I would like to ask if at all possible to expedite solicitation on the Bills that I introduced, I think there were about ten Bills that are very, very in need of for the House to at least debate on the Bill so that we can act on it, if that is not a burden to each respective Committee, I ask for your cooperation on my Bills.

<u>Speaker Fitial</u>: I believe the Committees, as you have indicated, are working very, very hard. And I know that one Chairman is not too happy today because he's better have complaining why also Saturday you have to go through – and like you said, they are really very busy. They are working very hard and they will be producing a lot of Committee Reports from now on.

Rep. Attao: In line with that, Mr. Speaker, I will be more than happy to at least receive a cc copy on all solicitation for comments so that I will know what is the status of the Bills I introduced so that if somebody calls me up, I have all the information readily available.

<u>Speaker Fitial</u>: The best way to address your concern is to visit each Committee Chair because they have already sent out a lot of requests for public comments.

Rep. Attao: Thank you.

Speaker Fitial: No further Announcement? Floor Leader?

Floor Leader Babauta: Mr. Speaker, I move to recess until Monday at 11:00 in the morning.
