Speaker Fitial: I think your suggesting that we call a session in Tinian at 2:00 p.m. on Monday. I just want to announce that there's a letter from the Chairman Don Young writing to the Speaker and his team – to visit Washington, D. C., in April after the adjournment of the First Regular Session. I would like to inform you that I would like to get the final list of the delegation going to Washington as soon as possible so I can send it to Chairman Don Young. As most of you already know - we will be meeting with the Senators and the Congressmen to discuss this federal takeover legislation and I have some information regarding the minimum wage. The U.S. Congress is concentrating on passing amendments here, this session. There are two minimum wage Bills, one is being sponsored by Democrats and one from the Republicans. The one by the Republicans includes the tax break incentives for retailers, small businesses. The one by the Democrat, they may sneak in the CNMI provision to extend the applicability of that omnibus Bill if passed by the CNMI. So, I just want to share that information with all of you. Representative Peter has a copy of that information. I will be monitoring the progress of these legislations and I will continue to share this information with you because we need to do something not only important, but very serious for our economic welfare. So, I believe we will be meeting with Chairman Don Young and some of the Congressional leadership with this visit to Washington, D. C., early next month. With that, I recognize the Floor Leader for the recess motion.

<u>Floor Leader Babauta</u>: Mr. Speaker, just before I move for recess, I just like to advise the members that the Senate met and passed two House Bills without amendments and it will go back to the House for your transmittal. Just for information.

Speaker Fitial: Anymore deliberation before we recess? Floor Leader?

<u>Floor Leader Babauta</u>: Mr. Speaker, I move to recess until tomorrow at 10:00 a.m. same venue.
