The House reconvened at 2:07 p.m.

<u>Speaker Fitial</u>: We are back to the plenary session. Floor Leader?

<u>Floor Leader Babauta</u>: Mr. Speaker, thank you. Mr. Speaker, I move for the adoption of House Joint Resolution No. 12-6.

<u>Speaker Fitial</u>: Can we have a suspension motion first, Floor Leader? We need to suspend the Rule to place it on the Calendar.

Floor Leader Babauta: 12-32, Mr. Speaker?

Speaker Fitial: Yes.

<u>Floor Leader Babauta</u>: Mr. Speaker, I withdraw my original motion and reinstate my motion to suspension Rule VII, Section 9 for the placement of House Resolution No. 12-32.

Speaker Fitial: Rule VII, Section 9 is the committee report requirement so it is in order since we don't have any committee report. Since we are placing this Resolution on

today's Calendar without a committee report then it is in order that we suspend the committee report requirement. So, can we just say that that motion is to suspend the committee report so we can place this without the committee report? Any discussion on that suspension motion?

There was no discussion raised. The motion to Suspend Rule VII, Section 9 to place House Resolution No. 12-32 the today's Calendar without a committee report was carried by voice vote.

<u>Speaker Fitial</u>: The motion carries. Now, we need the suspension motion to act on it – actually we don't need such a motion because we already decided unanimous consent that we place this on today's Resolution Calendar. Floor Leader?

<u>Floor Leader Babauta</u>: Thank you, Mr. Speaker. Mr. Speaker, I move for the adoption of House Joint Resolution No. 12-6.

The motion was seconded.

Speaker Fitial: House Joint Resolution No. 12-6 is adopted. Floor Leader?

<u>Floor Leader Babauta</u>: Mr. Speaker, thank you. I move for the adoption of House Resolution Nos. 12-23, 12-25 and 12-32.

The motion was seconded.

Speaker Fitial: House Resolution Nos. 12-23, 12-25, and 12-32 are adopted.

BILL CALENDAR

The Chair recognized the Floor Leader.

<u>Floor Leader Babauta</u>: Mr. Speaker, thank you. I move for the suspension of Rule IX, Sections 9 and 10 for the passage of House Bill No. 12-116, House Draft 1.

The motion was seconded.

Speaker Fitial: Discussion? Representative Attao?

Rep. Attao: May I ask the Floor Leader to make a motion to suspend Rule IX, Section 11 for an Amendment on this same Bill?

Speaker Fitial: Floor Leader?

<u>Floor Leader Babauta</u>: Unless the Chair allows, Mr. Speaker, to amend as a subsidiary motion that would include suspension of Rule IX, Section 11.

<u>Speaker Fitial</u>: Can we go ahead and dispose of the suspension motion to allow this Bill to be acted upon on First and Final Reading first? The motion offered by the Floor Leader was to suspend Rule IX, Sections 9 and 10 for House Bill No. 12-116, House Draft 1, to be passed on First and Final Reading. It is just a suspension motion. So, can we dispose of that and then we suspend the motion to allow you to offer your amendment? Further discussion on the suspension motion? None?

The motion to suspend Rule IX, Sections 9 and 10 for the passage on First and Final Reading House Bill No. 12-116, House Draft 1, was carried by voice vote.

<u>Speaker Fitial</u>: The motion carries. We are now going to entertain the motion for the passage. Floor Leader?

<u>Floor Leader Babauta</u>: Mr. Speaker, before I entertain a motion for the passage, I wish to move to suspend Rule IX, Section 11 for pertinent amendments to be incorporated before the passage occurs, Mr. Speaker.

<u>Speaker Fitial</u>: You can do that or either we go that route, or just move for the passage and than we can offer amendments –

Rep. Hofschneider: I think we are out of order. I think we need to move for the passage then discussion and then a motion for an oral floor amendment.

Speaker Fitial: Okay. Let us effectuate a passage motion first, Floor Leader.

<u>Floor Leader Babauta</u>: Mr. Speaker, I recall my original motion and move for the passage on First and Final Reading, House Bill No. 12-116, House Draft 1.

The motion was seconded.

H. B. NO. 12-116, H. D. 1: A BILL FOR AN ACT TO REPEAL AND REENACT SECTION 6(c)(4) OF PUBLIC LAW 11-79; AND FOR OTHER PURPOSES.

Speaker Fitial: Discussion? Representative Attao?

<u>Rep. Attao</u>: If there is no objection, Mr. Speaker, I would like to make a motion for the suspension of Rule IX, Section 11 so that my oral amendment can be incorporated into House Bill No. 12-116, House Draft 1.

The motion was seconded.

Speaker Fitial: Discussion?

There was a division on the floor during the voice vote on the motion to suspend Rule IX, Section 11, for Representative Attao to make an oral amendment.

<u>Speaker Fitial</u>: Can we vote by just raising hands? We don't need to roll call. So, all those in favor of the motion to suspend Rule IX, Section 11 to allow the oral amendment to be considered raise your hand. Seven raised their hands.

Rep. Attao: Mr. Speaker, let me clarify my amendment here. This particular Bill does not address anything with respect to the expenditure authority. Public Law 11-78, due to technical deficiencies, all the expenditure authorities were deleted and Public Law 11-79 did not address the expenditure authority. My amendment is to avoid delay on the project, incorporate the expenditure authority so that the provision will allow CUC and DPW to expend the \$2 million as called for in the Bill. It is not that I am going to take

One Million Dollars out of the Two Million Dollars. This is just to give authority to the respective department who has that particular project within their department. That is my amendment.

Speaker Fitial: Chairman Tony Camacho?

Rep. A. Camacho: Mr. Speaker, the amendment is only to move the amount of one construction project in Tanapag going to As Matuis –

<u>Speaker Fitial</u>: Let us not discuss the amendment because the motion is for the passage. We haven't –

Rep. A. Camacho: That is why we are voting "no" on the amendment because –

Rep. Attao: Mr. Speaker, let me just make myself very clear. Public Law 11-78 superceded by Public Law 11-79 because of technical deficiencies. And Public Law 11-78, the expended authority for CUC was line item vetoed that is why I am trying to revive the expenditure authority under Public Law 11-78 to be part of House Bill No. 12-116. Because even if we pass this and the Senate passes it, the Governor signs it, nobody can spend the \$2 million, that is why it is very important to put the expenditure authority.

Rep. A. Camacho: Public Law 11-79 did that.

Rep. Attao: No. Public Law 11-79 reference to Public Law 11-78, but in this case, CUC was line item vetoed. It was not incorporated in Public Law 11-79. So, what I am doing is reinstating the expenditure authority so that CUC and DPW can spend the fund that we are passing.

Rep. A. Camacho: So, no comments, Mr. Speaker. Too positive is better than none.

Rep. Jones: Point of information, Mr. Speaker.

Speaker Fitial: State your point of information.

Rep. Jones: Representative Attao, what was the reason for deleting CUC from the expenditure authority?

Rep. Attao: There were some technical deficiencies under Public Law 11-78.

Rep. Jones: And what was that?

<u>Rep. Attao</u>: So, Public Law 11-79 reflect all Public Law 11-78 with the exception of CUC under the expenditure authority, it was line item vetoed.

Rep. Jones: What was the technical matter there?

Rep. Attao: That is the CIP under Public Law 11-78 so as Public Law 11-79.

Rep. Benavente: Mr. Speaker, short recess, so we can talk to our counsel about the -

Speaker Fitial: Short recess.

The House recessed at 2:18 p.m.

RECESS

The House reconvened at 2:29 p.m.

<u>Speaker Fitial</u>: We are back to the plenary session. We are still on the passage motion. Further discussion? Representative Attao?

<u>Rep. Attao</u>: Mr. Speaker, during our recess it was agreed that the amendment is to be offered by the Chairman on Ways and Means Committee, Representative Tony Camacho.

Speaker Fitial: Recognized.

Rep. A. Camacho: Mr. Speaker, I have a Floor Amendment to assist the author of the original Bill, to renumber "Section 2" and put a new "Section 2. To amend Section 7 (d) of Public Law 11-79 to replace "Tanapag" with "As Matuis"; and the first "Section 2" becomes "Section 3", and "Section 3" becomes "Section 4", and "Section 4" becomes Section 5"

The motion was seconded.

<u>Speaker Fitial</u>: Can we go back because we did not complete the process? We should effectuate a suspension motion to allow the oral amendment.

Rep. A. Camacho: I have a written amendment.

Speaker Fitial: Okay.

Rep. Benavente: Point of order, Mr. Speaker.

Speaker Fitial: State your point of order.

<u>Rep. Benavente</u>: I think before we call the recess, we were debating on the need to support the suspension of the Rules. I think you are right to dispose of the motion to suspend the Rules offered by Representative Attao. Ready.

Speaker Fitial: So, I am going to call the vote again for the suspension motion to allow the oral amendment

Rep. Hofschneider: Pont of order, Mr. Speaker. I think we are in order if the mover of the motion recalls the motion.

Speaker Fitial: We need to make copies short recess again for copies.

The House recessed at 2:30 p.m.

RECESS

The House reconvened at 2:33 p.m.

<u>Speaker Fitial</u>: We are back to the plenary session. We have an amendment to be offered -- I believe we did not dispose of that motion. Can you restate your amendment?

Rep. A. Camacho: Mr. Speaker, I move to offer an Amendment to add a new "Section 2" and that Section 2 reads, "To amend Section 7 (b) of Public Law 11-79 to replace "Tanapag" with "As Matuis"; and the old "Section 2" becomes "Section 3"; and "Section 3" becomes "Section 4"; and "Section 4" becomes "Section 5."

There was no discussion raised. The motion to adopt the Floor Amendment offered by Representative Antonio Camacho was carried by voice vote.

<u>Speaker Fitial</u>: The motion carries. We have now the main motion for the passage of House Bill No. 12-116, House Draft 2. Further discussion? Roll call.

<u>Speaker Fitial</u>: House Bill No. 12-116, House Draft 2, passes the House on First and Final Reading.

MISCELLANEOUS BUSINESS

The Chair recognized Rep. Peter.

Chairwoman Peter: Thank you, Mr. Speaker. On February 29, the Committee on Health and Welfare held their public hearing on some Bills, including the Bill increasing the age to purchase tobacco. During that hearing we heard from Commonwealth Health Center witnesses about the tobacco settlement. The Chair then requested the Secretary to provide the Committee with information, documentations on the tobacco settlement. Mr. Speaker, we have yet to receive and in today's newspaper, on the front page, the Secretary mentioned here that he is working closely with the Legislature on the legislation that will help fund or request for \$8 million funding. I wonder who he is working with? Is it the local Legislature or the U.S. Legislature, somewhere? If the Secretary is working with the local Legislature, I would like to know who from the Legislature he is working with?

Speaker Fitial: No debate.

<u>Rep. Hofschneider</u>: No debate. Mr. Speaker, I have been keeping track of the settlement and a legislation is forthcoming on establishing the need at stalk to establish that particular settlement amount for the purposes stipulated in the Federal Act.

Speaker Fitial: Further Miscellaneous? Representative Pangelinan?

Rep. Pangelinan: Mr. Speaker, this concerns my House Bill No. 12-65, "The Scuba Diving Act". The Marianas Variety, today, on page 5, reported, Mr. Speaker and my colleagues, that tourism officials said, "Collection of fees and issuance of permits are inappropriate as this would only impose additional cost to tourist who only stayed in the CNMI for a couple of days." Mr. Speaker and my colleagues, no one in this Chamber is questioning the need to improve our tourism industry. It is the pipeline of life to our economy, it is just like the oxygen that flow to the regulator, to a scuba diver, a source of life. In my mind, it is a challenge to establish balance in role between tourism and our delicate marine life out there in our water. One must always remember that once our marine wildlife is left without major protection, major tourism will definitely decline heavily. Everyday, our marine environment is being damaged by pollution, such as that nightmare at Puerto Rico dump, oil spill, too many sea crafts, over fishing, and unrestricted, unlimited diving activities. From Grotto, Nikko, Plumeria, Aqua, Tanapag, all the way to PIC, to Obyan and Laulau Bay area, no matter how careful a diver is in the water this single activity will somewhat disturb our marine environments, step on the corals, breaks sea weeds, scare the fish away, yet, we take for granted that daily damages these water sports activities have in our sensitive marine environment, yet, every year, millions of dollars are invested in promoting tourism, which I am totally in support of. The question I would like to ask is, how much funding have been appropriated to protect our marine environment? How much funding have been provided to study the heavily harm or damage environment by our pollution cause by our negligent, or/and our total support inability to protect our own fragile marine environment? The intention of my Bill, House Bill No. 12-65, is to charge a fee of only \$10.00 per year, 365 days a year and you can dive as many dives as you can in this given time period. The purpose of this minute fee, is for the Division of Fish and Wildlife to use that collected revenue for research, conducting studies of the status of our marine environment, restoration, restoring the wealth of our marine environment that were either damaged or destroyed, improvement of marine lives sanctuaries and that we have failed in some degree. A man is the number one enemy of his own environment, but a man is the only one that can save it. We have ignored for many years the critical need to be environmental conscientious individuals. We must know, and we should be, for the best interest of our people, our children, our children's children, and for the tourism industry. Let me remind each of you that one of the key elements of the Speaker's vision progress for the entire CNMI, one of the four E's, it's the Environment. If we do not initiate a legislation mandating the protection and conservation of our wildlife and their habitats, and our marine environment, then kiss tourism good-bye. The land and the sea in the Commonwealth is rightfully ours, it belongs to our people. If we do not protect and conserve its resources, who will? One of the most commonly heard saying that, it is better to try and fail than to fail to try. Thank you.

Speaker Fitial: Further deliberation under Miscellaneous? None.

<u>Speaker Fitial</u>: Further Announcement? I would like to ask Chairman Norman Palacios—do you have anything to announce? I think your Committee met this morning, the Ad Hoc Committee, do you wish to share with the members what you talked about?

<u>Chairman Palacios</u>: We just undergo title meeting for preparation for March 16 - I'll probably give you guys a short report later. But it is still on going.

Speaker Fitial: I would like to announce that I met with the Governor this morning and one of our concerns that was raised and discussed was the very same concern that Representative Pangelinan expounded on earlier. That is true. Our environment needs tender loving care. We are going to ban, we are going to come up with a plan, a legislation or whatever measure is needed expediently to ban the importation of all detergents that has phosphate contents. I know these are very cheap detergents, but in the long run they will ruin all the marine lives that we have in our waters. As you may know U.S. EPA ban phosphate content detergents in the United States. I don't know why the CNMI can't do the same to protect the marine lives. It is very serious because a lot of these detergents come in from somewhere else other than the United States and they come in because they are very cheap. So, for your information, I am going to be meeting with the ex-EPA person at four o'clock today to further discuss this very serious problem. The Governor may invoke his authority and issue an Executive Order or we may come up with a legislation banning phosphate content detergent. So, which ever is quicker the better. Floor Leader?

Floor Leader Babauta: Under Announcement, Mr. Speaker?

Speaker Fitial: Yes.

<u>Floor Leader Babauta</u>: Mr. Speaker, I would like to announce that we recess until 1:30 tomorrow afternoon.
