REPORTS OF STANDING COMMITTEES

<u>Speaker Fitial</u>: I see a standing committee report just distributed to the members. Floor Leader, do you wish to effectuate any motion to consider this standing committee report in today's Order of Business.

<u>Floor Leader Babauta</u>: Mr. Speaker, if there is no objection, can we go back to Item 6 of the Agenda.

Speaker Fitial: Item 6, Senate Communications?

Floor Leader Babauta: Yes, Mr. Speaker.

Speaker Fitial: What are you going to do with that?

<u>Floor Leader Babauta</u>: Mr. Speaker, I just want to ask the Speaker to transmit Senate Communication 12-18 to the proper standing committee of the House for immediate action regarding Senate Bill No. 12-36.

Speaker Fitial: Okay.

SENATES COMMUNICATIONS

<u>Speaker Fitial</u>: Senate Communication 12-18 is assigned to the Committee on Health and Welfare.

Rep. Attao: Privilege, Mr. Speaker.

Rep. Hofschneider: Point of order, Mr. Speaker.

Speaker Fitial: State your point of order.

Rep. Hofschneider: I believe that we have to accept the communication to be properly in order of conducting business. I think we have to accept the communication for the House has it in the proper —

<u>Speaker Fitial</u>: What happens if we do not accept?

Rep. Hofschneider: Then limbo, it is still in the Senate.

Rep. Benavente: Clarification.

Rep. A. Camacho: Short recess, Mr. Speaker.

Speaker Fitial: Representative Benavente, state your clarification.

Rep. Benavente: I am not sure, but it might be in the House Rules that requires that in order for the House to act, it shall be accepted for the purpose of the Bill being a property of the House. Without that, I believe that it is not yet a property of the House. It requires the acceptance of the House. Again, I am not sure, but it might be in the Rules.

<u>Speaker Fitial</u>: Well, if that is the Rule that we have to accept something that we have then I think that Rule is redundant. How did it make it to the Order of Business in the first place?

Rep. Benavente: Further clarification.

Rep. Hofschneider: May I?

<u>Speaker Fitial</u>: Because when we receive communications from the Governor, we do not necessarily act on a motion to act on them.

Rep. Hofschneider: May I?

Speaker Fitial: Proceed.

Rep. Hofschneider: Except, Mr. Speaker, that two houses with their properties belonging to each respective house, for one house to act on the property of the other house, we must have a rule of conduct of accepting properties that belongs to the other house. In Mason's and Roberts Rules of Parliamentary each house must accept the other's property then it belongs to that particular house. The fact that they communicated does not make it a property of the house.

<u>Speaker Fitial</u>: The Rules does not specifically state that we should accept communications from the Senate, but it does require that it be referred to a Committee. So, I am still in order. So, Senate Communication 12-18 is assigned to the Committee on Health and Welfare.

Speaker Fitial: The House shall reconvene.

BILL CALENDAR

The Chair recognized the Floor Leader.

<u>Floor Leader Babauta</u>: Mr. Speaker, thank you. Mr. Speaker, I move to suspend Rule IX, Sections 9 and 10 for the passage of House Bill No. 12-108 on First and Final Reading.

The motion was seconded and carried by voice vote.

<u>Speaker Fitial</u>: House Bill No. 12-108 is now under the Bill Calendar for passage on First and Final Reading. Floor Leader, recognize for the passage motion.

<u>Floor Leader Babauta</u>: Mr. Speaker, I now move for the passage on First and Final Reading House Bill No. 12-108.

The motion was seconded.

H. B. NO. 12-108: A BILL FOR AN ACT TO ESTABLISH POLICIES AND PROCEDURES FOR THE PRESENTATION AND ADOPTION OF AGREEMENTS AND PROCEEDINGS RESULTING FROM FORMAL CONSULTATIONS UNDER SECTION 902 OF THE COVENANT, ENTERED INTO BETWEEN THE SPECIAL REPRESENTATIVES OF THE CNMI GOVERNOR AND THE U. S. PRESIDENT; AND FOR OTHER PURPOSES.

Speaker Fitial: Discussion? Representative Jones?

Rep. Jones: Thank you, Mr. Speaker. I would like to make an amendment on the Bill.

Speaker Fitial: Do you have a written amendment?

Rep. Jones: No. Can I make an oral floor amendment?

Floor Leader Babauta: Mr. Speaker?

Speaker Fitial: Floor Leader, for the suspension motion.

<u>Floor Leader Babauta</u>: Mr. Speaker, I move to suspend Rule IX, Section 11 for oral amendment to be offered by Representative Jones.

The motion was seconded and carried by voice vote.

<u>Speaker Fitial</u>: The motion carries. Representative Jones, you may offer your oral amendment.

Rep. Jones: Under "Section 2. Findings.", the last word on that sentence which is "the" after "Covenant," should be deleted and all the way to line 3, "Governor and the President are authorized to Section 902 of the Covenant" should be deleted. So, it will read, "The Legislature finds that, pursuant to Section 902 of the Covenant, the Governor and the President..." should follow and thereafter.

Floor Leader Babauta: Second.

Rep. Attao: Point of information.

<u>Speaker Fitial</u>: It is moved and seconded that we accept the amendment offered by Representative Jones. Discussion? Representative Attao, recognized.

<u>Rep. Attao</u>: The amendment offered by Representative Jones is also included in the last paragraph of the Committee Report. In actuality, we don't need to amend the Bill, it is already taken care in the Committee Report.

Rep. Jones: Mr. Speaker, may I?

<u>Speaker Fitial</u>: The Committee Report did address the concern of Representative Jones's amendment, however, if you were to follow the Committee Report it will remove also certain words that are not intended in Representative Jones' amendment.

Rep. Jones: That is correct.

<u>Speaker Fitial</u>: So, for safety, I think we better follow Representative Jones' amendment. Further discussion on the amendment?

The motion to adopt the oral floor amendment offered by Representative Jones on House Bill No. 12-108 was carried by voice vote.

<u>Speaker Fitial</u>: The motion carries. We are now discussing the passage motion on First and Final Reading, House Bill No. 12-108, House Draft 1.

Rep. Benavente: Discussion.

<u>Speaker Fitial</u>: Further deliberation? Representative Benavente?

Rep. Benavente: Thank you. Before we vote on House Bill No. 12-108, I would like to say a few concerns, Mr. Speaker, and one of them is the possibility that the Legislature in this case might be interfering with the duties and responsibilities as provided by the

Constitution to the Executive Branch. I would certainly agree with the intent of requiring that the Administration or the Governor, or the Representative of the Governor in the 902 Talks report to the Legislature. But, we should not require that any agreement made, especially agreements that does not need legislative approval pursuant to the Constitution, that the Legislature be involve in accepting the agreements being proposed by the Administration. Again, my concern is only that we might be over stepping the constitutional provision, which guarantees the Administration, the Executive Branch of this government certain authority. I guess interfering with the separation of power. But again, I am in support and sure that there is no problem with requiring legislative approval on changes of existing statutes or policy. But that is not all that has in the past being proposed or being agreed to by the 902 Talks. I raise that a concern to the members. Thank you.

Rep. Jones: Mr. Speaker?

Speaker Fitial: That is very interesting. Representative Jones?

Rep. Jones: I would like to agree with the previous Speaker when it comes to laws within the CNMI, but when it comes to the Covenant, so-called, the treaty between the CNMI and the United State Government, or for that matter, any other government, the CNMI negotiated. Since we are also an elected leaders of the Legislature, and since this matter pertain to the people of the Commonwealth as a whole, it is the important that the legislation must be part of the process to ensure that we agreed and consent to the agreement. Even the United States Congress when there is an agreement between it and other nations the U. S. Congress is part of that process. The reason what prompted me to introduce this Bill is because of the matching fund agreement that was entered between the Governor and Stella Guerra, the Representative for the United States at that time. There was no consent as a whole by the Legislature on that agreement and we are now suffering because the fund, Covenant, that we are entitled because something that we have to accept and now we are suffering because we have to match our own money. The Representatives of the Legislature at that time when the funding was negotiated and agreed was only the Presiding Officers, but it did not go to the proper legislative process where the Legislature as a whole deliberated. There was no public hearing for that matter. Again, as I indicated earlier, since this is the Covenant and it affects and will affect the livelihood of the people as a whole in the Commonwealth. It is important that the Legislature must be part of that process. Therefore, the Eleventh Legislature passed this Bill. The only problem is that the Senate did not act on it. Thank you, Mr. Speaker.

Speaker Fitial: Representative Tom Pangelinan?

Rep. Pangelinan: My concern here is if it's an agreement already signed by the Governor and other agency, other body, the word "agreement" it must be mutually consented. Then, it empowers the Legislature after the fact to reject it, or accept it. Can you see something missing here? So, can we call that negotiation, something else besides an agreement? Because in my definition, agreement is something that is mutually consented by both parties then it goes down, after thirty days, it will come to the Legislature for use

to accept it or reject it. There is something missing in the whole process. Maybe we can reword it to say that it should be presented to the Legislature for acceptance or rejection before an agreement is ever reached, or a proposed.

<u>Speaker Fitial</u>: Well, this bill would do exactly that. It would allow the Legislature to review any propose agreement before they can be mutually accepted or duly executed.

Rep. Hofschneider: Clarification.

Speaker Fitial: State your point of clarification.

Rep. Hofschneider: This legislation does not purport to do that it is exactly on page 2, line 9 after the word "entirely" it states, "the negotiated agreements," it is already consummate.

Chairman A. Camacho: Mr. Speaker?

Speaker Fitial: Representative Tony Camacho?

<u>Chairman A. Camacho</u>: Thank you, Mr. Speaker. The purpose of this Bill according to my readings, the Legislature is mandated to ratify or not to ratify the negotiation. This is the Bill that would give us the vehicle to set straight what the Governor or the representative and the President's Representative agreed upon and under the condition that the Legislature has to ratify that's my reading on this Bill. If we don't ratify, that means their negotiation is null and void. There is no negotiation.

<u>Speaker Fitial</u>: Well, that is a better reading. Can we hear a legal reading?

Rep. Benavente: Can we have a short recess for that?

Speaker Fitial: Short recess.

The House recessed at 2:25 p.m.

RECESS

The House reconvened at 2:40 p.m.

<u>Speaker Fitial</u>: Back to the plenary session. We are still discussing the main motion, that is, to pass House Bill No. 12-108, House Draft 1, on First and Final Reading. Floor Leader, recognize.

<u>Floor Leader Babauta</u>: Mr. Speaker, clarification while we were in recess, is it for deferment?

Speaker Fitial: Yes, for clean up.

<u>Floor Leader Babauta</u>: Mr. Speaker, with the request of the members, I move to defer House Bill No. 12-108, House Draft 1, and refer it back to Committee on Federal and Foreign Relations for clean up.

The motion was seconded and carried by voice vote.

Speaker Fitial: House Bill No. 12-108, House Draft 1, is referred to the laundry.

MISCELLANEOUS BUSINESS

The Chair recognized Rep. Attao.

Rep. Attao: Thank you, Mr. Speaker. Mr. Speaker, I just want the record to reflect that I received a tally support relative to our projects in Precinct III and for the benefit of the Representatives from Precinct III. I am proud to report and share with you, Mr. Speaker, and members of the Twelfth Northern Marianas Commonwealth Legislature the progress submitted by, Mr. Timothy P. Villagomez, CUC Director, project by project if I may be allowed, Mr. Speaker, so that each and everyone will know what is going on?

Speaker Fitial: Please.

Rep. Hofschneider: Just submit, Mr. Speaker.

Speaker Fitial: Continue, continue --

Rep. Attao: Thank you, Mr. Speaker, and thank you, Representative Hofschneider. Project No. 1, Mr. Speaker, China Town sewer project. This project will provide services to the populated area which experiencing rapid growth. This project will allow resident and businesses to abundant the use of septic tank. Funding on this project, Mr. Speaker, CIP, Public Law 11-79, totaling to \$1,720,000 – status A & E Design per this project has been selected – after issuance of notice of proceed any design completion date is eleven weeks – A & E contract is been routed for signature approval. This is the Middle Road sewer project this project will extend sewer service from East-West Rental south to San Jose intersection, this is the traffic lights at San Jose. Funding for this – CIP Fiscal Year 1994, Public Law 10-40 -- \$874,329 - status A & E Design contract has been awarded. Design has submitted preliminary design layout for the area. Any award is considered 50% completed. Project No. 3, this is for the Lower Navy Hill expansion and upgrade various pump station. Funding, EPA Construction grant \$776,954 Fiscal Year 1998. A & E design for this project has been completed; award for construction is pending final evaluation from respective contractor. Project No. 4, this is the Beach Road project. Funding for this project is coming from EPA Construction Grant \$2,839,443 under Fiscal Year 1996 Funds. The anticipated completion date for the Beach Road project is July 2000. The project is considered 77% completed, Mr. Speaker, right behind Tomokane's residence as well as the old Japanese Jail will be incorporated and also will be completed July, 2000. Project No. 5, connection transmission line Beach Road, San Antonio to Garapan – upgrade and expansion of existing system. This project will rehabilitate existing transmission line as well as pump station, which service the most populated and developed area of Saipan. Funding, CIP Fiscal Year 1994 Public Law 9-24, \$5,600,000. The CUC is in the process of awarding contract for any design work to another prospective engineering firm after the previously hired firm defaulted. Any design work will take approximately 180 days, thereafter construction for the system will follow. Mr. Speaker, the next report will be coming from DPW, and this relates to the drainage, road improvements, traffic lights, road bumps and so forth, public facilities.

Speaker Fitial: What is the percentage of completion for Project No. 5?

Rep. Attao: I don't have the percentage here, Mr. Speaker.

Speaker Fitial: I understand you said A & E –

Rep. Attao: This morning, Mr. Speaker, I called CUC to provide me with the information as to how much was spent on the first A & E plan and also the percentage, but in this report it did not include the percentage completion. So, I'll be reporting that upon receipt of the information from CUC.

Speaker Fitial: This morning at seven o'clock, Representative Apatang, Floor Leader Babauta and I, met with CUC and specifically discussed this particular project, Project No. 5, from San Antonio to Garapan, which is estimated to cost more than \$5,000,000. They awarded A & E contract of \$600,000 to the firm that you mentioned that just defaulted, in limbo because Interior does not want to release the remaining amount because they wanted CUC to collect the money from the defaulted A & E firm so that they continue with the project. I know they have already awarded the design to another A & E firm, but the project fund is in abeyance in other words, Interior will not release until A & E money is collected from the defaulted A & E firm.

<u>Rep. Attao</u>: That is the report that CUC submitted to me. I question the Project No. 5 here, Mr. Speaker, the \$5.6 because of the first defaulted firm, I want to know how much was paid to the –

Speaker Fitial: They paid \$600,000.

Rep. Attao: And also this percentage completion on this as far as the A & E that particular information was not included in this report. However, I'll be calling CUC to get the information so that probably report it out to the members so that they will know what is going on. I'm sorry, Mr. Speaker, that is news to me, hearing the information right now. It is not part of the report but thank you for bringing that up.

<u>Speaker Fitial</u>: We met with CUC seven o'clock this morning. Further Miscellaneous? Representative Peter?

<u>Chairwoman Peter</u>: Thank you, Mr. Speaker. This afternoon during lunch the Representatives went and joined in with a group of people that have been getting involved with the Wa Kai Nekko Nakkai group of students coming from Japan. I would like to let you and the rest of the members be aware that they are forming a local committee, MVA, Mayor's Office, the schools, and some community members to try and do our best in meeting these students and also seeing them off. What I would like to say here is that they will be coming to us for assistance before these students arrive on May 8 and departing on May 9. So, I am asking for everyone's generosity and participation if and when this event comes up. Thank you.

Speaker Fitial: Representative Pangelinan?

Rep. Pangelinan: Thank you, Mr. Speaker. To me, this is very important, but this time it is under Miscellaneous Business, Mr. Speaker, and my colleagues, I would like to go on record recognizing the timely and courageous moves by Mr. Peter Barlas, the Acting Director of CRM, for suspending the issuance of permit for water sports craft to prevent further damages of our beautiful Saipan lagoon. It is high time to call a time off from these activities to study how much destructions have been done and to stand some restoration strategies to those areas that have been damaged or heavily destroyed. My hats off to Mr. Peter Barlas. Thank you, Mr. Speaker.

Speaker Fitial: Further Miscellaneous? None.

ANNOUNCEMENTS

The Chair recognized Rep. Palacios.

<u>Chairman Palacios</u>: I have the Japan-Northern Marianas Parliamentary League of Friendship and it goes to the Honorable Tokyo Yamasita, President, and Mr. Chisoni Shizumuzi, Chairman of JEPA, itinerary and events, I will be passing now. I'll be passing it to the left side – stand by.

Speaker Fitial: Do you care to announce what is happening tomorrow?

Chairman Palacios: Okay, I'll go down the line. Excuse me, I think I'm short of three – On March 16, Thursday at 14:20 arrival of this group by Japan Airline, 9407 – greetings at the airport will be conducted and also escort to Hyatt Regency. MVA will be conducting the greeting. The place is so small that they only allowed 21 people to participate in the welcoming side. That is beyond my control – I would like to invite everybody there. And also, there will be two wreath presentations. It will be located at Suicide Cliff and the last one is at Banzai Cliff.
