## INTRODUCTION OF BILLS

The Chair recognized Rep. Hofschneider.

Rep. Hofschneider: Thank you, Mr. Speaker. Today, the Governor signed into Law House Bill No. 12-131 -- the Bill that we initiated recall; however, the Senate fail to go into session to do the same. So in the spirit of cooperation, Mr. Speaker, I met with the Governor yesterday and he agreed to sign the Bill on the basis that we immediately attain to the proposed language or correction, and I am pleased to introduce the Bill as follows: A Bill for an Act to amend 4 CMC ∋ 1708 (b)(1)(iii); and for other purposes. Which will accomplish that, also the Bill has been numbered, H. B. No. 12-258. I believe everyone has a copy. I ask the indulgence of the members, since this is just a technical amendment, if we could place it on today's Calendar for disposal. Thank you.

<u>Speaker Fitial</u>: House Bill No. 12-246, Committee Substitute 1, passes the House on First and Final Reading. Floor Leader?

Because the Rule says that the abstention goes to the prevailing, so your vote is still "yes".

Rep. Palacios: I know.

Rep. Hofschneider: Technically, it is 12-0, right?

<u>Speaker Fitial</u>: Technically, because of our Rules. But the journal will reflect that there are two abstentions.

<u>Rep. Palacios</u>: One thing I'm glad to see is that, the Education gets a lot of money at this time, as well as hospital and the college. My reason for abstained is that, the funding for Tinian is not enough and that is why I "abstained".

#### **MISCELLANEOUS BUSINESS**

<u>Speaker Fitial</u>: I just want to – the Bill the Representative Hofschneider introduced and we passed. One old man came in -- I met him at the entrance. He lives not too far away from here, and I asked him, "do you need help?" He said, "No. I just came out from meeting with Representative Jones". -- Because the government is asking him to pay tax on the land that he sold. He said, "You know, this is an exchanged land. If the government exchanged my land, land to land, there is no tax. But when the government exchange my land with compensation, gave me money for my land then there is tax." So, what is the difference?

<u>Floor Leader Babauta</u>: That is the inequity, Mr. Speaker, that we have just corrected it.

<u>Speaker Fitial</u>: I just want to point that out. That is the essence of the Bill that we just passed. That was Mr. Cabrera, Tun Goru-Esco. Representative Jones, I did not talk to you about this matter. He was very concerned when he walked out of your office that day. So, what we just did proves to be working.

Rep. Hofschneider: Thank you, Mr. Speaker and members.

Speaker Fitial: Any further Miscellaneous before we go into Announcements? – None.

<u>Chairman A. Camacho</u>: Thank you, Mr. Speaker.
