EIGHTEENTH DAY

September 7, 2000

The House of Representatives of the Twelfth Northern Marianas Commonwealth Legislature convened in its Eighteenth Day, Second Regular Session, on Thursday, September 7, 2000, at 11:05 a.m., in the House Chamber, Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Benigno R. Fitial, Speaker of the House presided.

In accordance with Rule XIII, $\ni 2(a)$, thirteen members were present. Representatives Martin B. Ada, Heinz S. Hofschneider, Brigida DLG. Ichihara, Norman S. Palacios and Thomas B. Pangelinan were excused.

<u>Speaker Fitial</u>: A quorum is duly constituted for the Eighteenth Day of our Second Regular Session. All five members absent are excused. I believe Representative Tony Camacho is around.

<u>Speaker Fitial</u>: House Bill No. 12-194 passes the House on First and Final Reading. Miscellaneous.

MISCELLANEOUS BUSINESS

The Chair recognized Rep. Benavente.

<u>Rep. Benavente</u>: Thank you. I've brought this issue up before, Mr. Speaker, and I still think that even if it is in the Constitution and even if it is in our House Rules that there was never the intent to place peoples lives in danger. I am talking about calling sessions during tropical storms, I'm talking about calling sessions when there is really no pressing or urgent matter to be discussed. I think that if we wish to call a session then I have no problem. I am not afraid to come out here, but we have to give consideration to the staff who have to be here and attend this session. It is presently Tropical Storm Condition I, and even government agencies are closed because of that and also schools are closed because of that. There is power fluctuation at this time. Some of our children are at home. I can understand if there are pressing and urgent matters to be discussed that we need to make the sacrifices, but I really don't believe that there was reason to make such sacrificing in today's session or even yesterday's session. If it is in our House Rules that requires to meet everyday or minimum amount of days, then I hope that the leadership will consider amending that House Rules, so that we don't have a situation where we have to call a House session just because it says so in our House Rules and put peoples lives in danger. Thank you.

Speaker Fitial: Further Miscellaneous? Floor Leader?

<u>Floor Leader Babauta</u>: Mr. Speaker, just to request the assistance of the Sergeant-At-Arms to assist Chairwoman Peter in looking after the information that we earlier discussed during our

breaks about the deceased Mr. Albert Camacho, so we can have it considered -- efforts to expedite the processing. Thank you.

Speaker Fitial: Further Miscellaneous? Representative Rosiky Camacho?

<u>Chairman Rosiky Camacho</u>: Mr. Speaker, last Tuesday, the present of those government agencies directors, secretaries, were there Tuesday afternoon at 1:30, the Public Hearing on House Bill No. 12-250. They were fully informed in writing so as in verbal that they are supposed to be here yesterday afternoon at 1:30 p.m. and only one government agency was present for the Public Hearing. The Committee so decides that next week, I will call them in for final information, clarification on the issue of House Bill No. 12-250. It is a little disappointment from the Committee, but as we all know, maybe due to the directive of the Governor, they so see that that request from the House supercede that directive from the Governor, so, I accept that particular proceedings from their behalf. Thank you.

<u>Speaker Fitial</u>: Did the Committee receive any notice from those concern government agencies who where supposed to appear before the Committee yesterday? Did you receive any notice?

<u>Chairman Rosiky Camacho</u>: None other than MVA. MVA called in and I said the scheduled Public Hearing is still on going. But the others didn't give the courtesy to inform the Committee. Just a little disappointment, but I understand.

Speaker Fitial: Further Miscellaneous? If none, Announcements.

<u>Chairman Rosiky Camacho</u>: On Monday the Committee on Public Utilities, Transportation and Communications will be having a Public Hearing at 1:30 p.m. in reference to House Bill No. 12-226 (Electronic Signature). I think it is timely that that particular Bill will be scheduled by Monday. Thank you, Mr. Speaker.

<u>Speaker Fitial</u>: Further Announcements? I just want to remind everybody that tomorrow is the Joint Session for the purpose of considering the extension of Laulau Bay lease. I believe the Joint Session will convene tomorrow at nine o'clock in the morning, rain or shine. I will

ask the Chairman on Natural Resources Committee to ensure that all members receive the Joint Session Resolution together with all the necessary information concerning the subject lease.

Chairman Jones: Well taken.

Speaker Fitial: Okay. No further Announcements? Floor Leader?

Floor Leader Babauta: So move, Mr. Speaker, until tomorrow at the Joint Session at 9:00 a.m.
