<u>Floor Leader Babauta</u>: So move, Mr. Speaker, for the passage on First and Final Reading House Bill No. 12-59, Committee Substitute 1, under Standing Committee Report No. 12-176.

Speaker Fitial: Discussion? Representative Hofschneider?

Rep. Hofschneider: May I ask the indulgence of the members if we can pass this on a subsidiary motion for First Reading? We would like to check, Mr. Speaker, Public Law Nos. 9-1 and 10-38, I think we have exhausted that fund balances. And just to make sure, I request that we put this on First Reading, if there is no objection.

There was no objection raised.

<u>Speaker Fitial</u>: Can we just ask the Chairman of the Committee to enlighten the House?

Rep. A. Camacho: Mr. Speaker, the fund status report that was given to the Committee by the Ms. Vicky Villagomez, is as of September 30th, these are the closed project fund balance.

Rep. Attao: Mr. Speaker?

Speaker Fitial: Representative Attao?

Rep. Attao: For Oleai Elementary School, Mr. Speaker, we do have \$20,000 and for the Garapan Elementary School we have \$81,227. So, on the \$81,227 the RFP is out, they are bidding for the construction so as Oleai Elementary School. Under Public Law 9-1, I am certain that the two unexpended fund balances are booked and considered committed for the two respective schools.

Rep. A. Camacho: Mr. Speaker, the fund balance that the Committee took under consideration was the completed engrossed project. So there is no problem whatsoever to the respect and recommended by the CIP coordinator.

Rep. Attao: Yes. I understand that, Mr. Speaker.

<u>Speaker Fitial</u>: I think you are talking about the same thing except different level. In other words, those balances are accurate. What they are saying over here is that, those balances are now being planned to be encumbered.

Rep. Attao: You are correct, Mr. Speaker.

Rep. A. Camacho: As of September 30^{th} , Mr. Speaker, they put on the report that it was given to the Committee by –

<u>Speaker Fitial</u>: The question is, are they authorized to encumber those fund balances without appropriation?

<u>Rep. Attao</u>: We did appropriate it, Mr. Speaker, and the balance was to be use for other projects within that school. So, the balance that shows on the report is not clear, Mr. Speaker, because the fund balance has been reprogrammed to be use within the respective school.

<u>Speaker Fitial</u>: If it has been reprogrammed, why is it that it is showing under the September 30th fund status report as unencumbered?

Rep. Hofschneider: May I answer that?

<u>Rep. Attao</u>: You know, Mr. Speaker, for the Garapan Elementary School we appropriated about \$307,900. The balance of the \$81,227 is still available, but as far as that report, as the Chair stated today, that fund balance is committed for the project that is not yet completed.

Rep. A. Camacho: Mr. Speaker, my record shows that it is closed. Completed and closed.

Rep. Attao: Is that for Garapan, Mr. Speaker?

Rep. A. Camacho: This is not for Garapan. This is for other schools, for Precinct I.

Rep. Attao: If it is for other schools, I rest my case. Otherwise, Mr. Speaker –

Rep. A. Camacho: I respect Precinct III projects.

<u>Rep. Attao</u>: I don't want to jeopardize the ongoing project if we are re-appropriating that fund balance.

Rep. A. Camacho: I am trying to assist Precinct III also. The Committee did not take Precinct III project for the schools.

<u>Speaker Fitial</u>: So, Mr. Chairman, are you saying that these balances that we are now reappropriating do not concern those projects for Garapan and Oleai?

Rep. A. Camacho: No. Garapan, I am not within purview of this reauthorization on appropriation.

Rep. Hofschneider: Does he have a copy so we can just look at it briefly? We can tell where the fund balance is if it is in that Public Law? If they have that fund status we can tell you what Public Law?

Rep. Attao: Mr. Speaker?

Floor Leader Babauta: Short recess, one minute.

<u>Speaker Fitial</u>: No, let us proceed. Let us move to the other one... We will just suspend discussion on the passage motion on House Bill No. 12-59 temporarily and let us entertain another motion if there is no objection by the members.

<u>Speaker Fitial</u>: House Bill No. 12-279, Committee Substitute 1, passes the House on First and Final Reading. Can we go back to --

Floor Leader Babauta: Ready for the question.

Speaker Fitial: Ready for the question?

Floor Leader Babauta: Yes, Mr. Speaker.

Rep. Hofschneider: Under discussion, Mr. Speaker.

Speaker Fitial: We are still under discussion.

Rep. A. Camacho: Mr. Speaker?

Speaker Fitial: Chairman, recognized.

Rep. A. Camacho: On the report that we received from CIP coordinator Kagman Elementary School has a fund balance of \$342,000; Marianas High School Gym has a balance of \$300,000; San Antonio and San Vicente Library has \$20,000, so, I did not use all the fund balance that is appropriate in this bill.

Rep. Attao: Mr. Speaker, may I ask the Chair when did get?

Rep. A. Camacho: This is just three days ago, Mr. Speaker, from the CIP coordinator, Mrs. Vicky Villagomez, as of September 30th, 2000, PSS CIP Status Report that she had given me. So, I have to trust if we don't anybody in the Administration so I am sorry, but I trust her for giving me this.

Speaker Fitial: That is the right report.

Rep. Attao: Can I see the document, Mr. Speaker?

Rep. A. Camacho: After the session, Mr. Speaker, I can provide him a copy. As for now, this is my only copy.

Rep. Attao: Mr. Speaker, I think Kagman Elementary School is in need of funds.

Rep. A. Camacho: Yes. We have the appropriation also here for fencing and that sources.

Rep. Attao: I think they need more than \$41,000.

Rep. A. Camacho: Mr. Speaker, the Commissioner of Education and the Public Works Technical Service Director, we met with the Chairwoman of the Education Committee, and they have their shopping lists, and we have so many other lists and other things. We encourage them also to use the FEMA fund balance for about \$41,000. So, we are helping the schools from re-appropriating their own funds.

Speaker Fitial: What the Chairman is saying is that, he is expecting that you also trust him.

Rep. Attao: No. It is not that I did not trust him, Mr. Speaker. It is a matter of protecting the needs of the respective schools (Garapan and Oleai Elementary School).

Rep. A. Camacho: Ready. We don't touch it because we have the balances.

Rep. Attao: Mr. Speaker?

Speaker Fitial: Go ahead.

<u>Rep. Attao</u>: If the Chair is telling us the truth now, then the true picture of the running balance of the unexpended fund balances from Kagman, San Antonio, Marianas High School Gym are correct and not touching Garapan and Oleai, Mr. Speaker, I will support that.

Rep. A. Camacho: I am not touching for Garapan. I respect your... –

<u>Rep. Attao</u>: If it is within the whole fund balance for PSS CIP, and Garapan and Oleai is not part of that, Mr. Speaker, then I have no question. However, funds are committed for Garapan and Oleai Schools.

Speaker Fitial: I recognize the Chairwoman on Education Committee.

Rep. Ichihara: Mr. Speaker, we had previously met on September 12 and we hade been waiting for Mrs. Villagomez to come up with these balances. It had been agreed by the Chairman on Ways and Means that we will leave all the monies that are lapse from the respective schools and reappropriate it as requested by the school. What the Commissioner did with Mr. Frilying was come up with a listing of priorities that the school needs to be done now. In order to expedite the needs of the children they came up with that listing and with that listing we went over with the list that the Chairman had and so, that is what we are working on and it was never a part in our discussion as to trying to take away monies from the respective schools that have those lapse funds, so please, Representative Attao and Hofschneider...

Speaker Fitial: Representative Hofschneider?

Rep. Hofschneider: It is true, Mr. Speaker, there is sufficient amount of fund balances. The burden is really on the administration which one to apply the \$256,000 legislation. So, there is sufficient to take whatever fund balances to add up \$256,000.

Rep. A. Camacho: Ready.

<u>Speaker Fitial</u>: Representative Hofschneider just assured Precinct III that there are sufficient fund balances in which to accommodate school projects in Precinct III. Okay, we call for the question, roll call.
