REPORTS OF SPECIAL AND CONFERENCE COMMITTEES

The Chair recognized the Floor Leader.

<u>Floor Leader Babauta</u>: Mr. Speaker, before I make a motion for the adoption of the Conference Committee Report, at this time if there is no objection from the members, I wish to recognize one of the elected officials in the gallery, the Chairman of the Saipan Municipal Council, Mr. Guerrero. (Applause) Mr. Speaker, I now move for the adoption of Conference Committee Report No. 12-1, reporting on House Bill No. 12-001, CS2, HD3, SD2, so move, Mr. Speaker.

The motion was seconded.

Conf. Cmte. Rep. No. 12-1: Reporting on House Bill No. 12-001, CS2, HD3, SD2, entitled, "To make appropriations for the operations and activities of the government of the Commonwealth of the Northern Mariana Islands, its agencies, instrumentalities, and independent programs, and to provide budget authority for Government corporation for Fiscal Year 2000; and for other purposes." *Your Conference Committee recommends passage of the bill in the form of Conference Committee Substitute 1.*

Speaker Fitial: Discussion? Representative Hofschneider, recognized.

<u>Rep. Hofschneider</u>: Thank you, Mr. Speaker. On the Committee Report, did the Speaker of the House instruct the Conference on a specific item to be taken up in the Conference limiting the matters to be discussed relative to the motion rejecting the Senate amendment?

Speaker Fitial: Again your question, was the Speaker of the House --?

Rep. Hofschneider: Did the Speaker of the House instruct the Conferees?

<u>Speaker Fitial</u>: The Speaker of the House did not instruct or give any specific instruction to the Conferees. Although – if I may, the Conferees are fully aware that the only matter of discussion would be limited to whatever the Senate amended and we rejected in the Budget. I think that is a common knowledge in legislative procedure.

Rep. Hofschneider: Can we take a short recess? I want to point something out off the record?

Speaker Fitial: Short recess.

The House recessed at 3:38 p.m.

RECESS

The House reconvened at 3:41 p.m.

Speaker Fitial: The House shall reconvene. Representative Hofschneider, you still have the floor.

<u>Rep. Hofschneider</u>: Thank you, Mr. Speaker. Just one more question maybe to the Chairman, or perhaps the legal counsel would be the more appropriate person to answer -- on page 22, line items 5 to 8, the underlined sentence, "<u>To the extend that additional resources... etc.</u>," The Constitution only allows the Governor to identify resources to be appropriated the Legislature cannot identify additional resources. I just want to make sure before I support the Budget, Mr. Speaker, that this particular language does not in any way infringed in the powers of the Governor to identify resources. Because the way I read this sentence, it allows the total identification to go beyond, to supplement what was originally line item appropriated or proposed appropriation. This language is in line and in order to supplement the shortfall of that particular line item. The problem is a Constitutional question, whether it is an infringement in the separation of authority?

Speaker Fitial: No.

Rep. Hofschneider: Then I rest.

<u>Speaker Fitial</u>: We could safely say that, this is in contemplation in receiving the Governor's adjusted estimate. Since we are aware for a fact that the Governor has indicated in the past few months, that revenues may be more than what he had originally submitted to the Legislature.

<u>Rep. Hofschneider</u>: In that case, Mr. Speaker, one last question and that is on the same page line 17, the words "...for land claims" after "judgments..." is this intended to settle land claims that were adjudicated or land claims pending land compensations?

Speaker Fitial: Adjudicated.

Rep. Hofschneider: Thank you.

Speaker Fitial: Further deliberation on the motion?

Several members voiced, "ready".

Speaker Fitial: All we need is a voice vote for the Committee Report. Representative Attao?

<u>Rep. Attao</u>: I am going to ask the Chairman to make a clarification, Mr. Speaker, on page 13, lines 5 through 10.

<u>Rep. A. Camacho</u>: Mr. Speaker, on the Committee Report's Findings, on number 4, it is very clear on that section that the Municipal Council and the Chair of the Board of Public Lands, to sole sources contracts for legal services, consultations, and professional services with private independent contractors. I think that answers the good Representative Attao's concern.

Rep. Attao: Thank you. Ready.

The motion to adopt Conference Committee Report No. 12-1, reporting on House Bill No. 12-001, CS2, HD3, SD2, was carried by voice vote.

Speaker Fitial: Conference Committee Report No. 12-1 is adopted.
