Acting Speaker Babauta: House Resolution Nos. 12-60, 12-61 and House Joint Resolution No. 12-11 are hereby adopted.

MISCELLANEOUS BUSINESS

The Chair recognized Rep. Attao.

Rep. Attao: Under Miscellaneous, on House Resolution No. 12-58, reviewing the resolving clause, Mr. Speaker, I think it will be appropriate and important to give a copy to the Chairman of the 902 talks. This is relative to requesting the Department of Interior to assist the Commonwealth on the Compact-Impact issues. So, if there is no objection

from the members, I would like to make a motion to add one copy to the Chairman of the 902 talks so that he will be aware of the Resolution that we just adopted.

<u>Acting Speaker Babauta</u>: If there is no objection on the floor, I request the Clerk to make the necessary addition to the resolving clause.

There was no objection raised.

<u>Acting Speaker Babauta</u>: So ordered. Clerk, please take note? Miscellaneous Business? Representative Malua Peter?

Rep. Peter: No. I am ready for Announcement, Mr. Speaker.

<u>Acting Speaker Babauta</u>: Representative Antonio Camacho, under Miscellaneous Business.

Acting Floor Leader A. Camacho: Thank you, Mr. Speaker. It was very sad when the House of Representatives went to Washington, D. C., we worked hard in trying to establish somebody there to protect our interest and while we are arguing among ourselves here, certain invested interest in Washington, D. C., tried to make our Headnote 3(a) privilege. I really feel that because we are working on the budget and if this happens and it becomes a reality that the U. S. Congress really approve the removal of the Head Note 3(a), it is going to be like downsizing of our government operations. I simply urge the Senate and the House to work together and out ridge the Governor to sole source a lobbying firm there to protect our interest to fight for our interest regarding Headnote 3(a) and other matters that really affects our interest here. Thank you, Mr. Speaker.

<u>Acting Speaker Babauta</u>: So noted, Representative A. Camacho. Anymore under Miscellaneous Business?

Rep. Attao: Mr. Speaker?

Acting Speaker Babauta: Under Miscellaneous?

Rep. Attao: Yes, under Miscellaneous. Do you plan to call a session tomorrow?

Acting Speaker Babauta: For the benefit of the members, the Floor Leader will be recessing this session until tomorrow afternoon at 3:00 p.m.

Rep. Attao: So, Mr. Speaker, may I ask that you coordinate with the legal counsel to come up with a resolution supporting the Governor on his effort to have a lobbyist in Washington, D. C., to protect our interests here, and I recommend Representative Antonio Camacho for airing the thing out. Thank you.

Acting Floor Leader A. Camacho: Mr. Speaker?

Acting Speaker Babauta: You may proceed.

Acting Floor Leader A. Camacho: This is not a debate to Representative Attao's –

Acting Speaker Babauta: As long as you are in line with respect to the issue, proceed.

Acting Floor Leader A. Camacho: Mr. Speaker, I think it is going to be like a unanimous consent that we have to have a resolution introduce so that we can allow the Governor to start working on a lobbying firm to work on our behalf over in Washington, D. C.

Acting Speaker Babauta: I am sure both of you -- our counsel Tony Cabrera, see him and probably initiate that House Joint Resolution for tomorrow. Counsel Cabrera can you please take note on that? Anymore under Miscellaneous? Announcement.
