The House of Representatives of the Twelfth Northern Marianas Commonwealth Legislature convened in its Second Day, Eighth Special Session, on Friday, July 14, 2000, at 04:08 p.m. in the House Chamber, Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Benigno R. Fitial, Speaker of the House, presided.

Mr. Perios Besong was appointed Acting Sergeant-At-Arms.

A moment of silence was observed.

In accordance with Rule XIII, \ni 2(a), fifteen members were present. Representatives Dino M. Jones, Alejo M. Mendiola, Jr. and William S. Torres were excused.

<u>Speaker Fitial</u>: A quorum is duly constituted for the Second Day of our Eighth Special Session. All members absent are excused.

ADOPTION OF JOURNALS

The Chair recognized the Floor Leader.
